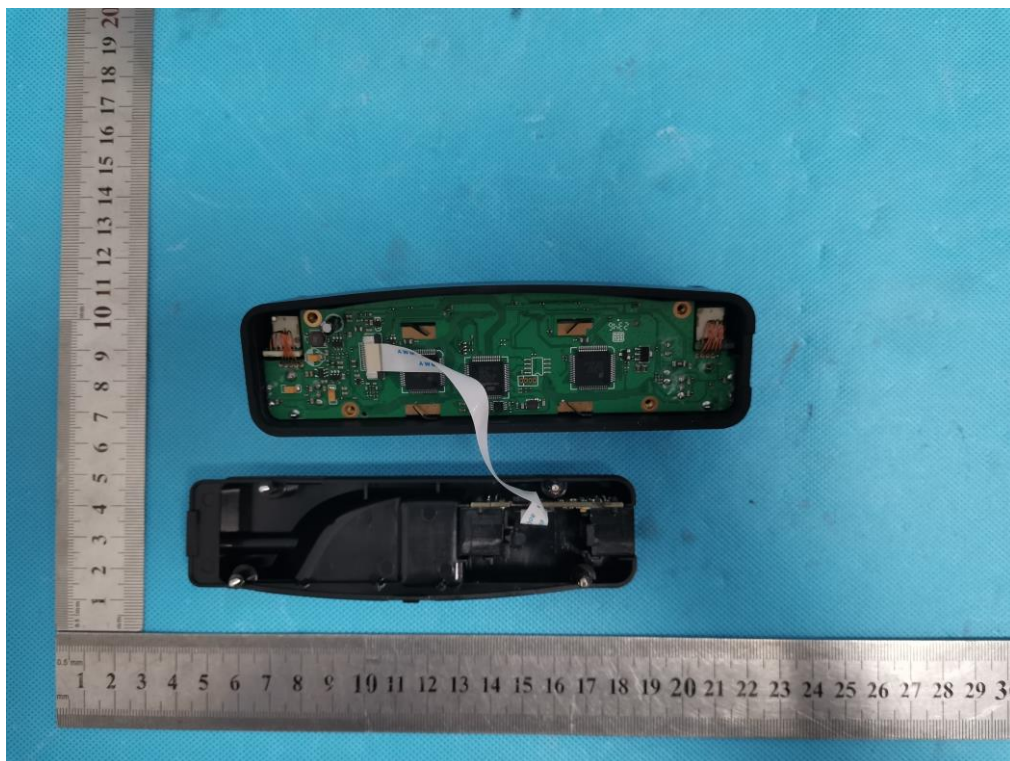

OPEN VIEW OF EUT(Figure 1)

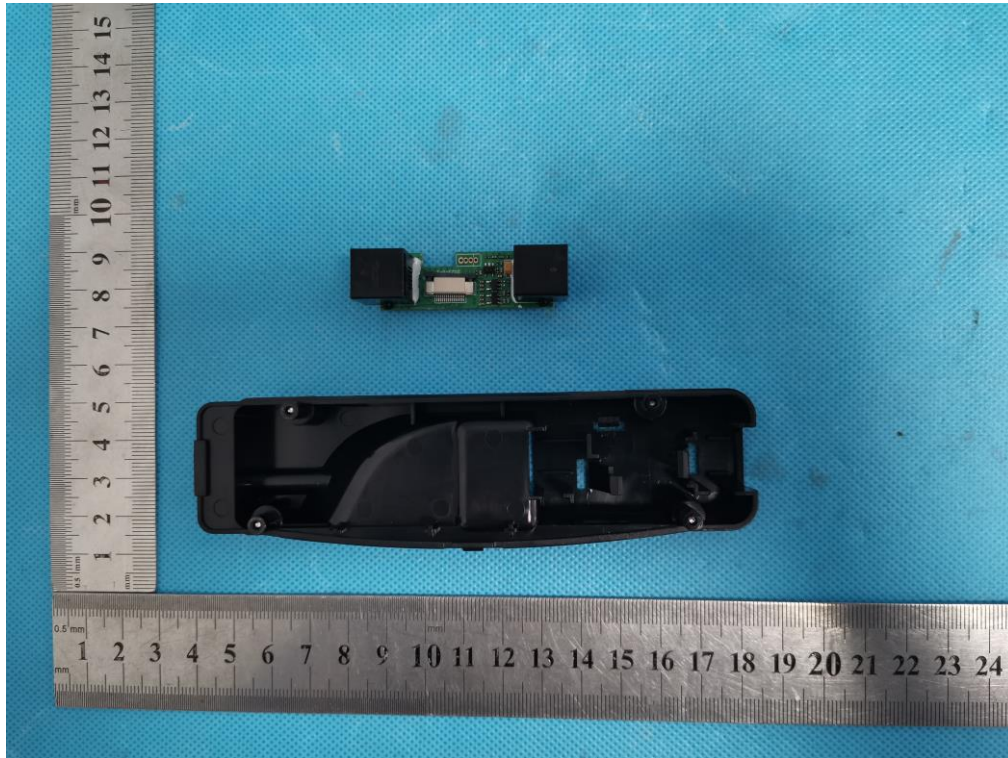


OPEN VIEW OF EUT(Figure 2)

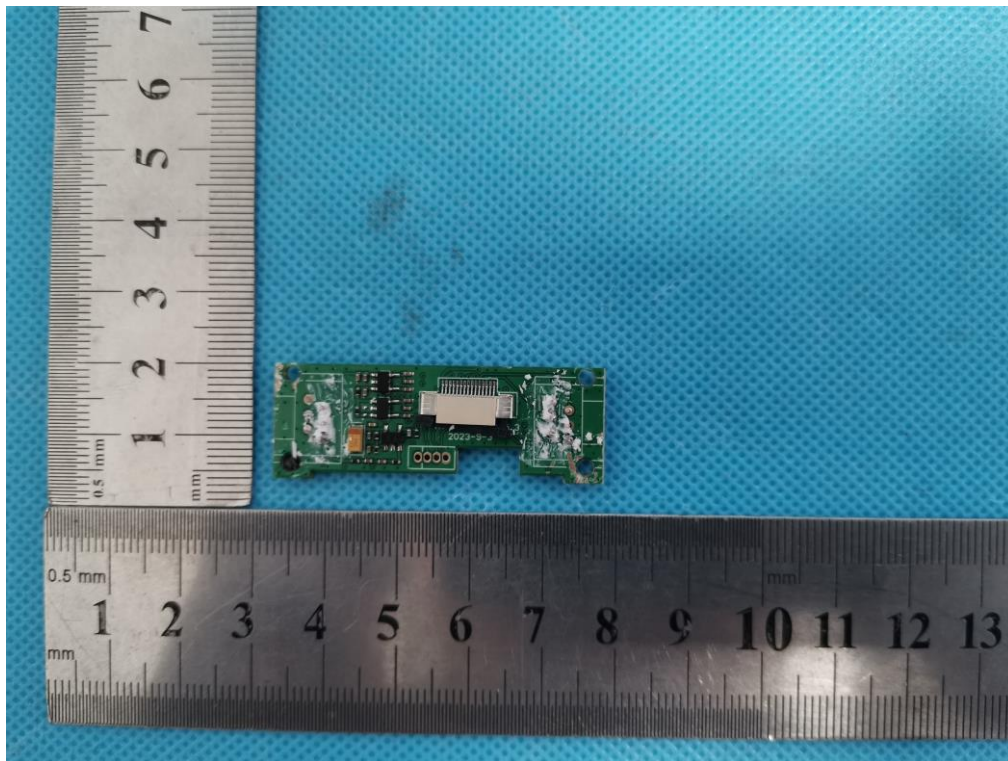

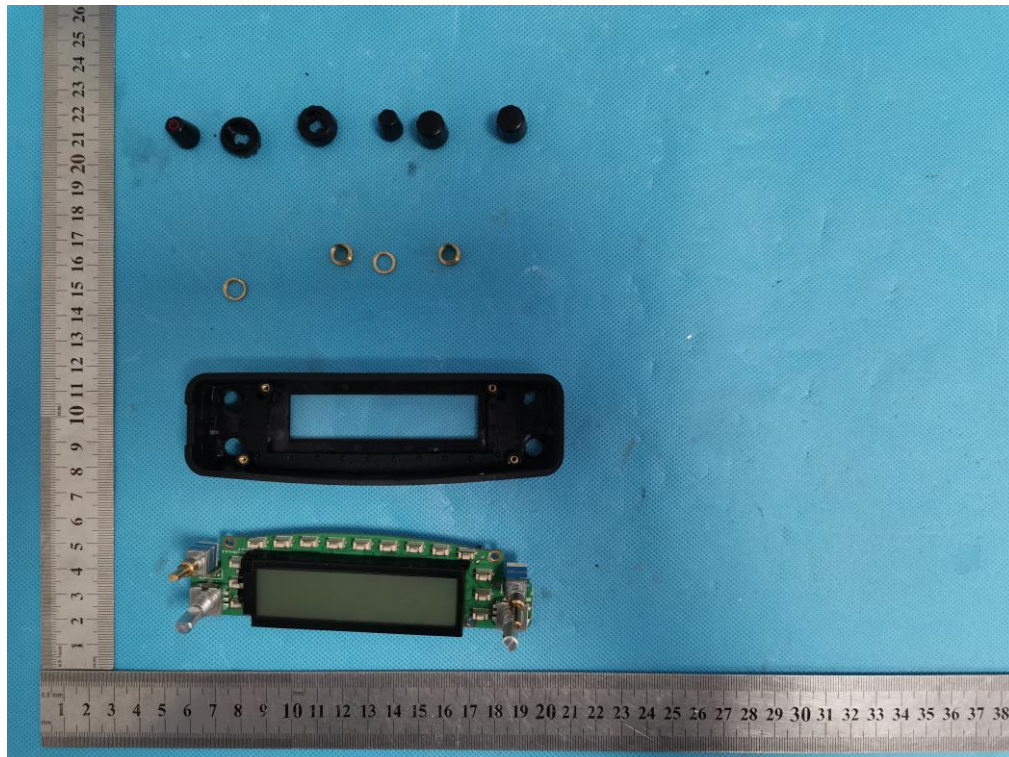


INTERNAL VIEW OF EUT-3

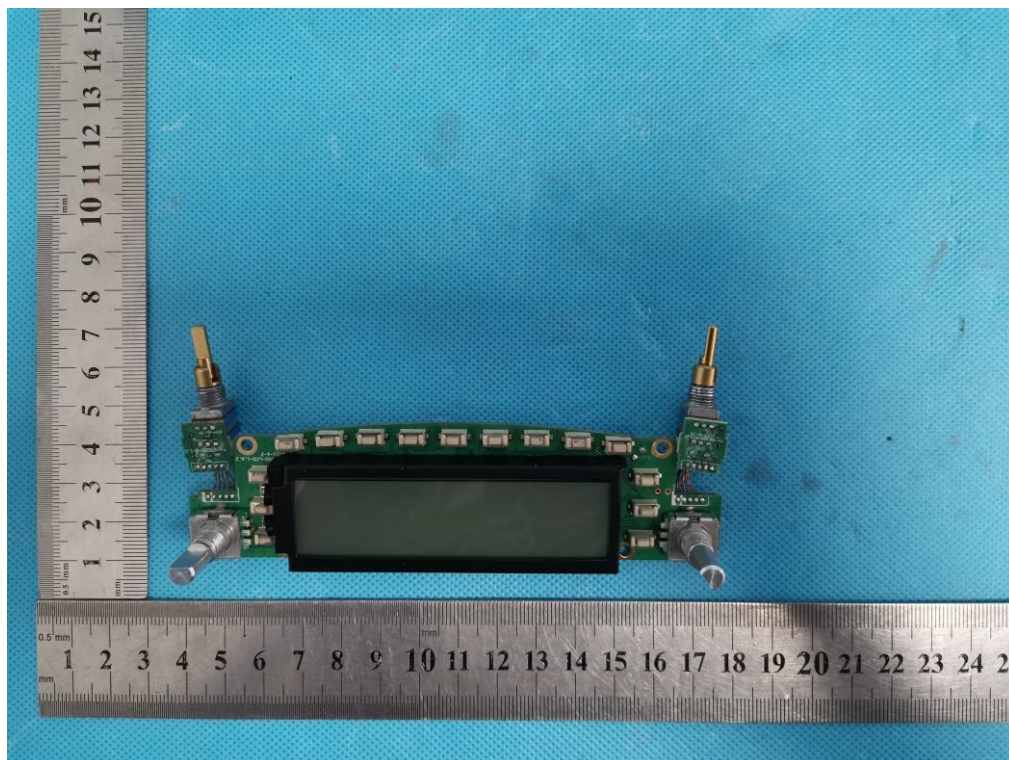

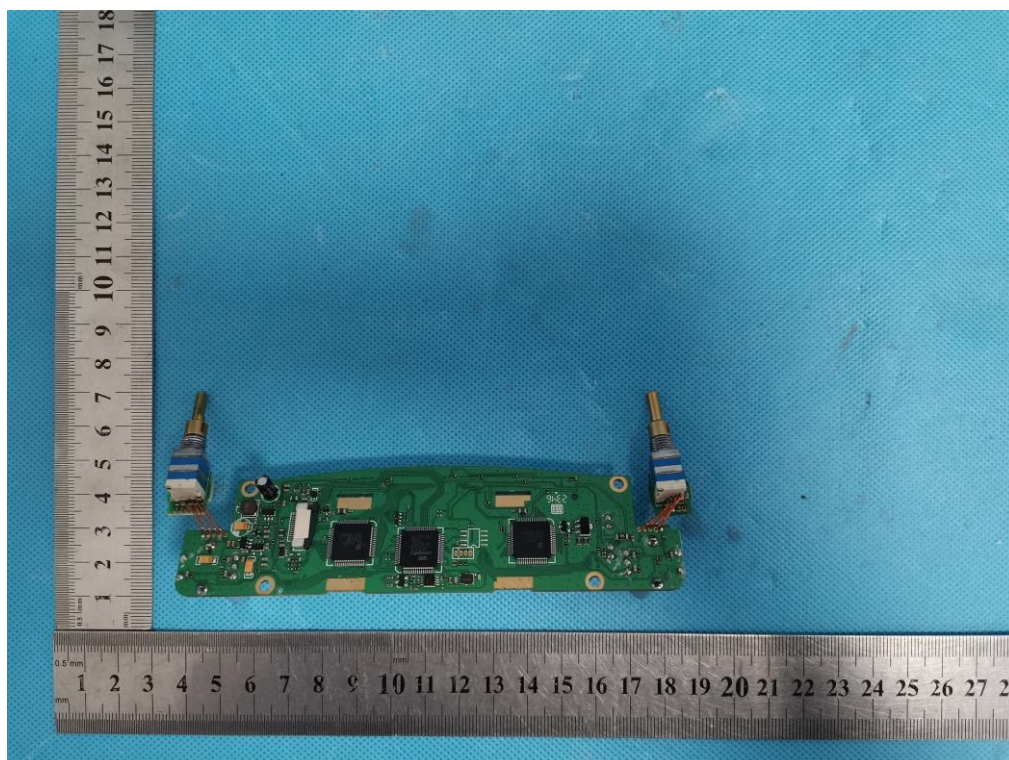

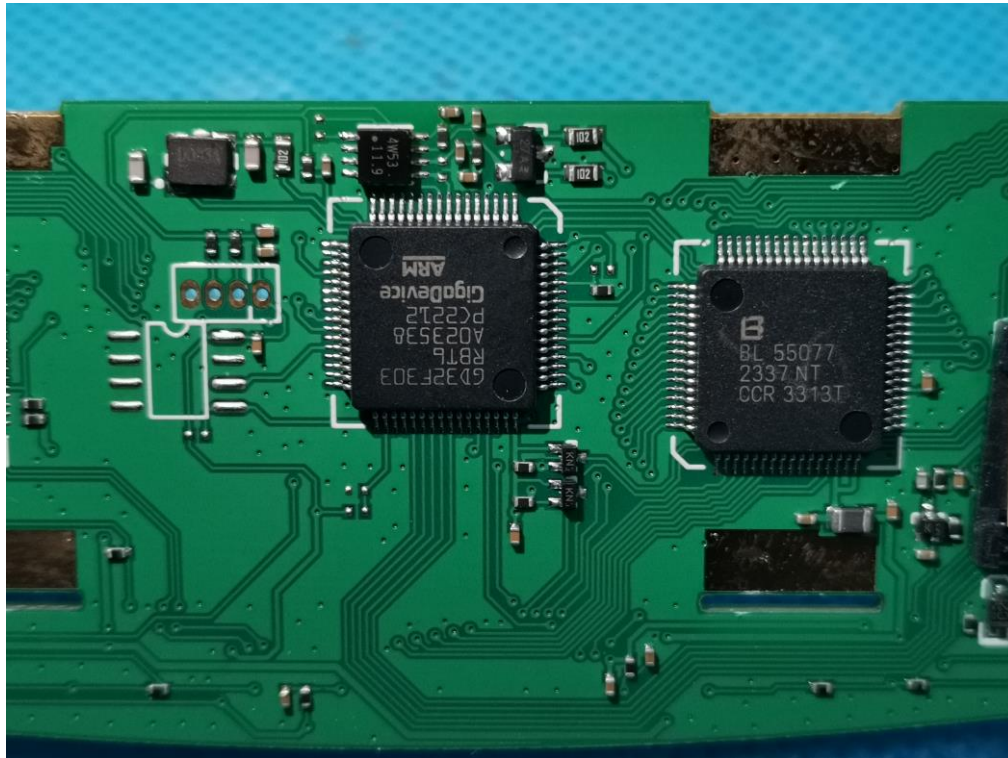

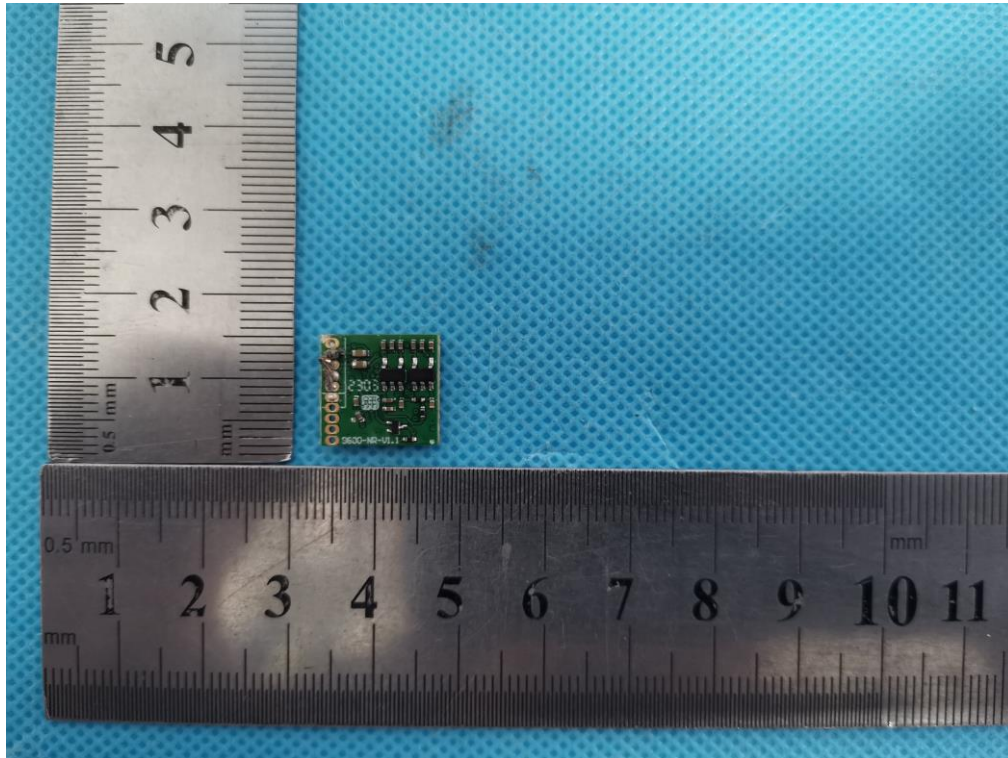

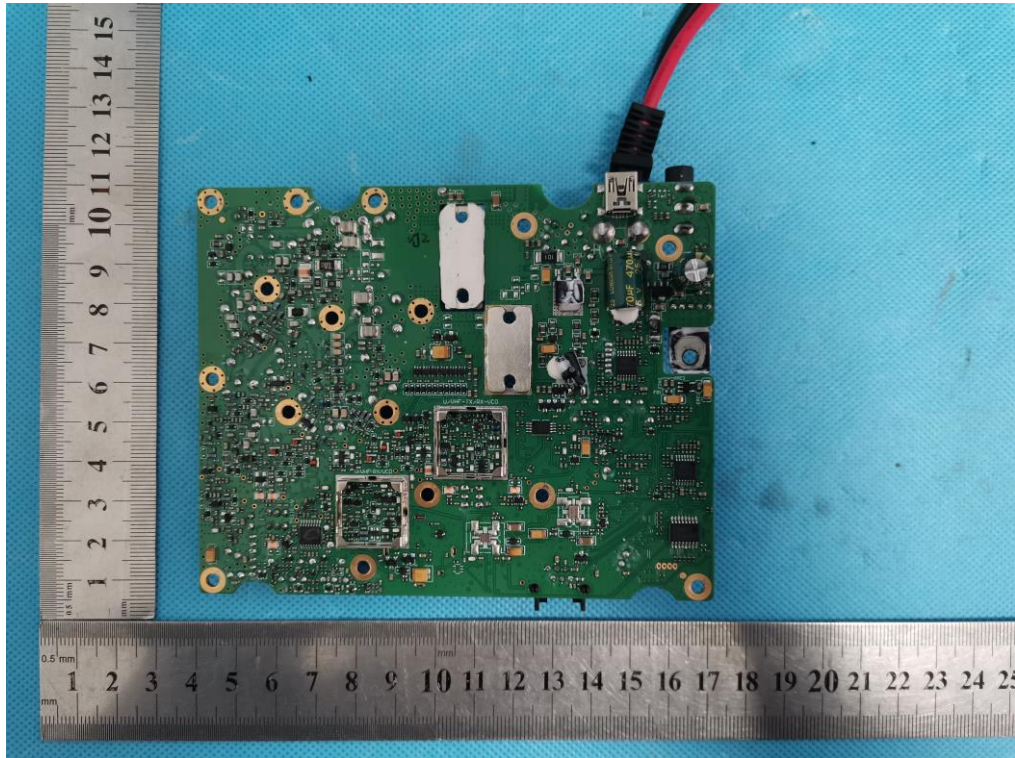

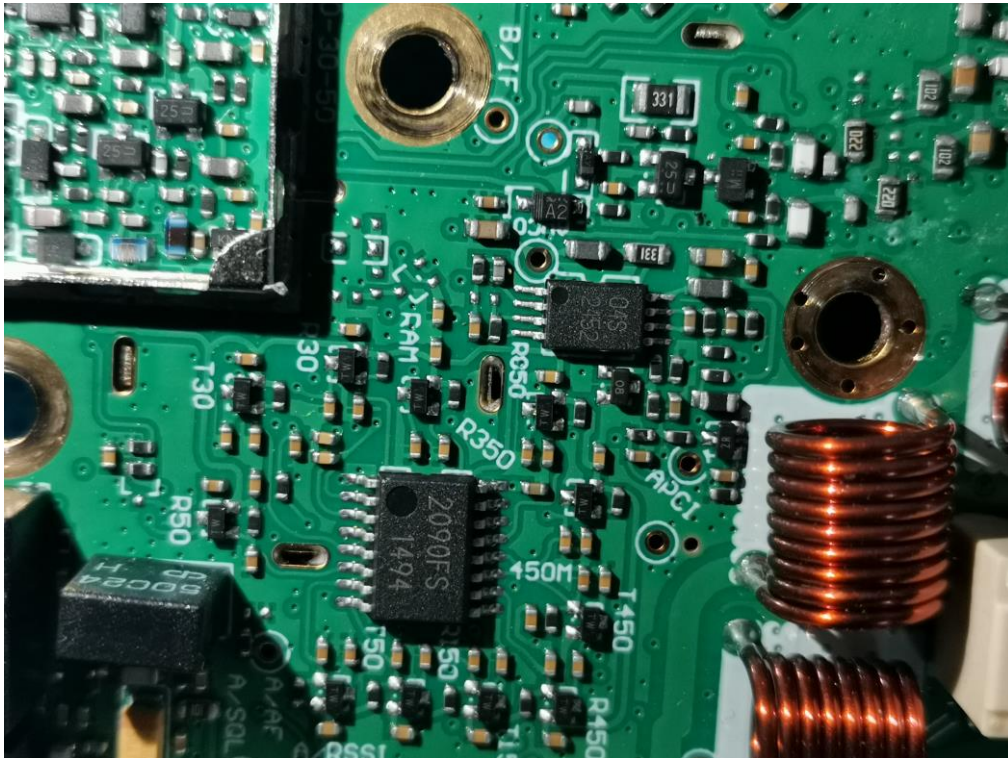

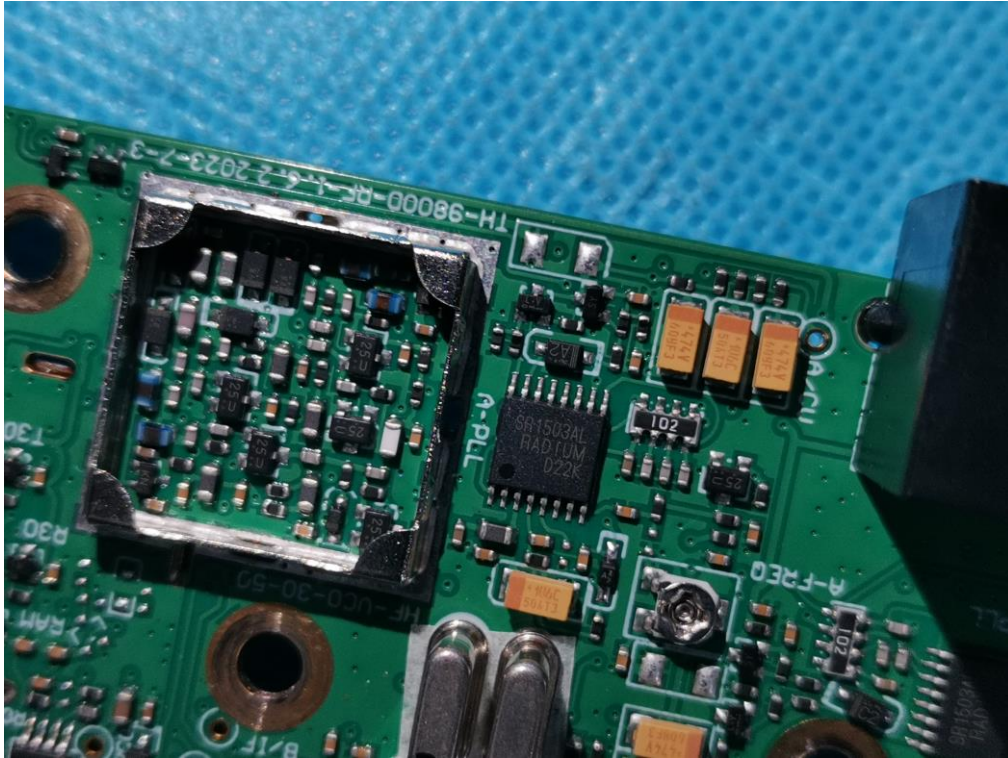

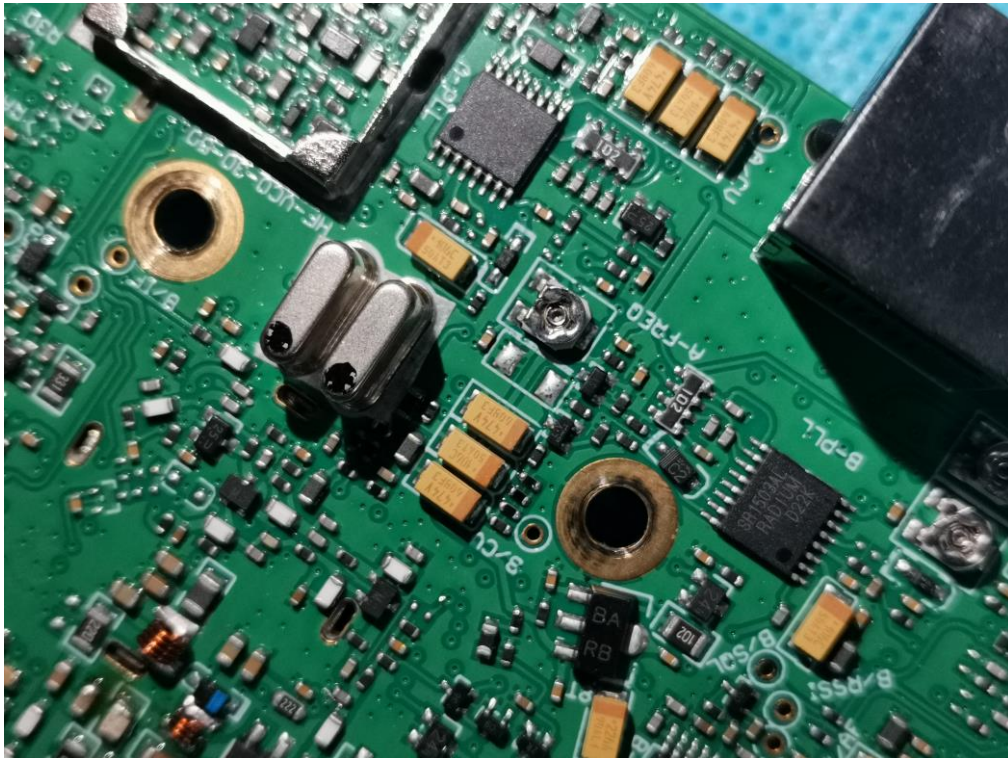

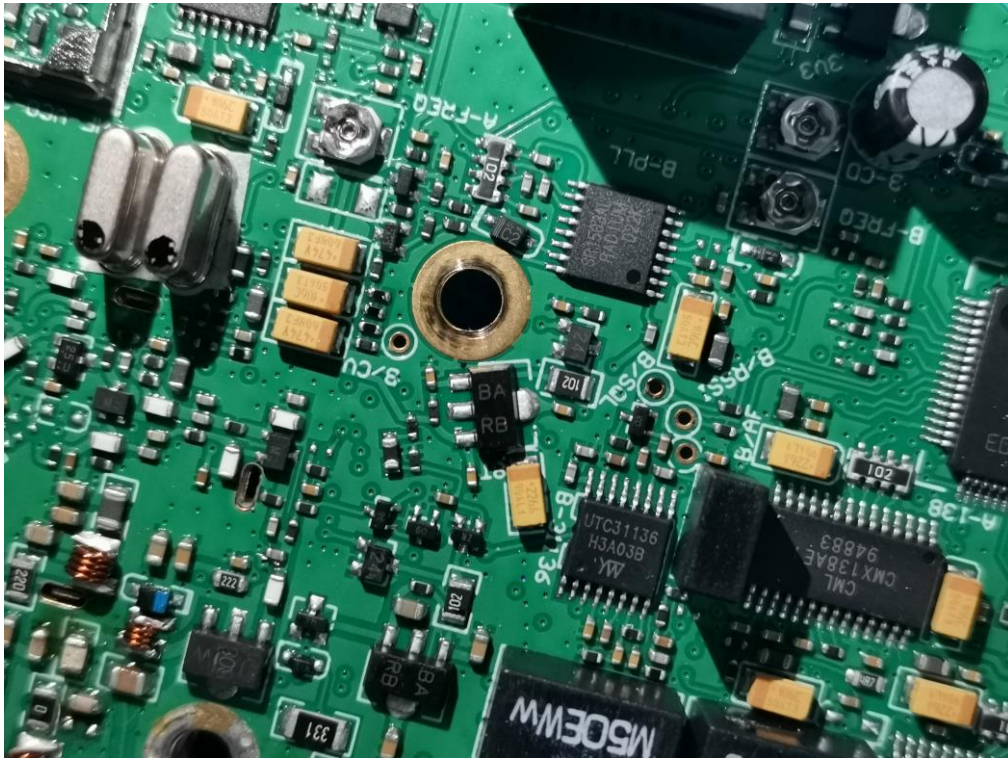

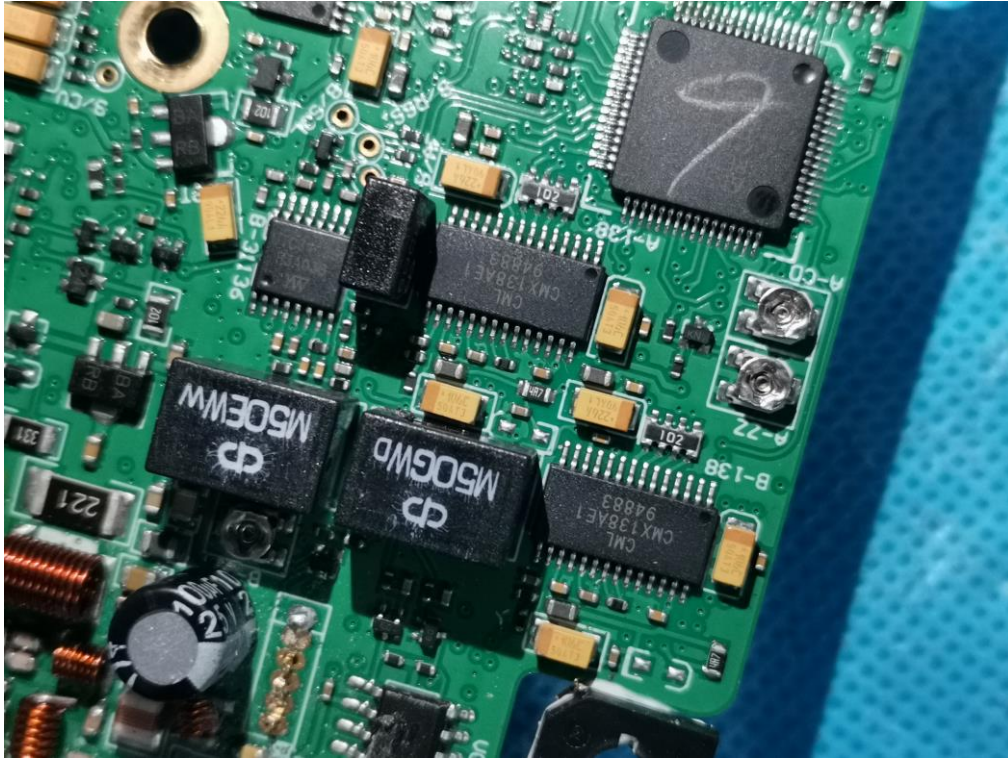


INTERNAL VIEW OF EUT(FIGURE 11)

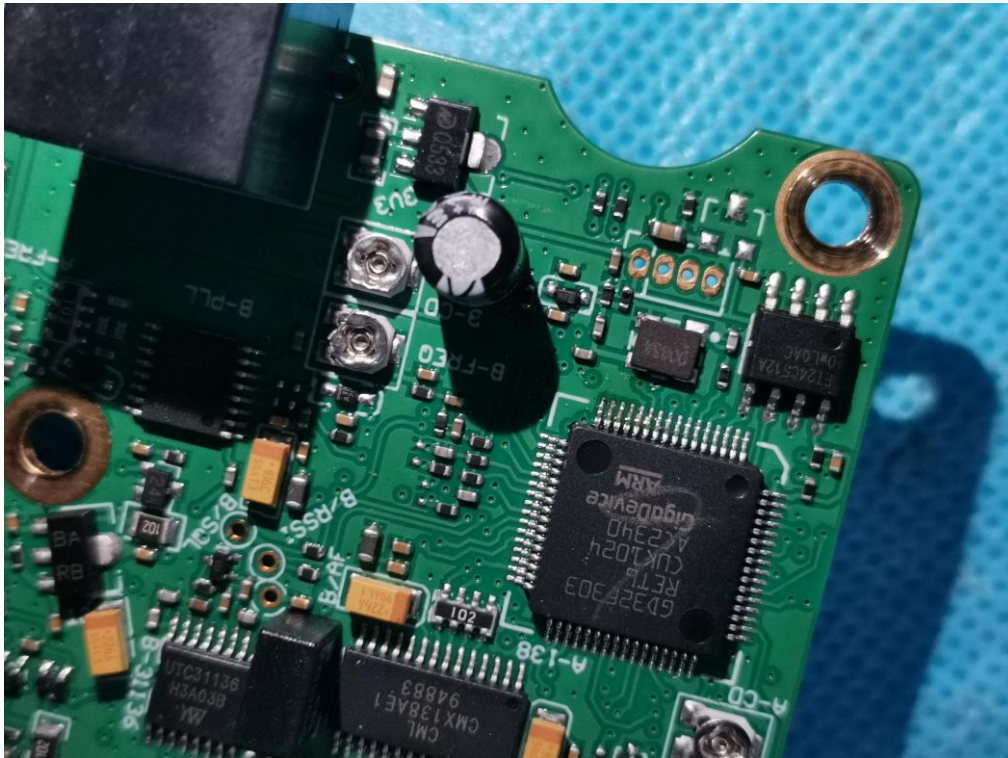

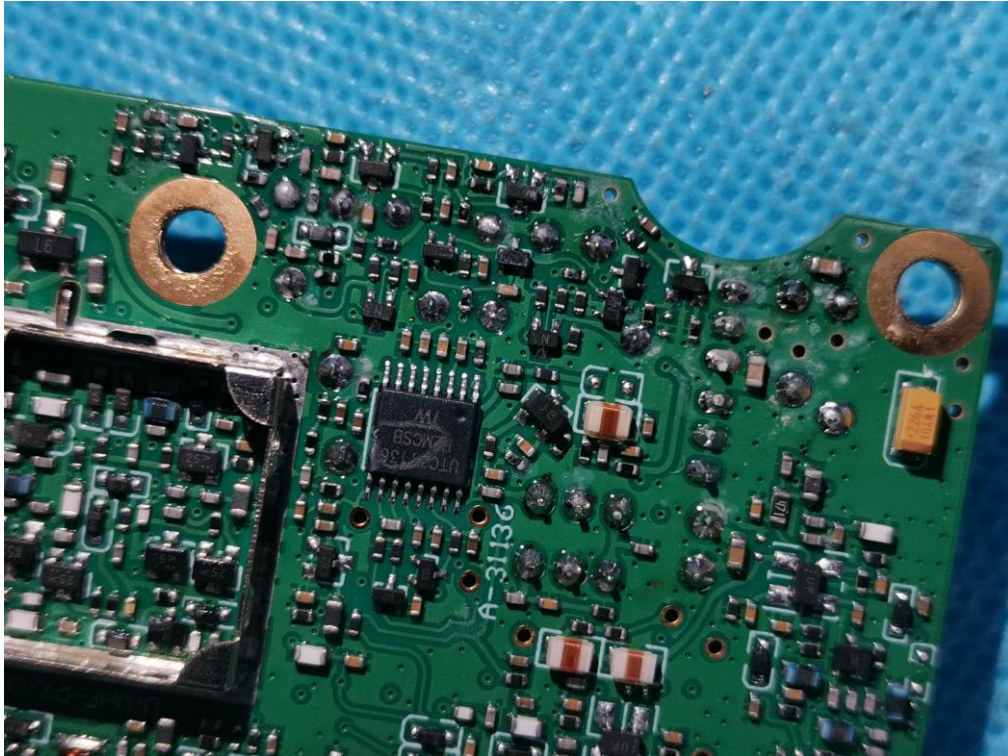


INTERNAL VIEW OF EUT(FIGURE 13)

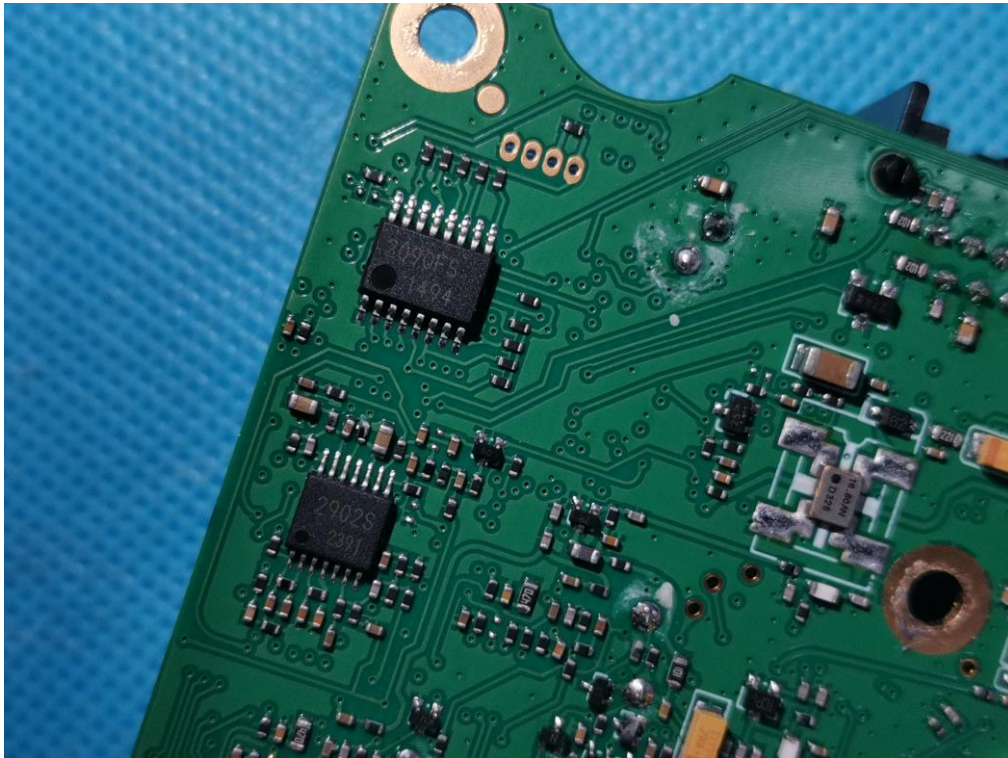

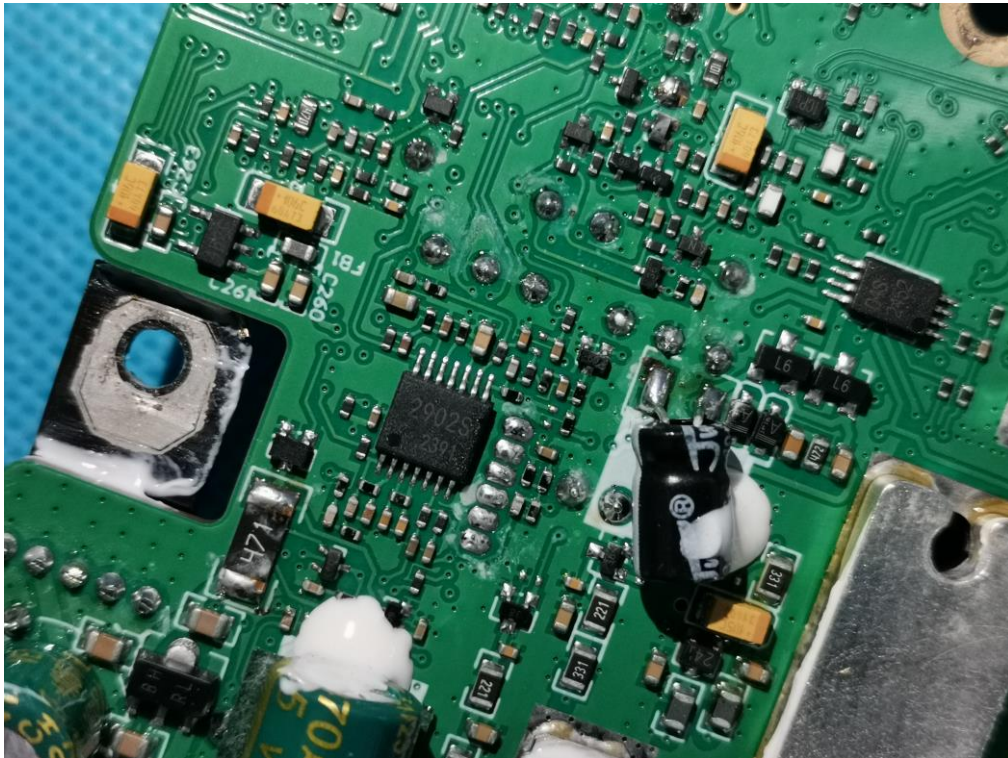

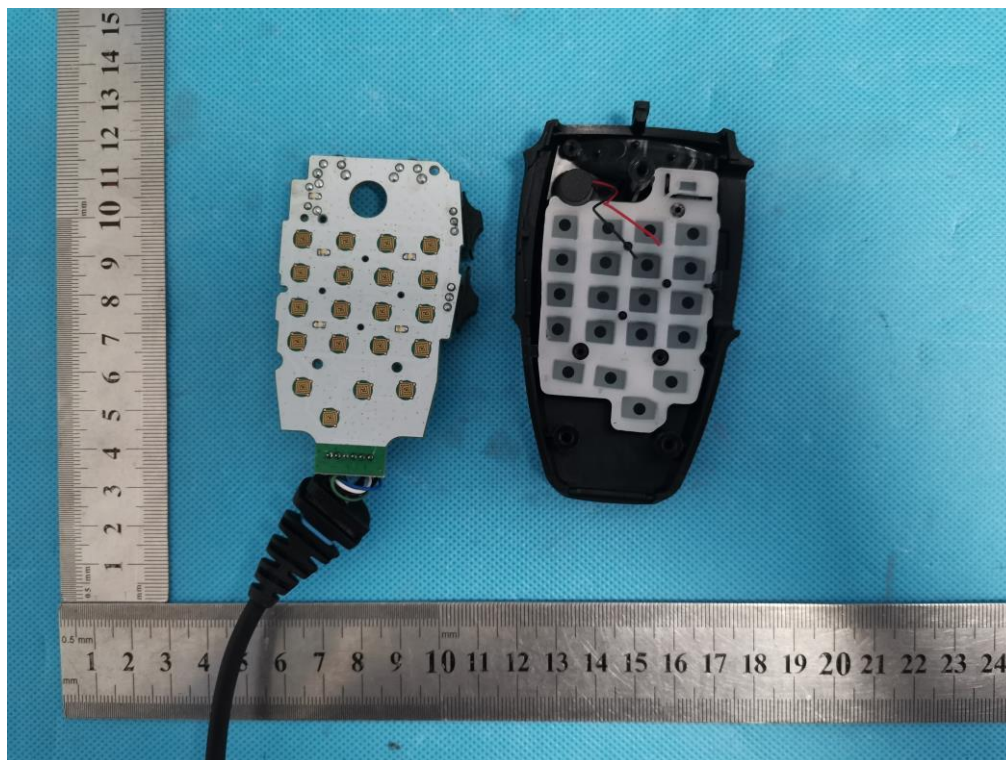
