Otherwise the emissions that did not have 10dB margin would be retested one by one using peak or average method as specified and then reported in a data sheet.
- g. Test the EUT in the lowest channel, the middle channel, the Highest channel.
- h. The radiation measurements are performed in X, Y, Z axis positioning for Transmitting mode, and found the X axis positioning which it is the worst case.
- i. Repeat above procedures until all frequencies measured was complete. Remark:
- 1. Level= Read Level+ Cable Loss+ Antenna Factor- Preamp Factor
- 2. Scan from 18GHz to 40GHz, the disturbance above 18GHz was very low. The points marked on above plots are the highest emissions could be found when testing, so only above points had been displayed. The amplitude of spurious emissions from the radiator which are attenuated more than 20dB below the limit need not be reported.
