疑难排除

若您未能将耳机和移动电话连接上, 请尝试以下步骤:
--确保耳机已被启动及已完全充电。
--确保耳机已与移动电话连接。
--确保移动电话的蓝牙功能已被启动。
--确保耳机在移动并没有障碍物阻隔。
●若以上步骤仍未能排除疑难, 请将耳机充电, 或将您的移动电话再次重新开机。

保养及维修

--将耳机放在口袋或袋子前, 先关掉耳机, 避免意外按下耳机功能键。
--切勿将耳机暴露在液体或潮湿的地方。
--切勿使用腐蚀性溶剂清洗耳机。
--切勿将耳机放置在温度极高或极低的地方, 最佳存放环境为-10℃到+60℃, 否则会影响耳机的使用寿命。
--切勿将耳机暴露在烟火之中, 避免爆炸危险。
--切勿将耳机接触尖锐对象, 会造成刮痕或损毁。
--切勿将任何物件插入耳机内, 会损毁内部组件。
--切勿尝试拆卸耳机。

Ensure your mobile phone's Bluetooth feature is activated. Please refer your mobile phone user guide for specific instruction.
Ensure the headset is within a 10 meters range of your mobile headset and

Care and Maintenance Headset

Consider turning your headset off before placing it in your pocket or bag. If the MBF is accidentally activated, your mobile phone may place an unintended call.
Do not expose the headset to liquid, moisture or humidity as it is not waterproof.
Do not use abrasive cleaning solvents to clean the headset.
