Dear Application Examiner,

The Wilson Football Tag we are submitting for approval has no user's manual.

Wilson Sporting Goods will retain control over the Wilson Football Tag module. The module will only be installed into host devices by Wilson Sporting Goods or by specific manufacturers under the direct instruction of Wilson Sporting Goods. In this way, the compliance of the end product will always be assured.

Wilson Sporting Goods understands that any end host device using this module must include the following information on the host device:

Contains FCC ID: 2AHBQWX1F3C8

Contains IC: 21110-WX1F3C8

Additionally the host device's user manual will include the relevant FCC and IC compliance statements:

This device complies with Part 15 of the FCC Rules and with Industry Canada license-exempt RSS standard(s). Operation is subject to the following two conditions: (1) This device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.
