SETUP

3. Follow in-app instructions to complete the setup and connect the camera to your Wi-Fi network.

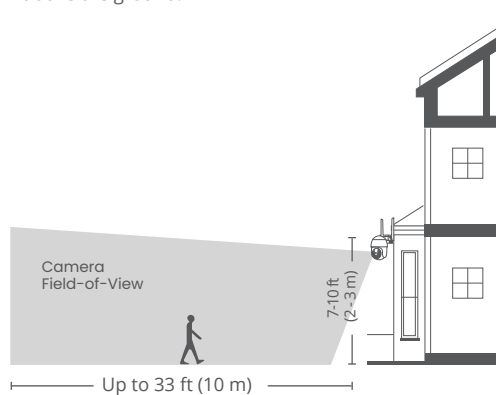
MOUNTING

Select a Location

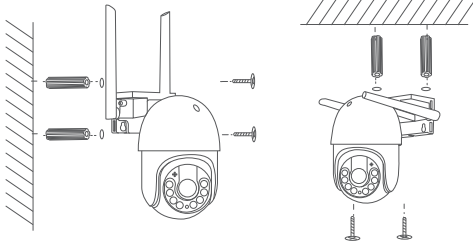
Select a location for the desired view:

- Make sure the camera can reach a power outlet and receive a strong Wi-Fi signal.
- For best results, mount the camera 7-10 ft (2-3 m) above the ground.



Mount the Camera

Mount the camera onto the wall or the ceiling with the provided screws.



SAFETY

- Do not use the device in the environment at too high or too low temperature, never expose the device to strong sunshine or too wet environment.
- The suitable temperature for the device and accessories is temperature is 0°C to 40°C.
