

How it works

1.Connection Instruction

- a. Connecting the power supply according to the diagram.
- b. Put device on wireless charging area.
- c. When the indicator lamp is on, it indicates that it is ready to charge.

2. Power Indicator Instuction

- a. After connecting the power source, the sky blue lamp and green lamp flashes once orderly, then die out.
- b. When the Wireless Phone is placed in the Wireless charging area 1 and the devices enters the charging state, the green lamp indicator light is always on.
- c. When the iWatch is placed in the wireless charging area 2 and the devices enters the charging state, the blue lamp indicator is always on.
- d. When the two areas are charged at the same time, the sky blue indicator light is always on.
- e. The green light flashes when other metallic foreign objects are placed in the wireless charging zone.(FOD detection)





Notice

a. Please use QC compatible power adapter to achieve fast charge. It is a normal phenomenon of fever during the charging process. b. Please kindly take off the device after full charge to protect device and wireless charger.
