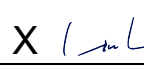

The minimum distance for the EUT is less than 5mm.

**For Bluetooth Chip1 stand-alone:**

Since maximum peak output power of the transmitter is 3.99 dBm  $\approx 2.51 \text{ mW} < \frac{3 \cdot d}{\sqrt{f}} = 9.52 \text{ mW}$ .

Hence the EUT is excluded from SAR evaluation according to FCC KDB Publication 447498 D01 General RF Exposure Guidance v06.
