



1: Switch key

Switch the machine for 2 seconds long. Switch mode short by 1 second.

2: Bluetooth key


Long press Bluetooth to turn on / off and prompt tone.

3: Next key


Press one second to play the next piece of music. Long press 2 seconds, music pause.

4: Volume key

The volume size is divided into 4 files, and the boot defaults 2 files. You can press small to large $1\,$ - 4 files. Each press 1 times, 1 files.



Five modes of intelligent function



Warm prompt: each mode defaults to 15 minutes automatic shutdown. A warning tone occurs when the battery voltage is too low.
