Indicator light description

The device adopts two-color indicator light, which flashes in different colors and frequencies to represent different states of the device:


Indicator state	corresponding states
Blue light once	Unlock successfully
Red light once	Failed to unlock/ fingerprint collection
The red and blue lights flash twice at the same time	Fingerprint collection mode/ fingerprint collection successful
The red light flashed three times	Command fails
The red light dimly flashes	charging state
Long bright blue light	charge complete


