

The automatic bandwidth measurement capability of an instrument may be employed using the X dB bandwidth mode with X set to 6 dB, if the functionality described above (i.e., RBW = 100 kHz, VBW \geq 3 × RBW, peak detector with maximum hold) is implemented by the instrumentation function. When using this capability, care shall be taken so that the bandwidth measurement is not influenced by any intermediate power nulls in the fundamental emission that might be \geq 6 dB.

Limit

According to §15.247(a)(2), systems using digital modulation techniques may operate 902 \sim 928 Mb, 2 400 \sim 2 483.5 Mb, and 5 725 \sim 5 850 Mb bands. The minimum 6 dB bandwidth shall be at least 500 kb.

The maximum peak conducted output power may be measured using a broadband peak RF power m eter. The power meter shall have a video bandwidth that is greater than or equal to the DTS bandw idth and shall use a fast-responding diode detector.

ANSI C63.10-2013 - Section 11.9.2.3.2

Alternatively, measurements may be performed using a wideband gated RF power meter provided that the gate parameters are adjusted such that the power is measured only when the EUT is transmitting at its maximum power control level. Because the measurement is made only during the ON time of the transmitter, no duty cycle correction is required.

Limit

According to §15.247(b)(3), For systems using digital modulation in the 902~928 Mb, 2 400~2 483.5 Mb, and 5 725~5 850 Mb bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted out-put power. Maximum Conducted Out-put Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the maximum conducted output power is the highest total transmit power occurring in any mode.

- a. Set analyzer center frequency to DTS channel center frequency.
- b. Set the span to 1.5 times the DTS bandwidth.
- c. Set the RBW to 3 kHz \leq RBW \leq 100 kHz
- d. Set the VBW \geq [3 × RBW].
- e. Detector = peak.
- f. Sweep time = auto couple.
- g. Trace mode = max hold.
- h. Allow trace to fully stabilize.
- i. Use the peak marker function to determine the maximum amplitude level within the RBW.
- j. If measured value exceeds requirement, then reduce RBW (but no less than 3 kHz) and repeat.

Limit

According to §15.247(e), For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 klb band during any time interval of continuous transmission. This power spectral density shall be determined in accordance with the provisions of paragraph (b) of this section. The same method of determining the conducted output power shall be used to determine the power spectral density.





The diagram below shows the test setup that is utilized to make the measurements for emission from 30 Mb to 1 Gb emissions.





The diagram below shows the test setup that is utilized to make the measurements for emission from 1 GHz to the tenth harmonic of the highest fundamental frequency or to 40 GHz emissions, whichever is lower.



Test procedure

Radiated emissions from the EUT were measured according to the dictates in section 11.11 & 11.12 of ANSI C63.10-2013.

Test procedure below 30 Mb

- The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- 2. Then antenna is a loop antenna is fixed at one meter above the ground to determine the maximum value of the field strength. Both parallel, ground parallel and perpendicular of the antenna are set to make the measurement. It was determined that <u>parallel</u> was worst-case orientation; therefore, all final radiated testing was performed with the EUT in <u>parallel</u>.
- 3. For each suspected emission, the EUT was arranged to its worst case and then the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- 4. The test-receiver system was set to average or quasi peak detect function and Specified Bandwidth with Maximum hold mode.

Test procedure above 30 №

- 1. The EUT was placed on the top of a rotating table 1.5 meters above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- The antenna is a bi-log antenna, a horn antenna ,and its height are varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- 3. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- The test receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- 5. Spectrum analyzer settings for f < 1 GHz:
 - ① Span = wide enough to fully capture the emission being measured
 - ② RBW = 100 kHz
 - ③ VBW ≥ RBW
 - ④ Detector = quasi peak
 - Sweep time = auto
 - 6 Trace = max hold

- 6. Spectrum analyzer settings for $f \ge 1$ GHz: Peak
 - ① Analyzer center frequency was set to the frequency of the radiated spurious emission of interest
 - ② RBW = 1 Mbz
 - ③ VBW ≥ 3 Mb
 - 4 Detector = peak
 - Sweep time = auto
 - 6 Trace = max hold
 - 7 Trace was allowed to stabilize
- 7. Spectrum analyzer settings for $f \ge 1$ GHz: Average
 - ① Analyzer center frequency was set to the frequency of the radiated spurious emission of interest
 - ② RBW = 1 Mb
 - ③ VBW ≥ 3 × RBW
 - ④ Detector = RMS, if span/(# of points in sweep) ≤ (RBW/2). Satisfying this condition may require increasing the number of points in the sweep or reducing the span. If this condition cannot be satisfied, then the detector mode shall be set to peak.
 - ⑤ Averaging type = power(i.e., RMS)
 - 1) As an alternative, the detector and averaging type may be set for linear voltage averaging.
 - 2) Some instruments require linear display mode in order to use linear voltage averaging. Log or dB averaging shall not be used.
 - 6 Sweep = auto
 - 7 Trace = max hold
 - 8 Perform a trace average of at least 100 traces.
 - A correction factor shall be added to the measurement results prior to comparing to the emission limit in order to compute the emission level that would have been measured had the test been performed at 100 percent duty cycle. The correction factor is computed as follows:
 - 1) If power averaging (RMS) mode was used in step (5), then the applicable correction factor is $(10 \log(1/x))$, where x is the duty cycle.
 - 2) If linear voltage averaging mode was used in step \mathfrak{S} , then the applicable correction factor is $20 \log(1/x)$, where x is the duty cycle.
 - 3) If a specific emission is demonstrated to be continuous (≥ 98 percent duty cycle) rather than turning on and off with the transmit cycle, then no duty cycle correction is required for that emission.

- 4. Emissions below 18 GHz were measured at a 3 meter test distance while emissions above 18 GHz were measured at a 1 meter test distance with the application of a distance correction factor.
- The fundamental of the EUT was investigated in three orthogonal orientations X, Y and Z, it was determined
 that <u>X orientation</u> was worst-case orientation; therefore, all final radiated testing was performed with the EUT
 in X orientation.
- 6. The worst-case emissions are reported however emissions whose levels were not within 20 $\rm dB$ of respective limits were not reported.
- 7. According to exploratory test no any obvious emission were detected from 9 klb to 30 Mlb. Although these tests were performed other than open field site, adequate comparison measurements were confirmed against 30 m open field site. Therefore sufficient tests were made to demonstrate that the alternative site produces results that correlate with the ones of tests made in an open field based on KDB 414788.

LimitAccording to 15.209(a), for an intentional radiator devices, the general required of field strength of radiated emissions from unintentional radiators at a distance of 3 meters shall not exceed the following values:
