Safety Information 🗘

Vista Pad is designed with user safety as a top priority. However, improper usage may result in electric shock, fire, or damage to the device. To avoid such risks, please follow these guidelines during setup, operation, and maintenance:

General Safety Guidelines:

- Prevent Electric Shock or Fire: Do not expose the tablet to rain, liquids, or excessive moisture.
- Inspect Cables: Ensure all cables are securely connected and undamaged before use. If damaged, contact your retailer for assistance.
- Avoid Extreme Conditions: Keep the device away from excessive dust, humidity, or extreme temperatures. Do not place it in areas prone to moisture or direct sunlight.
- Prevent Intrusions: Avoid inserting foreign objects or letting liquids spill into the tablet.
- Use Certified Accessories: Always use accessories provided by ARZOPA or certified by the manufacturer to ensure compatibility and safety.
- Do Not Attempt Repairs: There are no user-serviceable parts inside the device. For any issues, contact ARZOPA customer support.

To Avoid Injuries:


- Place the tablet on a stable, flat surface.

- Keep out of reach of children to avoid potential harm or device damage.
- Use only accessories specifically designed for Vista Pad.
- Disconnect the power cord when the device will not be used for an extended period.
- During lightning storms, avoid contact with power cords or cables.

To Protect the Device:

- Do not press or scratch the screen with hard objects, as this may result in permanent damage.
- Use the recommended resolution for the best performance. Non-standard resolutions may lead to display issues.
- Avoid displaying static images for long durations to prevent screen retention.

For any technical problems, contact professional support or your retailer. Handle the device with care to prevent damage. Always lift the tablet using both hands, holding the edges securely.

Operating Instructions



Before First Use

Inspect the device and ensure all accessories are included and undamaged.
 If there are any issues, contact your retailer immediately.

Rear Stand

- To power on the Vista Pad, press and hold the power button located on the side of the device.
- Adjust the rear stand to your desired angle for a comfortable viewing experience, whether in landscape or portrait orientation.

Maintenance and Cleaning 🙆



- Power off the Vista Pad and unplug any connected cables before cleaning.
- Use a soft, non-abrasive cloth for cleaning. For tougher stains, lightly dampen the cloth with a mild cleaning solution and wipe the surface gently.
- Avoid using cleaning agents containing alcohol, acetone, or other harsh chemicals.
- Do not spray liquid directly onto the screen to prevent seepage into internal components.

Important Notes on Display Behavior

- Slight brightness variations may occur based on the displayed image—this is normal.
- Prolonged display of a static image may result in temporary screen retention.
 Use a screen saver or power off the device when not in use for extended periods.
- If the screen becomes unresponsive or displays unusual behavior, contact ARZOPA customer support for assistance.

Vista Pad includes a 1-year limited warranty.

- Within 7 Days of Purchase: You may request a refund, replacement, or repair for eligible defects.
- Within 15 Days of Purchase: You may request a replacement or repair for eligible defects.
- Within 1 Year of Purchase: You are entitled to free repairs for defects covered under warranty.

Exclusions from Warranty

The warranty does not cover:

- · Expired warranty period.
- Absence of valid proof of purchase.
- Screen issues with 3 or fewer dead or bright pixels.
- Damage caused by improper use, unauthorized repairs, or accidental drops.
- Damage due to natural disasters or external forces, such as power surges.
