




#### 6 Radiated Emission Test

6.1 Test Method and test Procedure:

- (1) The EUT was tested according to ANSI C63.10-2013. The radiated test was performed at TIMEWAY EMC Laboratory. This site is on file with the FCC laboratory division, Registration No.744189
- (2) The EUT, peripherals were put on the turntable which table size is 1m x 1.5 m, table high 0.8 m. All set up is according to ANSI C63.10-2013.
- (3) The frequency spectrum from 30 MHz to 5 GHz was investigated. All readings from 30 MHz to 1 GHz are quasi-peak values with a resolution bandwidth of 120 kHz. All readings are above 1 GHz, peak values with a resolution bandwidth of 1 MHz. Measurements were made at 3 meters.
- (4) The antenna high is varied from 1 m to 4 m high to find the maximum emission for each frequency.
- (5) Maximizing procedure was performed on the six (6) highest emissions to ensure EUT compliance is with all installation combinations. All data was recorded in the peak detection mode. Quasi-peak readings was performed only when an emission was found to be marginal (within -4 dB of specification limit), and are distinguished with a "QP" in the data table.
- (6) The antenna polarization: Vertical polarization and Horizontal polarization.

## **Block diagram of Test setup**





## Horizontal





## 7.0 20dB and 99% Bandwidth Testing

## 7.1 Requirement

Per 15.231(c) and RSS-210 A1, The bandwidth of the emission shall be no wider than 0.25% of the center frequency for devices operating above 70 MHz and below 900 MHz. Bandwidth is determined at the points 20 dB down from the modulated carrier.

## 7.2 Test Procedure

With the EUT's antenna attached, the EUT's 20dB Bandwidth power was received by the test antenna which was connected to the spectrum analyzer with the START and STOP frequencies set to the EUT's operation band.



## 20dB Bandwidth







- 1. Place the EUT on the table and set it in transmitting mode.
- 2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.
- 3. Set center frequency of spectrum analyzer=operating frequency.
- 4. Set the spectrum analyzer as RBW = VBW=1000kHz, Span=0Hz, Adjust Sweep=100ms.
- 5. Repeat above procedures until all frequency measured were complete.

This requirement does not apply to carrier current devices or to devices operated under the provisions of Sections 15.211, 15.213, 15.217, 15.219, or 15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with Section 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded.
