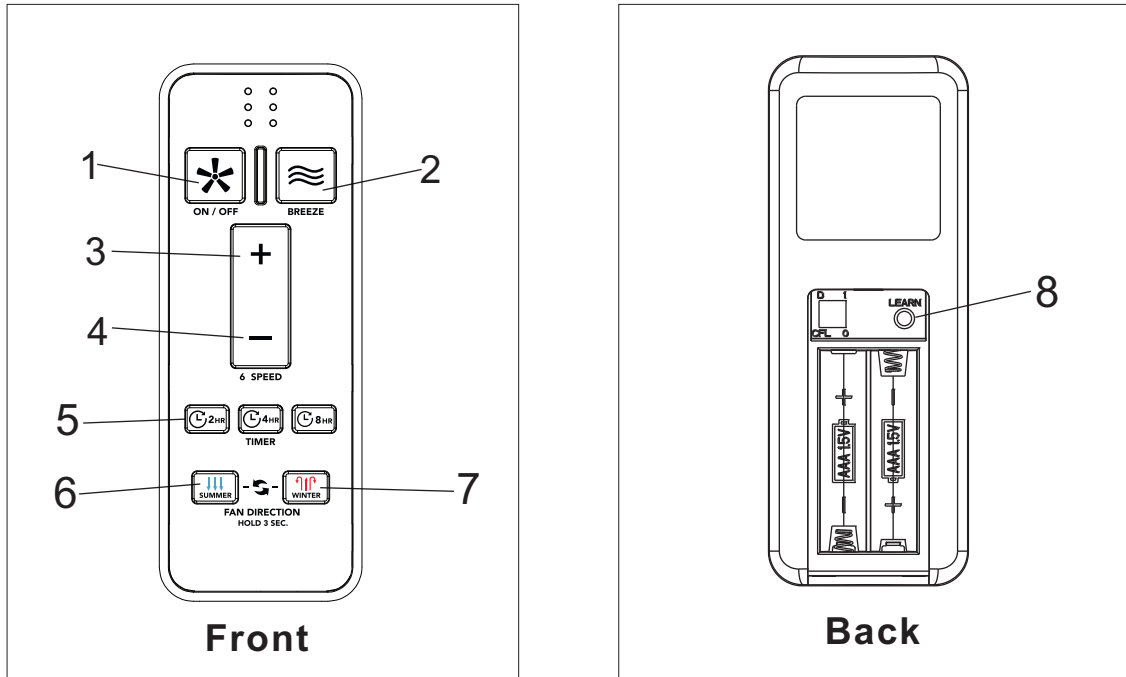


# OPERATION INSTRUCTION

Note:  
Install two AAA 1.5V batteries to the remote control.

## ***Remote Control Functions:***

1. FAN ON/OFF Button: Turn the fan on or off.
2. Nature Breeze Button.
3. FAN Speed Button "+": Increases the fan speed.
4. FAN Speed Button "-": Decreases the fan speed.
5. Timer button: Automatically turn fan off after 2, 4, or 8 hours.
6. Fan reverse button - Warm weather (Forward).
7. Fan reverse button - Cool weather (Reverse).
8. Extended Function Switch L.

## FCC STATEMENT
