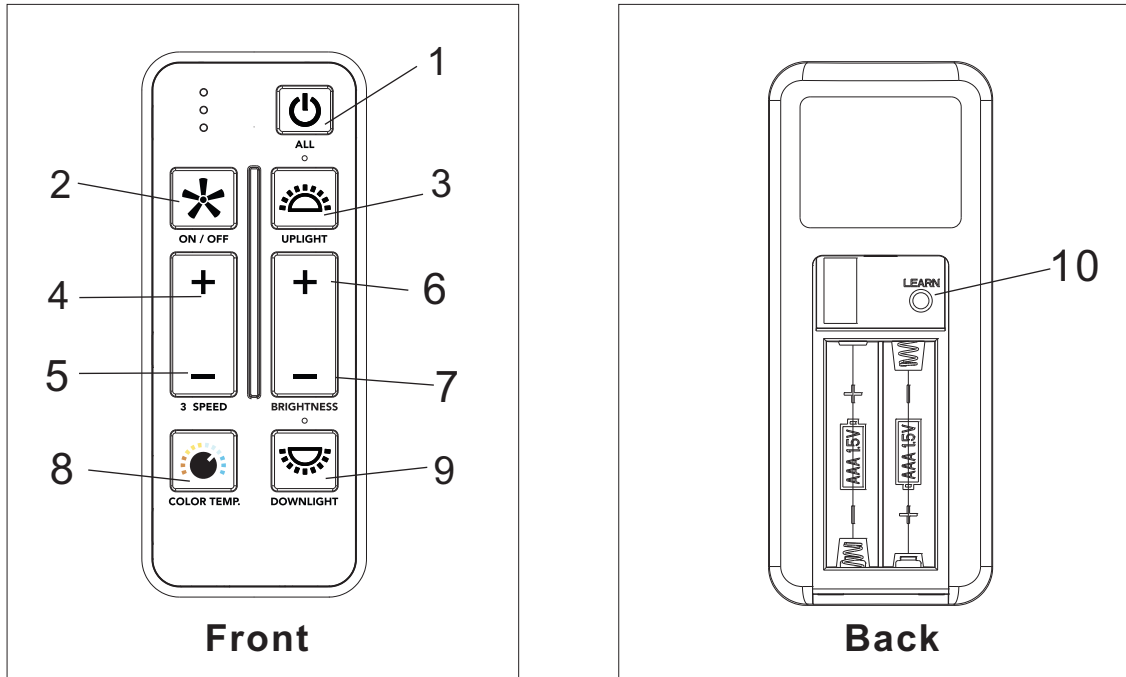


OPERATION INSTRUCTION

Note:
Install two AAA 1.5V batteries to the remote control.

Remote Control Functions:

1. FAN & LIGHT/OFF Button: Turn the fan & light on or off.
2. FAN ON/OFF Button: Turn the fan on or off.
3. UP LIGHT ON/OFF Button: Turn the up light on or off.
4. FAN Speed Button "+": Increases the fan speed.
5. FAN Speed Button "-": Decreases the fan speed.
6. Light Brightness Button "+": Increases the the light brightness.
7. Light Brightness Button "-": Decreases the light brightness.
8. CCT Function Button.
9. DOWN LIGHT ON/OFF Button: Turn the down light on or off.
10. Extended Function Switch L.

OPERATION INSTRUCTION

FCC STATEMENT
