Request for Limited Modular Transmitter Approval

This Bluetooth Module (Model: ICS-X7 BT PWB) is designed by Alpine Electronics, Inc., and only installed to devices for vehicles.

This modular transmitter complies the modular transmitters basic requirements (Item 1 to 8) in FCC Part 15 Subpart C Section 15.212 as indicated below:

[Modular transmitters basic requirements]

- (1) Have its own RF shielding: This module has its own RF shielding. Please refer to the external photo.
- (2) Have buffered modulation/data inputs: Data input to this modular transmitter is controlled as not generating excessive data speed and abnormal modulation.
- (3) Have its own power supply regulation: This module does not have its own power supply regulator, however, host device provides stable power (3.3V) to the module, and the power is not changed when voltage of the device is fluctuated.
- (4) Comply with the antenna and transmission system requirements of FCC§ 15.203, 15.204(b) and 15.204(c): Antenna is permanently printed on the module. This modular transmitter will always be used in the configuration in which it was authorized.
