Owner's Manual Use Case

IDCM Product Description:

- Module which controls 3 interior displays.
- Module runs on an android platform.
- Control of this module will be done from the interior displays.
- Module will have the capability to connect to Bluetooth, and will arbitrate the audio in the interior cabin.

Procedure to use Bluetooth Audio:

- Connect user's mobile phone to the vehicle system via Bluetooth.
- Connect user's headset or earphone to IDCM via Bluetooth.
 - Turn on user's headset or earphone, and enable Bluetooth function.
 - Touch "BT" button on the interior display.
 - IDCM searches connectable devices and shows the list of them.
 - Choose the user's headset or earphone.
- The user controls the operation (selecting audio source, volume control, playback/stop, etc.) by user's mobile phone.
