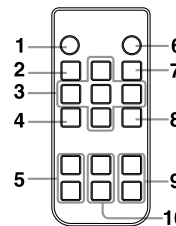
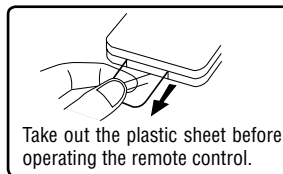


Front Panel



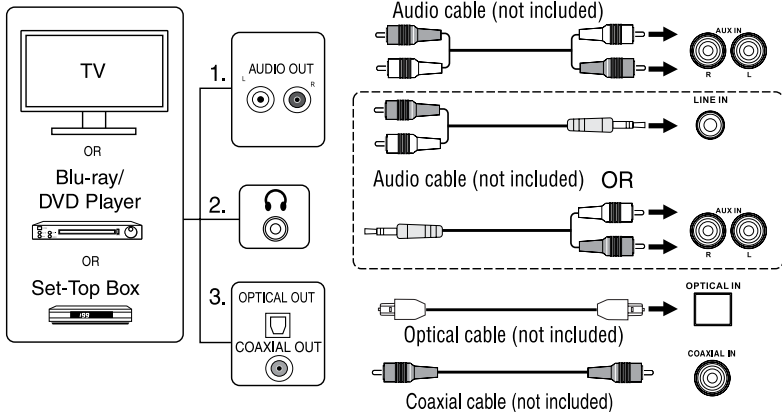

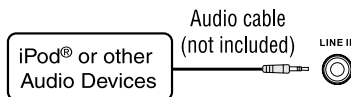


Adjust Volume, Bass and Treble

Play other devices:

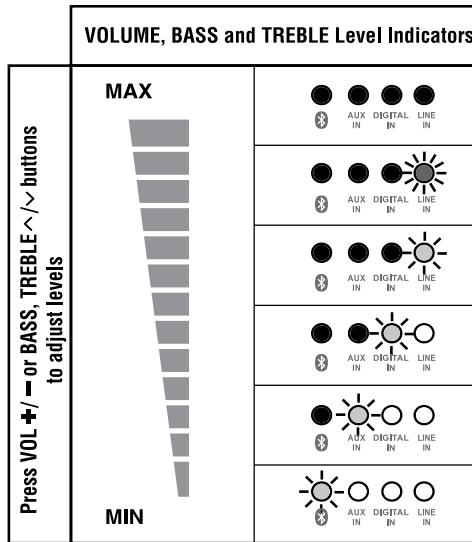


Play audio through Bluetooth:

- On your device (mobile phone, MP3 player, etc.), select "Bluetooth" from the list of available Bluetooth connections.

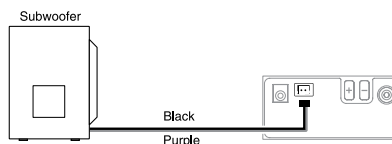
Note: If your Bluetooth device (such as, mobile phone) requires a password while pairing, please enter 4-digit number: 0000.

FCC STATEMENT

One Year Parts & Labor Warranty

AVC products purchased in the United States are warranted to be free from defects in materials or workmanship for a period of one year from the date of their original retail purchase. If the unit fails to conform to this warranty, we will service the product using new or refurbished parts and products, at AVC's sole discretion.

During a period of one year from the effective warranty date, AVC will provide, when needed, service labor to repair a manufacturing defect at its designated Service Center. To obtain warranty service in the United States, you must first contact our Customer Support Center at support.RCAAV.com. The determination of service will be made by AVC Customer Support. PLEASE DO NOT RETURN YOUR UNIT TO AVC WITHOUT PRIOR AUTHORIZATION. New or remanufactured replacements for defective parts or products will be used for repairs by AVC at its designated Service Center for one year from the effective warranty date. Such replacement parts or products are warranted for an additional one year from the date of repair or replacement. The Customer will be required to ship the unit to the Service Center indicated at the time Customer Support is contacted to make the necessary repairs. The customer is responsible for all transportation charges to the service facility.

Packaging and Shipping Instruction

When you send the product to the AVC service facility you must use the original carton box and packing material or an equivalent as designated by AVC.

Your Responsibility

- You must retain the original sale receipt to provide proof of purchase.
- These warranties are effective only if the product is purchased and operated in the U.S.A. or Canada.
