# 2. Maximum Permissible Exposure Prediction

Prediction of MPE limit at a given distance

 $S = PG/4\pi R^2$ 

S = Power density

P = Power input to antenna

G = Power gain to the antenna in the direction of interest relative to an isotropic radiator

R = Distance to the center of radiation of the antenna

### 3. Results

• The EUT duty cycle is calculated according to ANSI C63.26 - 5.2.4.3.4.

Duty Cycle = On-time / Transmitter period = 73.17 %

Duty Correction =  $10 \log (1/\text{duty cycle}) = 10 \log (1/0.7317) = 1.3569 \text{ dB}$ 

• MIMO Max. EIRP (66 dBm) – Duty Correction (1.3569 dB) + tolerance (3 dB) = Total (67.64 dBm)
