#### INTRODUCTION 1.0

#### 1.1 Scope

Measurement and determination of electromagnetic emissions (EMC) of radio frequency devices including intentional and/or unintentional radiators for compliance with the technical rules and regulations of the Federal Communications Commission and the Industry Canada Certification and Engineering Bureau.

#### 1.2 **PCTEST Test Location**




Figure 1-1. Map of the Greater Baltimore and Metropolitan Washington, D.C. area

The map below shows the location of the PCTEST LABORATORY, its proximity to the FCC Laboratory, the Columbia vicinity, the Baltimore-Washington Internt'l (BWI) airport, the city of Baltimore and the Washington, DC area. (See Figure 1-1).

These measurement tests were conducted at the PCTEST Engineering Laboratory, Inc. facility located at 7185 Oakland Mills Road, Columbia, MD 21046. The site coordinates are 39° 10'23" N latitude and 76° 49'50" W longitude. The facility is 0.4 miles North of the FCC laboratory, and the ambient signal and ambient signal strength are approximately equal to those of the FCC laboratory. The detailed description of the measurement facility was found to be in compliance with the requirements of § 2.948 according to ANSI C63.4-2009 on February 15, 2012.

#### 2.1 **Equipment Description**

The Equipment Under Test (EUT) is the Samsung Wireless LAN Multimedia Box FCC ID: A3LGTB9150. The test data contained in this report pertains only to the emissions due to the EUT's WLAN (DTS) transmitter.

The Samsung Wireless LAN Multimedia Box employs two separate antennas capable of transmitting in DTS/NII modes. These antennas are also capable to operate in Multiple Input Multiple Output (MIMO) mode.

#### 2.2 **Device Capabilities**

This device contains the following capabilities:

802.11a/b/g/n WLAN (DTS/NII), WiFi 2x2 MIMO, Bluetooth (1x,EDR, LE)

Note: 5GHz WLAN (DTS/NII) operation is possible in 20MHz and 40MHz channel bandwidths. The device employs MIMO technology. Below are the possible configurations.

CDD or Cyclic Delay Diversity MIMO function is also a capability of the EUT. However, since CDD only alters the system by transmitting a phase shifted (i.e. cyclical) copy of the original signal within the same allotted bandwidth and using the same Tx power, it was determined that CDD operation was the same, in regards to matters relating to the bandwidth and powers, as SDM MIMO mode, which is addressed in the report. Thus, no further measurements were performed for CDD MIMO operation.

#### 2.3 **Test Configuration**

The Samsung Wireless LAN Multimedia Box FCC ID: A3LGTB9150 was tested per the guidance of ANSI C63.10-2009 and KDB 558074. See Sections 3.2 and 6.1 of this test report for a description of the radiated emissions test setups.

# DESCRIPTION OF TEST

#### **Evaluation Procedure** 3.1

The measurement procedures described in the American National Standard for Testing Unlicensed Wireless Devices (ANSI C63.10-2009), and the guidance provided in KDB 558074 were used in the measurement of the Samsung Wireless LAN Multimedia Box FCC ID: A3LGTB9150.

#### 3.2 **Radiated Emissions**

The radiated test facilities consisted of an indoor 3 meter semi-anechoic chamber used for final measurements and exploratory measurements, when necessary. The measurement area is contained within the semianechoic chamber which is shielded from any ambient interference. For measurements above 1GHz absorbers are arranged on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections. For measurements below 1GHz, the absorbers are removed. An ETS Lindgren Model 2188 raised turntable is used for radiated measurement. It is a continuously rotatable, remotecontrolled, metallic turntable and 2 meters (6.56 ft.) in diameter. The turn table is flush with the raised floor of the chamber in order to maintain its function as a ground plane. A 78cm high PVC support structure is placed on top of the turntable. A 3/4" (~1.9cm) sheet of high density polyethylene is used as the table top and is placed on top of the PVC supports to bring the total height of the table to 80cm.

For all measurements, the spectrum was scanned through all EUT azimuths and from 1 to 4 meter receive antenna height using a broadband antenna from 30MHz up to the upper frequency shown in 15.33(b)(1) depending on the highest frequency generated or used in the device or on which the device operates or tunes. For frequencies above 1GHz, linearly polarized double ridge horn antennas were used. For frequencies below 30MHz, a calibrated loop antenna was used. When exploratory measurements were necessary, they were performed at 1 meter test distance inside the semi-anechoic chamber using broadband antennas, broadband amplifiers, and spectrum analyzers to determine the frequencies and modes producing the maximum emissions. Sufficient time for the EUT, support equipment, and test equipment was allowed in order for them to warm up to their normal operating condition. The test set-up was placed on top of the 0.8 meter high, 1 x 1.5 meter table. The EUT, support equipment, and interconnecting cables were arranged and manipulated to maximize each emission. Appropriate precaution was taken to ensure that all emissions from the EUT were maximized and investigated. The system configuration, clock speed, mode of operation or video resolution, if applicable, turntable azimuth, and receive antenna height was noted for each frequency found.

Final measurements were made in the semi-anechoic chamber using calibrated, linearly polarized broadband and horn antennas. The test setup was configured to the setup that produced the worst case emissions. The spectrum analyzer was set to investigate all frequencies required for testing to compare the highest radiated disturbances with respect to the specified limits. The turntable containing the EUT was rotated through 360 degrees and the height of the receive antenna was varied 1 to 4 meters and stopped at the azimuth and height producing the maximum emission. Each emission was maximized by varying: the mode of operation or resolution, clock or data rate, scrolling H pattern to the EUT and/or support equipment, and changing the polarity of the receive antenna, whichever produced the worst-case emissions.

#### **Test Overview and Limit**

All out of band radiated spurious emissions are measured with a spectrum analyzer connected to a receive antenna while the EUT is operating at its maximum duty cycle (>98%), at maximum power, and at the appropriate frequencies. All data rates and modes were investigated for radiated spurious emissions. Only the radiated emissions of the configuration that produced the worst case emissions are reported in this section. Worst case radiated emissions were found to be in 802.11b and 802.11a mode. MIMO (802.11n) radiated spurious emissions were found to be less than or equal to 802.11a emissions and thus are not reported.

All out of band emissions appearing in a restricted band as specified in Section 15.205 of the Title 47 CFR must not exceed the limits shown in Table 6-2 per Section 15.209.




Figure 6-1. Test Instrument & Measurement Setup

#### **Test Notes**

- The optional test procedures for antenna port conducted measurements of unwanted emissions per the guidance of KDB 558074 v03 were not used to evaluate this device for compliance to radiated limits. All radiated spurious emissions levels were measured in a radiated test setup per the guidance in Section 12.2.6 of KDB 558074.
- 2. All emissions lying in restricted bands specified in §15.205 are below the limit shown in Table 6-10.
- 3. The antenna is manipulated through typical positions, polarity and length during the tests. The EUT is manipulated through three orthogonal planes.
- 4. The EUT is supplied with nominal AC voltage and/or a new/fully-recharged battery.
- 5. The spectrum is measured from 9kHz to the 10th harmonic of the fundamental frequency of the transmitter using CISPR quasi peak detector below 1GHz. 


Plot 6-1. Radiated Restricted Lower Band Edge Measurement (Average)


Plot 6-2. Radiated Restricted Lower Band Edge Measurement (Peak)




Plot 6-3. Radiated Restricted Upper Band Edge Measurement (Average)


Plot 6-4. Radiated Restricted Upper Band Edge Measurement (Peak)




Plot 6-6. Radiated Restricted Lower Band Edge Measurement (Peak)




Plot 6-7. Radiated Restricted Upper Band Edge Measurement (Average)
