8.3. 20dB channel bandwidth



<u>Limit</u>

According to §15.247(a)(1), frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 $\,\mathrm{klz}$ or the 20 $\,\mathrm{dB}$ bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2 400-2 483.5 $\,\mathrm{klz}$ band may have hopping channel carrier frequencies that are separated by 25 $\,\mathrm{klz}$ or two-thirds of the 20 $\,\mathrm{dB}$ bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 $\,\mathrm{mW}$.

ANSI C63.10-2013 - Section 6.9.2

Test settings

20dB channel bandwidth and Occupied bandwidth

The occupied bandwidth is measured as the width of the spectral envelope of the modulated signal, at an amplitude level reduced from a reference value by a specified ratio (or in decibels, a specified number of dB down from the reference value). Typical ratios, expressed in dB, are -6 dB, -20 dB, and -26 dB, corresponding to 6 dB BW, 20 dB BW, and 26 dB BW, respectively. In this subclause, the ratio is designated by "-xx dB." The reference value is either the level of the unmodulated carrier or the highest level of the spectral envelope of the modulated signal, as stated by the applicable requirement. Some requirements might specify a specific maximum or minimum value for the "-xx dB" bandwidth; other requirements might specify that the "-xx dB" bandwidth be entirely contained within the authorized or designated frequency band.

- a) The spectrum analyzer center frequency is set to the nominal EUT channel center frequency.
- b) Span: Two times and five times the OBW.
- c) RBW = 1 % to 5 % of the OBW and VBW \geq 3 x RBW
- d) Set the reference level of the instrument as required, keeping the signal from exceeding the maximum input mixer level for linear operation.
- e) The dynamic range of the instrument at the selected RBW shall be more than 10 dB below the target "-xx dB down" requirement; that is, if the requirement calls for measuring the -20 dB OBW, the instrument noise floor at the selected RBW shall be at least 30 dB below the reference value.
- f) Detector: peak
- g) Trace mode: max hold.
- h) Allow the trace to stabilize.
- i) Determine the "-xx dB down amplitude" using ((reference value) xx). Alternatively, this calculation may be made by using the marker-delta function of the instrument.
- j) If the reference value is determined by an unmodulated carrier, then turn the EUT modulation ON, and either clear the existing trace or start a new trace on the spectrum analyzer and allow the new trace to stabilize. Otherwise, the trace from step g) shall be used for step j).
- k) Place two markers, one at the lowest frequency and the other at the highest frequency of the

The occupied bandwidth is the frequency difference between the two markers. Alternatively, set a marker at the lowest frequency of the envelope of the spectral display, such that the marker is at or slightly below the " $-xx\ dB$ down amplitude" determined in step h). Reset the marker-delta function and move the marker to the other side of the emission until the delta marker amplitude is at the same level as the reference marker amplitude. The marker-delta frequency reading at this point is the specified emission bandwidth.





8.5. Time of occupancy(Dwell time)



Limit

According to §15.247(a)(1)(iii), frequency hopping systems in the 2 400-2 483.5 Mb band shall use at least 15 channels. The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed. Frequency hopping systems may avoid or suppress transmissions on a particular hopping frequency provided that a minimum of 15 channels are used.

Test procedure

ANSI C63.10-2013 - Section 7.8.4

Test settings

- a) Span: Zero span, centered on a hopping channel.
- b) RBW ≤ channel spacing and >> 1 / T, where T is the expected dwell time per channel.
- c) Sweep: As necessary to capture the entire dwell time per hopping channel; where possible use a video trigger and trigger delay so that the transmitted signal starts a little to the right of the start of the plot. 


The diagram below shows the test setup that is utilized to make the measurements for emission from 9 kHz to 30 MHz Emissions

8.7. Conducted Spurious Emission



<u>Limit</u>

According to §15.247(d), In any 100 klb bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operation, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 klb bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation specified in §15.209(a) is not required. In addition, radiated emission limits specified in §15.209(a) (see §15.205(c)).







8.8. AC Conducted emission

According to 15.207(a), for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies, within the band 150 Å to 30 Å, shall not exceed the limits in the following table, as measured using a 50uH/50 ohm line impedance stabilization network (LISN). Compliance with the provision of this paragraph shall on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower applies at the boundary between the frequencies ranges.

Measurement procedure

- 1. The EUT was placed on a wooden table of size, 1 m by 1.5 m, raised 80 cm in which is located 40 cm away from the vertical wall and 1.5m away from the side wall of the shielded room.
- 2. Each current-carrying conductor of the EUT power cord was individually connected through a $50\Omega/50\mu H$ LISN, which is an input transducer to a spectrum analyzer or an EMI/Field Intensity Meter, to the input power source.
- 3. Exploratory measurements were made to identify the frequency of the emission that had the highest amplitude relative to the limit by operating the EUT in a range of typical modes of operation, cable position, and with a typical system equipment configuration and arrangement. Based on the exploratory tests of the EUT, the one EUT cable configuration and arrangement and mode of operation that had produced the emission with the highest amplitude relative to the limit was selected for the final measurement.
- 4. The final test on all current-carrying conductors of all of the power cords to the equipment that comprises the EUT (but not the cords associated with other non-EUT equipment is the system) was then performed over the frequency range of 0.15 Mb to 30 Mb.
- 5. The measurements were made with the detector set to peak amplitude within a bandwidth of 10 kHz or to quasi-peak and average within a bandwidth of 9 kHz. The EUT was in transmitting mode during the measurements.


