## 2. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.10-2009, FCC CFR 47 Part 2, FCC CFR 47 Part 15.

## 3. FACILITIES AND ACCREDITATION

The test sites and measurement facilities used to collect data are located at 218 Maeyeong-ro, Yeongtong-gu, Suwon-si, Gyeonggi-do, 16675, Korea. Line conducted emissions are measured only at the 218 address. The following table identifies which facilities were utilized for radiated emission measurements documented in this report. ## 4. CALIBRATION AND UNCERTAINTY

### 4.1. MEASURING INSTRUMENT CALIBRATION

The measuring equipment utilized to perform the tests documented in this report has been calibrated in accordance with the manufacturer's recommendations, and is traceable to recognized national standards.

### 4.2. SAMPLE CALCULATION

Where relevant, the following sample calculation is provided:

$$\begin{aligned} \text{Field Strength (dBuV/m)} &= \text{Measured Voltage (dBuV)} + \text{Antenna Factor (dB/m)} + \\ &\text{Cable Loss (dB)} - \text{Preamp Gain (dB)} \\ 36.5 \text{ dBuV} + 18.7 \text{ dB/m} + 0.6 \text{ dB} - 26.9 \text{ dB} &= 28.9 \text{ dBuV/m} \end{aligned}$$

### 4.3. MEASUREMENT UNCERTAINTY

Where relevant, the following measurement uncertainty levels have been estimated for tests performed on the apparatus:

This test report addresses the DTS (BLE) operational mode.

The transmitter has a maximum total conducted output power as follows:

### 5.3. DESCRIPTION OF AVAILABLE ANTENNAS

The radio utilizes an FPCB antenna, with a maximum gain of -3.75dBi

### 5.4. WORST-CASE CONFIGURATION AND MODE

Radiated emission and power line conducted emission were performed with the EUT set to transmit at the channel with highest output power as worst-case scenario.

The fundamental of the EUT was investigated in three orthogonal orientations X, Y and Z it was determined that X orientation was worst-case orientation; therefore, all final radiated testing was performed with the EUT in X orientation.

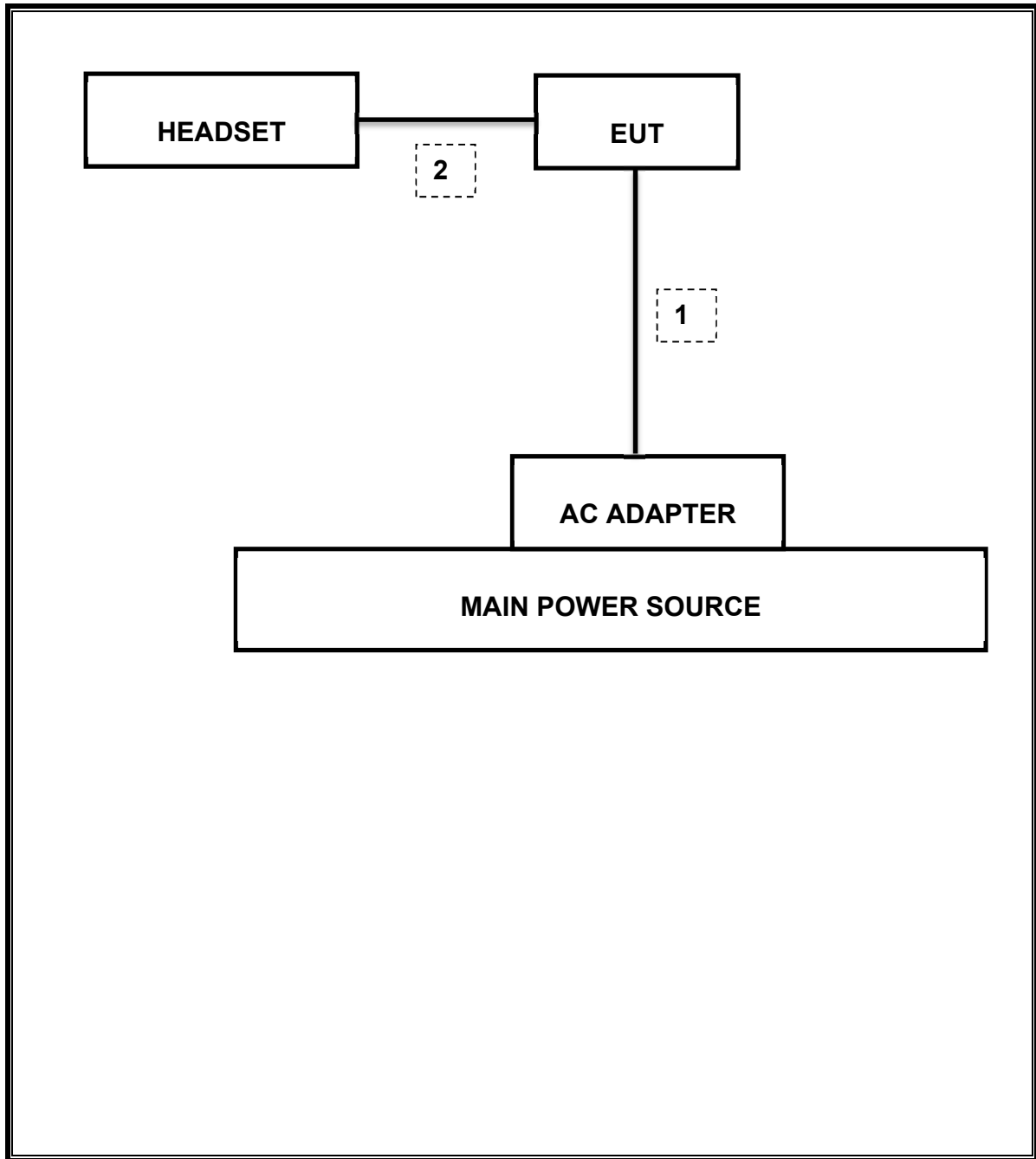

## 7. MEASUREMENT METHODS

KDB 558074 D01 DTS Meas Guidance v03r04: Measurement Procedure §9.1.1 is used for peak power and §10.2 PKPSD is used for power spectral density.

Unwanted emissions within Restricted Bands are measured using traditional radiated procedures.

Band edge emissions within Restricted Bands are measured using RMS with duty cycle factor offset method.

## 9. SUMMARY TABLE

The FCC ID: A3LSMA310N0 shares the same enclosure and circuit board as FCC ID: A3LSMA310M. The BLE circuitry and layout, including antennas, are almost identical between the two units. The BLE antennas and surrounding circuitry are the same between these two units.

After confirming through preliminary radiated emissions that the performance of the FCC ID: A3LSMA310M remains representative of FCC ID: A3LSMA310N0, test data for FCC ID: A3LSMA310M is being submitted for this application to cover BLE features

## 10. ANTENNA PORT TEST RESULTS

### 10.1. 6 dB BANDWIDTH

#### LIMITS

FCC §15.247 (a) (2)

The minimum 6 dB bandwidth shall be at least 500 kHz.

#### TEST PROCEDURE

The transmitter output is connected to a spectrum analyzer. The RBW is set to 100 kHz and the VBW is set to 300 kHz. The sweep time is coupled.

### 10.2. 99% BANDWIDTH

#### LIMITS

#### TEST PROCEDURE

The transmitter output is connected to the spectrum analyzer. The RBW is set to 1% to 3% of the 99 % bandwidth and to 1% of the span. The VBW is set to 3 times the RBW. The sweep time is coupled. The spectrum analyzer internal 99% bandwidth function is utilized.

### **10.3. OUTPUT POWER**

#### **LIMITS**

The maximum antenna gain is less than or equal to 6 dBi, therefore the limit is 30 dBm.

#### **TEST PROCEDURE**

Peak power is measured using KDB558074 D01 DTS Meas Guidance v03r03 under section 9.1.1 utilizing spectrum analyzer.

## **10.5. PSD**

### **LIMITS**

FCC §15.247

The power spectral density conducted from the transmitter to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

Power Spectral Density was performed utilizing the "Method PKPSD (Peak PSD)" under KDB558074 D01 DTS Meas Guidance v03r03

## **10.6. CONDUCTED SPURIOUS EMISSIONS**

### **LIMITS**

Output power was measured based on the use of a peak measurement, therefore the required attenuation is 20 dB.

### **TEST PROCEDURE**

The transmitter output is connected to a spectrum analyzer. The resolution bandwidth is set to 100 kHz. The video bandwidth is set to 300 kHz.

The spectrum from 30 MHz to 26 GHz is investigated with the transmitter set to the lowest, middle, and highest channels.

### 11.1. LIMITS AND PROCEDURE

#### TEST PROCEDURE

The EUT is placed on a non-conducting table 80 cm above the ground plane. The antenna to EUT distance is 3 meters. The EUT is configured in accordance with ANSI C63.10 - 2009. The EUT is set to transmit in a continuous mode.

For measurements below 1 GHz the resolution bandwidth is set to 100 kHz for peak detection measurements or 120 kHz for quasi-peak detection measurements. Peak detection is used unless otherwise noted as quasi-peak.

For measurements above 1 GHz the resolution bandwidth is set to 1 MHz, then the video bandwidth is set to 1 MHz for peak measurements and add duty cycle factor for average measurements. Duty cycle factor =  $10 \log(1/x)$ . For this sample: DCF =  $10 \log(1/0.622) = 2.06 \text{ dB}$  (Spectrum Analyzer round it up to 2.06dB)

The spectrum from 30 MHz to 26 GHz is investigated with the transmitter set to the lowest, middle, and highest channels in the 2.4 GHz band.

The frequency range of interest is monitored at a fixed antenna height and EUT azimuth. The EUT is rotated through 360 degrees to maximize emissions received. The antenna is scanned from 1 to 4 meters above the ground plane to further maximize the emission. Measurements are made with the antenna polarized in both the vertical and the horizontal positions.
