2. INTRODUCTION

2.1. DESCRIPTION OF EUT

The EUT was a Mobile Phone with GSM/GPRS/EGPRS/UMTS, CDMA(BC0, 1, 10) and LTE, Sub6. It also supports IEEE 802.11 a/b/g/n/ac (HT20/40/80), Bluetooth, BT LE, NFC.

2.2. MEASURING INSTRUMENT CALIBRATION

The measuring equipment, which was utilized in performing the tests documented herein, has been calibrated in accordance with the manufacturer's recommendations for utilizing calibration equipment, which is traceable to recognized national standards.

2.3. TEST FACILITY

The Fully-anechoic chamber and conducted measurement facility used to collect the radiated data are located at the **74**, **Seoicheon-ro 578beon-gil**, **Majang-myeon**, **Icheon-si**, **Gyeonggi-do**, **17383**, **Rep. of KOREA**.

3.2 RADIATED POWER

Test Overview

Radiated tests are performed in the Fully-anechoic chamber.

The equipment under test is placed on a non-conductive table 3-meters away from the receive antenna in accordance with ANSI/TIA-603-E-2016 Clause 2.2.17.

Test Settings

- Radiated power measurements are performed using the signal analyzer's "channel power" measurement capability for signals with continuous operation.
- 2. RBW = 1 5% of the expected OBW, not to exceed 1MHz
- 3. VBW ≥ 3 x RBW
- 4. Span = 1.5 times the OBW
- 5. No. of sweep points > 2 x span / RBW
- 6. Detector = RMS
- 7. Trigger is set to "free run" for signals with continuous operation with the sweep times set to "auto".
- 8. The integration bandwidth was roughly set equal to the measured OBW of the signal for signals with continuous operation.
- 9. Trace mode = trace averaging (RMS) over 100 sweeps
- 10. The trace was allowed to stabilize

Test Note

- 1. The turntable is rotated through 360 degrees, and the receiving antenna scans in order to determine the level of the maximized emission.
- 2. A half wave dipole is then substituted in place of the EUT. For emissions above 1GHz, a horn antenna is substituted in place of the EUT. The substitute antenna is driven by a signal generator and the previously recorded signal was duplicated.

The power is calculated by the following formula;

$$P_{d(dBm)} = Pg_{(dBm)} - cable loss_{(dB)} + antenna gain_{(dB)}$$

Where: P_{d} is the dipole equivalent power and P_{g} is the generator output power into the substitution antenna.

3. The maximum value is calculated by adding the forward power to the calibrated source plus its appropriate gain value.

These steps are repeated with the receiving antenna in both vertical and horizontal polarization, the difference

between the gain of the horn and an isotropic antenna are taken into consideration

- 4. The EUT was tested in three orthogonal planes(X, Y, Z) and in all possible test configurations and positioning.
- 5. All measurements are performed as RMS average measurements while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies.



3.3 RADIATED SPURIOUS EMISSIONS

Test Overview

Radiated tests are performed in the Fully-anechoic chamber.

Radiated Spurious Emission Measurements at 3 meters by Substitution Method according to ANSI/TIA-603-E-2016.

Test Settings

- 1. RBW = 100kHz for emissions below 1GHz and 1MHz for emissions above 1GHz
- 2. VBW ≥ 3 x RBW
- 3. Span = 1.5 times the OBW
- 4. No. of sweep points > 2 x span / RBW
- 5. Detector = Peak
- 6. Trace mode = Max Hold
- 7. The trace was allowed to stabilize
- 8. Test channel: Low/ Middle/ High
- 9. Frequency range: We are performed all frequency to 10th harmonics from 9 kHz.

Test Note

- Measurements value show only up to 3 maximum emissions noted, or would be lesser
 if no specific emissions from the EUT are recorded (ie: margin > 20 dB from the applicable limit)
 and considered that's already beyond the background noise floor.
- 2. The EUT was tested in three orthogonal planes(X, Y, Z) and in all possible test configurations and positioning.
 The worst case emissions are reported with the EUT positioning, modulations, RB sizes and offsets, and channel bandwidth configurations shown in the test data
- 3. For spurious emissions above 1GHz, a horn antenna is substituted in place of the EUT. The substitute antenna is driven by a signal generator and the previously recorded signal was duplicated.

The spurious emissions is calculated by the following formula;


Where: Pgis the generator output power into the substitution antenna.

If the fundamental frequency is below 1GHz, RF output power has been converted to EIRP.

$$EIRP_{(dBm)} = ERP_{(dBm)} + 2.15$$



3.4 OCCUPIED BANDWIDTH.



Test setup

The width of a frequency band such that, below the lower and above the upper frequency limits, the mean powers emitted are each equal to a specified percentage 0.5 % of the total mean power of a given emission.

The EUT makes a call to the communication simulator.


The conducted occupied bandwidth used the power splitter via EUT RF power connector between simulation base station and spectrum analyzer.

The communication simulator station system controlled a EUT to export maximum output power under transmission mode and specific channel frequency. Use OBW measurement function of Spectrum analyzer to measure 99 % occupied bandwidth

- The signal analyzer's automatic bandwidth measurement capability was used to perform the 99% occupied bandwidth and the 26dB bandwidth. The bandwidth measurement was not influenced by any intermediate power nulls in the fundamental emission.
- 2. RBW = 1 5% of the expected OBW
- 3. VBW ≥ 3 x RBW
- 4. Detector = Peak
- 5. Trace mode = max hold
- 6. Sweep = auto couple
- 7. The trace was allowed to stabilize
- 8. If necessary, steps 2 7 were repeated after changing the RBW such that it would be within
 - 1-5% of the 99% occupied bandwidth observed in Step 7



3.5 SPURIOUS AND HARMONIC EMISSIONS AT ANTENNA TERMINAL



Test setup

Test Overview

The level of the carrier and the various conducted spurious and harmonic frequencies is measured by means of a calibrated spectrum analyzer. The spectrum is scanned from the lowest frequency generated in the equipment up to a frequency including its 10th harmonic.


All out of band emissions are measured with a spectrum analyzer connected to the antenna terminal of the EUT while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies.

All data rates were investigated to determine the worst case configuration. All modes of operation were investigated and the worst case configuration results are reported in this section.

- 1. RBW = 1 MHz
- 2. VBW ≥ 3 MHz
- 3. Detector = RMS
- 4. Trace Mode = trace average
- 5. Sweep time = auto
- 6. Number of points in sweep $\ge 2 \text{ x Span}$ / RBW



3.6 BAND EDGE



Test setup

Test Overview

All out of band emissions are measured with a spectrum analyzer connected to the antenna terminal of the EUT while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies. All data rates were investigated to determine the worst case configuration. All modes of operation were investigated and the worst case configuration results are reported in this section.

- 1. Start and stop frequency were set such that the band edge would be placed in the center of the plot
- 2. Span was set large enough so as to capture all out of band emissions near the band edge
- 3. RBW > 1% of the emission bandwidth
- 4. VBW > 3 x RBW
- 5. Detector = RMS
- 6. Number of sweep points ≥ 2 x Span/RBW
- 7. Trace mode = trace average
- 8. Sweep time = auto couple
- 9. The trace was allowed to stabilize



Test Notes

§90.543(e)

- 1. On all frequencies between 769-775 MHz and 799-805 MHz, by a factor not less than 76 + 10 log (P) dB in a 6.25 kHz band segment, for base and fixed stations.
- 2. On all frequencies between 769-775 MHz and 799-805 MHz, by a factor not less than 65 + 10 log (P) dB in a 6.25 kHz band segment, for mobile and portable stations.
- 3. On any frequency between 775-788 MHz, above 805 MHz, and below 758 MHz, by at least 43 + 10 log (P) dB.
- 4. Compliance with the provisions of paragraphs (e)(1) and (2) of this section is based on the use of measurement instrumentation such that the reading taken with any resolution bandwidth setting should be adjusted to indicate spectral energy in a 6.25 kHz segment.
- 5. Compliance with the provisions of paragraph (e)(3) of this section is based on the use of measurement instrumentation employing a resolution bandwidth of 100 kHz or greater.
 - However, in the 100 kHz bands immediately outside and adjacent to the frequency block, a resolution bandwidth of 30 kHz may be employed.

Test Notes


According to FCC 22.917, 24.238, 27.53 specified that power of any emission outside of The authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least 43 + 10 log(P) dB. In the 1 MHz bands immediately outside and adjacent to the frequency block a resolution bandwidth of at least one percent of the emission bandwidth of the fundamental emission of the transmitter may be employed.

All measurements were done at 2 channels(low and high operational frequency range.)

The band edge measurement used the power splitter via EUT RF power connector between simulation base station and spectrum analyzer.



3.7 FREQUENCY STABILITY / VARIATION OF AMBIENT TEMPERATURE



Test setup

Test Overview

Frequency stability testing is performed in accordance with the guidelines of ANSI C63.26-2015.

The frequency stability of the transmitter is measured by:

1. Temperature:

The temperature is varied from -30°C to +50°C in 10°C increments using an environmental chamber.

- 2. Primary Supply Voltage:
 - .- Unless otherwise specified, vary primary supply voltage from 85% to 115% of the nominal value for other than hand carried battery equipment.
 - .- For hand carried, battery powered equipment, reduce the primary ac or dc supply voltage to the battery operating end point, which shall be specified by the manufacturer.

- The carrier frequency of the transmitter is measured at room temperature (20°C to provide a reference).
- 2. The equipment is turned on in a "standby" condition for fifteen minutes before applying power to the transmitter.

 Measurement of the carrier frequency of the transmitter is made within one minute after applying power to the transmitter.
- 3. Frequency measurements are made at 10°C intervals ranging from -30°C to +50°C. A period of at least one half-hour is provided to allow stabilization of the equipment at each temperature level.



3.8 WORST CASE(RADIATED TEST)

- The EUT was tested in three orthogonal planes(X, Y, Z) and in all possible test configurations and positioning.
- All modes of operation were investigated and the worst case configuration results are reported.
- The worst case is reported with the EUT positioning, modulations, RB sizes and offsets, and channel bandwidth configurations shown in the test data.

- 1) The EUT mounted on a non-conductive turntable is 2.5 meter above test site ground level.
- 2) During the test, the turn table is rotated until the maximum signal is found.
- 3) Record the field strength meter's level.
- 4) Replace the EUT with dipole/Horn antenna that is connected to a calibrated signal generator.
- 5) Increase the signal generator output till the field strength meter's level is equal to the item (3).
- 6) The signal generator output level with Ant. Gain and cable loss are the rating of effective radiated power.




BAND 14. Occupied Bandwidth Plot (Ch.23330 QPSK RB 25) 5 MHz






BAND 14. Occupied Bandwidth Plot (Ch.23330 16-QAM RB 25) 5 MHz






BAND 14. Occupied Bandwidth Plot (Ch.23330 64-QAM RB 25) 5 MHz






BAND 14. Occupied Bandwidth Plot (Ch.23330 QPSK RB 50) 10 MHz






BAND 14. Occupied Bandwidth Plot (Ch.23330 16-QAM RB 50) 10 MHz






BAND 14. Occupied Bandwidth Plot (Ch.23330 64-QAM RB 50) 10 MHz




BAND 14 Lower Band Edge Plot (5M BW Ch.23305 QPSK_RB1 OFFSET_0)






BAND 14 Lower Band Edge Plot (5M BW Ch.23305 QPSK_RB_25)






BAND 14 Lower Emission Mask (769 MHz ~ 775 MHz) Plot (5M BW Ch.23305 QPSK_RB1_0)-1












BAND 14 Lower Band Edge Plot (10M BW Ch.23330 QPSK_RB1 OFFSET_0)













BAND 14 Lower Emission Mask (769 MHz ~ 775 MHz) Plot (10M BW Ch.23330 QPSK_RB50_0)-1




BAND 14 Lower Emission Mask (769 MHz ~ 775 MHz) Plot (10M BW Ch.23330 QPSK_RB50_0)-2






BAND 14 Upper Emission Mask (799 MHz ~805 MHz) Plot (5M BW Ch.23355 QPSK_RB1_24)




BAND 14 Upper Emission Mask (793 MHz ~805 MHz) Plot (10M BW Ch.23330 QPSK_RB50_0)-2




