



# 4. Introduction

This report referenced from the FCC ID: A3LSMA346M

Based on their similarity, the FCC Part 15C (equipment class: DTS) reuse the original model's result and do spot-check, following the FCC KDB 484596 D01 v01.

And the applicant takes full responsibility that the test data as referenced in this report represent compliance for this FCC ID.

# 4.1 Difference

The FCC ID: A3LSMA346B shares the same enclosure and circuit board as FCC ID: A3LSMA346M. The WIFI/BT/BLE/NFC/WCDMA/GSM/LTE antenna and surrounding circuitry and layout are identical between these two units.

As for all bands, they have been verified and the parent model test results under FCC ID: A3LSMA346M shall remain representative of FCC ID: A3LSMA346B.

**Note.** The difference between the parent and variant is that the RF circuit for NR/LTE Bands (13/n5/n66), ULCA Band 4 and EN-DC for Band 2/66 in the parent model A3LSMA346M is removed from the variant model A3LSMA346B.

#### **Notes:**

- 2. According to exploratory test no any obvious emission were detected from 9 kHz to 30 MHz. Although these tests were performed other than open field site, adequate comparison measurements were confirmed against 30 m open field site. Therefore sufficient tests were made to demonstrate that the alternative site produces results that correlate with the ones of tests made in an open field based on KDB 414788.
- 3. The fundamental of the EUT was investigated in three orthogonal orientations X, Y and Z. It was determined that **X** orientation was worst-case orientation. Therefore, all final radiated testing was performed with the EUT in **X** orientation
- 4. The maximum production power and tolerance are not impacted by the change. So only spotcheck test was done against the worst case from the original model.
- 5. All the radiated tests have been performed several case. (Stand-alone, with accessories (DLC Cable etc.))






The diagram below shows the test setup that is utilized to make the measurements for emission from 9 kb to 30 kb Emissions

- 1. Analyzer center frequency was set to the frequency of the radiated spurious emission of interest
- 2. RBW = as specified in table
- 3. VBW  $\geq$  (3×RBW)

- 7. Allow sweeps to continue until the trace stabilizes

### Trace averaging with continuous EUT transmission at full power

If the EUT can be configured or modified to transmit continuously (D ≥ 98%), then the average emission levels shall be measured using the following method (with EUT transmitting continuously):

- RBW = 1 Mb (unless otherwise specified).
- VBW ≥ (3×RBW).
- Detector = RMS (power averaging), if [span / (# of points in sweep)] ≤ (RBW / 2). Satisfying this condition may require increasing the number of points in the sweep or reducing the span. If this condition cannot be satisfied, then the detector mode shall be set to peak.
- Averaging type = power (i.e., rms):
  - 1. As an alternative, the detector and averaging type may be set for linear voltage averaging.
  - 2. Some instruments require linear display mode to use linear voltage averaging. Log or  $\,\mathrm{d}B$  averaging shall not be used.
- Sweep time = auto.
- Perform a trace average of at least 100 traces.

# Trace averaging across ON and OFF times of the EUT transmissions followed by duty cycle correction

If continuous transmission of the EUT (D  $\geq$  98%) cannot be achieved and the duty cycle is constant (duty cycle variations are less than  $\pm 2\%$ ), then the following procedure shall be used:

- 1) The EUT shall be configured to operate at the maximum achievable duty cycle.
- 2) Measure the duty cycle D of the transmitter output signal as described in 11.6.
- 3) RBW = 1 Mb (unless otherwise specified).
