1.0 INTRODUCTION

1.1 Scope

2.0 PRODUCT INFORMATION

2.1 Equipment Description

The Equipment Under Test (EUT) is the **Samsung Portable Handset FCC ID: A3LSMF711B**. The test data contained in this report pertains only to the emissions due to the EUT's licensed transmitters that operate under the provisions of Part 22.

2.2 Device Capabilities

This device contains the following capabilities:

850/1900 GSM/GPRS/EDGE, 850/1700/1900 WCDMA/HSPA, Multi-band LTE, 5G NR (n5, n66), 802.11b/g/n/ax WLAN, 802.11a/n/ac/ax UNII (5GHz), Bluetooth (1x, EDR, LE), NFC, Wireless Power Transfer

2.3 Test Configuration

The EUT was tested per the guidance of ANSI/TIA-603-E-2016 and KDB 971168 D01 v03r01. See Section 0 of this test report for a description of the radiated and antenna port conducted emissions tests.

The Equipment Under Test (EUT) can operate in one of three physical configurations – "Open", "Half open" and "Closed". All emissions are investigated in three modes for compliance.

This device supports wireless charging capability and, thus, is subject to the test requirements of KDB 648474 D03 v01r04. Additional radiated spurious emission measurements were performed with the EUT lying flat on an authorized wireless charging pad (WCP) Model: EP-N5100 while operating under normal conditions in a simulated call or data transmission configuration. The worst case radiated emissions data is shown in this report.

No EMI suppression device(s) were added and no modifications were made during testing.

3.2 Radiated Power and Radiated Spurious Emissions

The radiated test facilities consisted of an indoor 3 meter semi-anechoic chamber used for final measurements and exploratory measurements, when necessary. The measurement area is contained within the semi-anechoic chamber which is shielded from any ambient interference. The test site inside the chamber is a 6m x 5.2m elliptical, obstruction-free area in accordance with Figure 5.7 of Clause 5 in ANSI C63.4-2014. Absorbers are arranged on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections for measurements above 1GHz. For measurements below 1GHz, the absorbers are removed. A raised turntable is used for radiated measurement. The turn table is a continuously rotatable, remote-controlled, metallic turntable and 2 meters (6.56 ft.) in diameter. The turn table is flush with the raised floor of the chamber in order to maintain its function as a ground plane. An 80cm tall test table made of Styrodur is placed on top of the turn table. A Styrodur pedestal is placed on top of the test table to bring the total table height to 1.5m.

The equipment under test was transmitting while connected to its integral antenna and is placed on a turntable 3 meters from the receive antenna. The receive antenna height is adjusted between 1 and 4 meter height, the turntable is rotated through 360 degrees, and the EUT is manipulated through all orthogonal planes representative of its typical use to achieve the highest reading on the receive spectrum analyzer.

For radiated power measurements, substitution method is used per the guidance of ANSI/TIA-603-E-2016. A half-wave dipole is substituted in place of the EUT. For emissions above 1GHz, a horn antenna is substituted in place of the EUT. The substitute antenna is driven by a signal generator with the level of the signal generator being adjusted to obtain the same receive spectrum analyzer level previously recorded from the spurious emission from the EUT. The power of the emission is calculated using the following formula:

 $P_{d \ [dBm]} = P_{g \ [dBm]} - cable \ loss \ _{[dB]} + antenna \ gain \ _{[dBd/dBi];}$ where P_d is the dipole equivalent power, P_g is the generator output into the substitution antenna, and the antenna gain is the gain of the substitute antenna used relative to either a half-wave dipole (dBd) or an isotropic source (dBi). The substitute level is equal to $P_{g \ [dBm]} - cable \ loss \ _{[dB]}$.

For radiated spurious emissions measurements and calculations, conversion method is used per the formulas in KDB 971168 Section 5.8.4. Field Strength (EIRP) is calculated using the following formulas:

All radiated measurements are performed in a chamber that meets the site requirements per ANSI C63.4-2014. Additionally, radiated emissions below 30MHz are also validated on an Open Area Test Site to assert correlation with the chamber measurements per the requirements of KDB 474788 D01.

Radiated power and radiated spurious emission levels are investigated with the receive antenna horizontally and vertically polarized per ANSI/TIA-603-E-2016.

Example: Spurious emission at 3700.40 MHz

The receive spectrum analyzer reading at 3 meters with the EUT on the turntable was -81.0 dBm. The gain of the substituted antenna is 8.1 dBi. The signal generator connected to the substituted antenna terminals is adjusted to produce a reading of -81.0 dBm on the spectrum analyzer. The loss of the cable between the signal generator and the terminals of the substituted antenna is 2.0 dB at 3700.40 MHz. So 6.1 dB is added to the signal generator reading of -30.9 dBm yielding -24.80 dBm. The fundamental EIRP was 25.50 dBm so this harmonic was 25.50 dBm - (-24.80) = 50.3 dBc.

- 1) All modes of operation and data rates were investigated. The test results shown in the following sections represent the worst case emissions.
- 2) The analyzer plots were all taken with a correction table loaded into the analyzer. The correction table was used to account for the losses of the cables, directional couplers, and attenuators used as part of the system to maintain a link between the call box and the EUT at all frequencies of interest.
- 3) All antenna port conducted emissions testing was performed on a test bench with the antenna port of the EUT connected to the spectrum analyzer through calibrated cables, attenuators, and couplers.
- 4) All conducted emissions measurements are performed with automated test software to capture the corresponding plots necessary to show compliance. The measurement software utilized is PCTEST EMC Software Tool Beta 8.

7.2 Occupied Bandwidth

Test Overview

The occupied bandwidth, that is the frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers radiated are each equal to 0.5 percent of the total mean power radiated by a given emission shall be measured. All modes of operation were investigated and the worst case configuration results are reported in this section.

Test Procedure Used

KDB 971168 D01 v03r01 - Section 4.2

Test Settings

- 1. The signal analyzer's automatic bandwidth measurement capability was used to perform the 99% occupied bandwidth and the 26dB bandwidth. The bandwidth measurement was not influenced by any intermediate power nulls in the fundamental emission.
- 2. RBW = 1 5% of the expected OBW
- 3. VBW \geq 3 x RBW
- 4. Detector = Peak
- 5. Trace mode = max hold




Plot 7-19. Occupied Bandwidth Plot (NR Band n5 - 10MHz 16-QAM - Full RB)

Plot 7-21. Occupied Bandwidth Plot (NR Band n5 - 5MHz QPSK - Full RB)




Plot 7-22. Occupied Bandwidth Plot (NR Band n5 - 5MHz 16-QAM - Full RB)



7.3 Spurious and Harmonic Emissions at Antenna Terminal

Test Overview

The level of the carrier and the various conducted spurious and harmonic frequencies is measured by means of a calibrated spectrum analyzer. 

Plot 7-26. Conducted Spurious Plot (LTE Band 26/5 - 10MHz QPSK - 1 RB - Low Channel)






Plot 7-28. Conducted Spurious Plot (LTE Band 26/5 - 10MHz QPSK - 1 RB - Low Channel)


Plot 7-30. Conducted Spurious Plot (LTE Band 26/5 - 10MHz QPSK - 1 RB - Mid Channel)








Plot 7-37. Conducted Spurious Plot (NR Band n5 - 20.0MHz - 1 RB)







Plot 7-40. Conducted Spurious Plot (GPRS Ch. 128)








Plot 7-42. Conducted Spurious Plot (GPRS Ch. 190)








Plot 7-49. Conducted Spurious Plot (WCDMA Ch. 4132)


Plot 7-51. Conducted Spurious Plot (WCDMA Ch. 4183)









Plot 7-58. Lower Band Edge Plot (LTE Band 26/5 - 10MHz QPSK - Full RB)





Plot 7-60. Lower Band Edge Plot (LTE Band 26/5 - 5MHz QPSK - Full RB)





Plot 7-72. Lower Band Edge Plot (NR Band n5 - 5.0MHz - Full RB)




Plot 7-73. Upper Band Edge Plot (NR Band n5 - 5.0MHz - Full RB)



7.5 Radiated Power (ERP)

Test Overview




Figure 7-4. Radiated Test Setup <1GHz




Figure 7-5. Test Instrument & Measurement Setup < 1GHz




Figure 7-6. Test Instrument & Measurement Setup >1 GHz



- 3) This device employs UMTS technology with WCDMA (AMR/RMC) and HSDPA capabilities. The EUT was tested under all configurations and the highest power is reported in WCDMA mode with HSDPA Inactive at 12.2 kbps RMC and TPC bits all set to "1".
- 4) The EUT was tested in three orthogonal planes and in all possible test configurations and positioning. The worst case emissions are reported with the EUT positioning, modulations, RB sizes and offsets, and channel bandwidth configurations shown in the tables below.
- 5) This unit was tested with its standard battery.
- 6) The EUT was tested in three orthogonal planes and in all possible test configurations and positioning. The worst case setup is reported in the tables below.
- 7) The spectrum is measured from 9kHz to the 10th harmonic of the fundamental frequency of the transmitter. The worst-case emissions are reported.
- 8) Emissions below 18GHz were measured at a 3 meter test distance while emissions above 18GHz were measured at a 1 meter test distance with the application of a distance correction factor.
- 9) The "-" shown in the following RSE tables are used to denote a noise floor measurement.
- 10) For NR operation, all subcarrier spacings (SCS) and transmission schemes (e.g. CP-OFDM and DFT-s-OFDM) were investigated to determine the worst case configuration. All modes of operation were investigated and the worst case configuration results are reported in this section.
- 11) Spurious emissions shown in this section are measured while operating in EN-DC mode with Sub 6GHz NR carrier as well as an LTE carrier (anchor). Spurious emissions from the NR carrier device, is subject to the rules under which the NR carrier operates. Spurious emission caused by the LTE carrier must meet the requirements of the rules under which the LTE carrier operates.











7.7 Frequency Stability / Temperature Variation

Test Overview and Limit

Frequency stability testing is performed in accordance with the guidelines of ANSI/TIA-603-E-2016. The frequency stability of the transmitter is measured by:

- a.) **Temperature:** The temperature is varied from -30°C to +50°C in 10°C increments using an environmental chamber.
- b.) **Primary Supply Voltage:** The primary supply voltage is varied from 85% to 115% of the nominal value for non hand-carried battery and AC powered equipment. For hand-carried, battery-powered equipment, primary supply voltage is reduced to the battery operating end point which shall be specified by the manufacturer.

For Part 22 and RSS-132, the frequency stability of the transmitter shall be maintained within $\pm 0.00025\%$ (± 2.5 ppm) of the center frequency.

Test Procedure Used

ANSI/TIA-603-E-2016

Test Settings

- 1. The carrier frequency of the transmitter is measured at room temperature (20°C to provide a reference).
- 2. The equipment is turned on in a "standby" condition for fifteen minutes before applying power to the transmitter. Measurement of the carrier frequency of the transmitter is made within one minute after applying power to the transmitter.
- 3. Frequency measurements are made at 10°C intervals ranging from -30°C to +50°C. A period of at least one half-hour is provided to allow stabilization of the equipment at each temperature level.

Test Setup

The EUT was connected via an RF cable to a spectrum analyzer with the EUT placed inside an environmental chamber.



Plot 7-84. LTE Band 26/5 Frequency Stability Chart



Plot 7-85. NR Band n5 Frequency Stability Chart



Plot 7-86. GSM/GPRS Cell Frequency Stability Chart


