




Plot 7-101. Average Conducted Power (2Mbps, iPA - Ch. 39) - ANT1


Plot 7-103. Average Conducted Power (3Mbps, ePA - Ch. 0) - ANT1




Plot 7-104. Average Conducted Power (3Mbps, ePA - Ch. 39) - ANT1

EUT operates in hopping and non-hopping transmission mode. Measurement is taken at the highest point located outside of the emission bandwidth. *The maximum permissible out-of-band emission level is* 20 dBc.

Test Procedure Used

ANSI C63.10-2013 - Section 6.10.4

Test Settings

- 1. Start and stop frequency were set such that the band edge would be placed in the center of the plot
- 2. Span was set large enough so as to capture all out of band emissions near the band edge
- 3. RBW = 100kHz
- 4. VBW = 300kHz
- 5. Detector = Peak
- 6. Number of sweep points ≥ 2 x Span/RBW
- 7. Trace mode = max hold
- 8. Sweep time = auto couple
- 9. The trace was allowed to stabilize




Plot 7-109. Band Edge Plot (Bluetooth with Hopping Disabled, ePA, 3 Mbps - Ch. 0) - ANTO


Plot 7-110. Band Edge Plot (Bluetooth with Hopping Disabled, ePA, 3 Mbps - Ch. 78) - ANTO




Plot 7-111. Band Edge Plot (Bluetooth with Hopping Enabled, ePA, 3 Mbps-Ch. 0) - ANTO


Plot 7-112. Band Edge Plot (Bluetooth with Hopping Enabled, ePA, 3 Mbps-Ch. 78) - ANTO




Plot 7-113. Band Edge Plot (Bluetooth with Hopping Disabled, iPA, 3 Mbps - Ch. 0) - ANTO


Plot 7-114. Band Edge Plot (Bluetooth with Hopping Disabled, iPA, 3 Mbps - Ch. 78) - ANTO




Plot 7-115. Band Edge Plot (Bluetooth with Hopping Enabled, iPA, 3 Mbps - Ch.0) - ANTO


Plot 7-116. Band Edge Plot (Bluetooth with Hopping Enabled, iPA, 3 Mbps - Ch.78) - ANTO

Plot 7-118. Band Edge Plot (Bluetooth with Hopping Disabled, ePA, 3 Mbps - Ch. 78) - ANT1




Plot 7-119. Band Edge Plot (Bluetooth with Hopping Enabled, ePA, 3 Mbps - Ch.0) - ANT1


Plot 7-120. Band Edge Plot (Bluetooth with Hopping Enabled, ePA, 3 Mbps - Ch.78) - ANT1




Plot 7-121. Band Edge Plot (Bluetooth with Hopping Disabled, iPA, 3 Mbps - Ch. 0) - ANT1

- 1. Span = Wide enough to capture peaks of two adjacent channels
- 2. RBW = 30% of channel spacing. Adjust as necessary to best identify center of each individual channel
- 3. VBW ≥ RBW
- 4. Sweep = Auto
- 5. Detector = Peak
- Trace mode = max hold
- 7. The trace was allowed to stabilize.
- 8. Marker-delta function used to determine separation between peaks of the adjacent channels



- 4. Trigger is set with appropriate trigger delay to place pulse near the center of the plot
- 5. Detector = peak
- 6. Trace mode = max hold
- 7. Marker-delta function used to determine transmit time per hop


Figure 7-5. Test Instrument & Measurement Setup






Figure 7-6. Test Instrument & Measurement Setup




Plot 7-133. Low End Spectrum Channel Hopping Plot (Bluetooth, ePA) – ANTO

Plot 7-135. Low End Spectrum Channel Hopping Plot (Bluetooth, iPA) – ANTO




Plot 7-136. High End Spectrum Channel Hopping Plot (Bluetooth, iPA) – ANTO


Plot 7-137. Low End Spectrum Channel Hopping Plot (Bluetooth, ePA) - ANT1




Plot 7-138. High End Spectrum Channel Hopping Plot (Bluetooth, ePA) – ANT1


Figure 7-7. Test Instrument & Measurement Setup




Plot 7-141. Conducted Spurious Plot (Bluetooth, 1Mbps - Ch. 0, ePA) - ANTO




Plot 7-142. Conducted Spurious Plot (Bluetooth, 1Mbps - Ch. 0, ePA) - ANTO


Plot 7-143. Conducted Spurious Plot (Bluetooth, 1Mbps - Ch. 39, ePA) - ANTO




Plot 7-144. Conducted Spurious Plot (Bluetooth, 1Mbps - Ch. 39, ePA) - ANTO

Plot 7-145. Conducted Spurious Plot (Bluetooth, 1Mbps – Ch. 78, ePA) – ANTO






Plot 7-147. Conducted Spurious Plot (Bluetooth, 1Mbps - Ch. 0, iPA) - ANTO


Plot 7-149. Conducted Spurious Plot (Bluetooth, 1Mbps - Ch. 39, iPA) - ANTO




Plot 7-150. Conducted Spurious Plot (Bluetooth, 1Mbps - Ch. 39, iPA) - ANTO



Plot 7-153. Conducted Spurious Plot (Bluetooth, 1Mbps - Ch. 0, ePA) - ANT1




Plot 7-154. Conducted Spurious Plot (Bluetooth, 1Mbps - Ch. 0, ePA) - ANT1




Plot 7-155. Conducted Spurious Plot (Bluetooth, 1Mbps - Ch. 39, ePA) - ANT1




Plot 7-156. Conducted Spurious Plot (Bluetooth, 1Mbps - Ch. 39, ePA) - ANT1


Plot 7-157. Conducted Spurious Plot (Bluetooth, 1Mbps - Ch. 78, ePA) - ANT1


Plot 7-159. Conducted Spurious Plot (Bluetooth, 1Mbps - Ch. 0, iPA) - ANT1




Plot 7-160. Conducted Spurious Plot (Bluetooth, 1Mbps - Ch. 0, iPA) - ANT1


Plot 7-161. Conducted Spurious Plot (Bluetooth, 1Mbps - Ch. 39, iPA) - ANT1








Figure 7-8. Radiated Test Setup >1GHz







Plot 7-165. Radiated Spurious Plot above 1GHz (BT- Ch. 0) - OPEN




Plot 7-166. Radiated Spurious Plot above 1GHz (BT- Ch. 39) - OPEN




Plot 7-167. Radiated Spurious Plot above 1GHz (BT- Ch. 78) - OPEN






Plot 7-168. Radiated Spurious Plot above 1GHz (BT- Ch. 0) - CLOSED




Plot 7-169. Radiated Spurious Plot above 1GHz (BT- Ch. 39) - CLOSED




Plot 7-170. Radiated Spurious Plot above 1GHz (BT- Ch. 78) - CLOSED








Plot 7-173. Radiated Restricted Upper Band Edge Measurement (Average) – ANT0



Plot 7-174. Radiated Restricted Upper Band Edge Measurement (Average) – ANT1




Plot 7-175. Radiated Restricted Upper Band Edge Measurement (Peak) – ANT0




Plot 7-176. Radiated Restricted Upper Band Edge Measurement (Peak) – ANT1







Plot 7-177. Radiated Restricted Upper Band Edge Measurement with WCP (Average) – ANT0




Figure 7-9. Radiated Test Setup < 1GHz









Figure 7-10. Test Instrument & Measurement Setup



Plot 7-183. Line-Conducted Test Plot (L1)




Plot 7-184. Line-Conducted Test Plot (N)


