



1.0 INTRODUCTION

1.1 Scope

Measurement and determination of electromagnetic emissions (EMC) of radio frequency devices including intentional and/or unintentional radiators for compliance with the technical rules and regulations of the Federal Communications Commission and the Innovation, Science and Economic Development Canada.

1.2 PCTEST Test Location

These measurement tests were conducted at the PCTEST Engineering Laboratory, Inc. facility located at 7185 Oakland Mills Road, Columbia, MD 21046. The measurement facility is compliant with the test site requirements specified in ANSI C63.4-2014.

1.3 Test Facility / Accreditations

Measurements were performed at PCTEST Engineering Lab located in Columbia, MD 21046, U.S.A.

2.3 Test Configuration

The EUT was tested per the guidance of KDB 558074 D01 v05r02. ANSI C63.10-2013 was used to reference the appropriate EUT setup for radiated spurious emissions testing. See Sections 7.7 and 7.8 for radiated emissions test setups, and 7.2, 7.3, 7.4, 7.5, and 7.6 for antenna port conducted emissions test setups.

This device supports wireless charging capability and, thus, is subject to the test requirements of KDB 648474 D03 v01r04. Additional radiated spurious emission measurements were performed with the EUT lying flat on an authorized wireless charging pad (WCP) Model: EP-N5100 while operating under normal conditions in a simulated call or data transmission configuration. The worst case radiated emissions data is shown in this report.

3.0 DESCRIPTION OF TESTS

3.1 Evaluation Procedure

The measurement procedures described in the American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices (ANSI C63.10-2013) and the guidance provided in KDB 558074 D01 v05r02 were used in the measurement of the EUT.

3.2 Radiated Emissions

The radiated test facilities consisted of an indoor 3 meter semi-anechoic chamber used for final measurements and exploratory measurements, when necessary. The measurement area is contained within the semi-anechoic chamber which is shielded from any ambient interference. The test site inside the chamber is a 6m x 5.2m elliptical, obstruction-free area in accordance with Figure 5.7 of Clause 5 in ANSI C63.4-2014. Absorbers are arranged on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections for measurements above 1GHz. An 80cm tall test table made of Styrodur is placed on top of the turn table. For measurements above 1GHz, an additional Styrodur pedestal is placed on top of the test table to bring the total table height to 1.5m.

For all measurements, the spectrum was scanned through all EUT azimuths and from 1 to 4 meter receive antenna height using a broadband antenna from 30MHz up to the upper frequency shown in 15.33 depending on the highest frequency generated or used in the device or on which the device operates or tunes. For frequencies above 1GHz, linearly polarized double ridge horn antennas were used. For frequencies below 30MHz, a calibrated loop antenna was used. When exploratory measurements were necessary, they were performed at 1 meter test distance inside the semi-anechoic chamber using broadband antennas, broadband amplifiers, and spectrum analyzers to determine the frequencies and modes producing the maximum emissions. Sufficient time for the EUT, support equipment, and test equipment was allowed in order for them to warm up to their normal operating condition. The test set-up was placed on top of the 1 x 1.5 meter table. The EUT, support equipment, and interconnecting cables were arranged and manipulated to maximize each emission. Appropriate precaution was taken to ensure that all emissions from the EUT were maximized and investigated. The system configuration, mode of operation, turntable azimuth, and receive antenna height was noted for each frequency found.

Final measurements were made in the semi-anechoic chamber using calibrated, linearly polarized broadband and horn antennas. The test setup was configured to the setup that produced the worst case emissions. The spectrum analyzer was set to investigate all frequencies required for testing to compare the highest radiated disturbances with respect to the specified limits. The turntable containing the EUT was rotated through 360 degrees and the height of the receive antenna was varied 1 to 4 meters and stopped at the azimuth and height producing the maximum emission. Each emission was maximized by changing the orientation of the EUT through three orthogonal planes and changing the polarity of the receive antenna, whichever produced the worst-case emissions.

All radiated measurements are performed in a chamber that meets the site requirements per ANSI C63.4-2014. Additionally, radiated emissions below 30MHz are also validated on an Open Area Test Site to assert correlation with the chamber measurements per the requirements of KDB 474788 D01.

3.3 Environmental Conditions

The temperature is controlled within range of 15°C to 35°C. The relative humidity is controlled within range of 10% to 75%. The atmospheric pressure is monitored within the range 86-106kPa (860-1060mbar).

4.0 ANTENNA REQUIREMENTS

Notes:

- 1) All modes of operation and data rates were investigated. The test results shown in the following sections represent the worst case emissions.
- 2) The analyzer plots shown in this section were all taken with a correction table loaded into the analyzer. The correction table was used to account for the losses of the cables and attenuators used as part of the system to connect the EUT to the analyzer at all frequencies of interest.
- 3) All antenna port conducted emissions testing was performed on a test bench with the antenna port of the EUT connected to the spectrum analyzer through calibrated cables and attenuators.
- 4) For conducted spurious emissions, automated test software was used to measure emissions and capture the corresponding plots necessary to show compliance. The measurement software utilized is PCTEST "WLAN Automation," Version 3.5.
- 5) For radiated band edge, automated test software was used to measure emissions and capture the corresponding plots necessary to show compliance. The measurement software utilized is PCTEST "Chamber Automation," Version 1.3.1.
- 6) 802.11ax OFDMA testing was performed for all signal tone configurations as specified by the 802.11ax standard. Worst case results are determined and reported per the guidance provided at the October 2018 TCB Workshop.

7.2 6dB Bandwidth Measurement

§15.247(a.2); RSS-247 [5.2]

Test Overview and Limit

The bandwidth at 6dB down from the highest in-band spectral density is measured with a spectrum analyzer connected to the transmitter antenna terminal of the EUT while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies. All data rates were investigated and the worst case configuration results are reported in this section.

The minimum permissible 6dB bandwidth is 500 kHz.

Test Procedure Used

ANSI C63.10-2013 – Section 11.8.2 Option 2
KDB 558074 D01 v05r02 – Section 8.2

Test Settings

1. The signal analyzer's automatic bandwidth measurement capability was used to perform the 6dB bandwidth measurement. The "X" dB bandwidth parameter was set to $X = 6$. The bandwidth measurement was not influenced by any intermediate power nulls in the fundamental emission.
2. RBW = 100kHz
3. VBW $\geq 3 \times$ RBW
4. Detector = Peak
5. Trace mode = max hold
6. Sweep = auto couple
7. The trace was allowed to stabilize








Plot 7-1. 6dB Bandwidth Plot SISO ANT1 (802.11ax OFDMA – 26 Tones – Ch. 1)




Plot 7-2. 6dB Bandwidth Plot SISO ANT1 (802.11ax OFDMA – 26 Tones – Ch. 6)




Plot 7-4. 6dB Bandwidth Plot SISO ANT1 (802.11ax OFDMA – 242 Tones – Ch. 1)


Plot 7-6. 6dB Bandwidth Plot SISO ANT1 (802.11ax OFDMA – 242 Tones – Ch. 11)






Plot 7-7. 6dB Bandwidth Plot SISO ANT2 (802.11ax OFDMA – 26 Tones – Ch. 1)




Plot 7-8. 6dB Bandwidth Plot SISO ANT2 (802.11ax OFDMA – 26 Tones – Ch. 6)




Plot 7-9. 6dB Bandwidth Plot SISO ANT2 (802.11ax OFDMA – 26 Tones – Ch. 11)




Plot 7-10. 6dB Bandwidth Plot SISO ANT2 (802.11ax OFDMA – 242 Tones – Ch. 1)

Test Overview and Limits

A transmitter antenna terminal of EUT is connected to the input of an RF power sensor. Measurement is made using a broadband power meter capable of making peak and average measurements while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies.

The maximum permissible conducted output power is 1 Watt.

Test Settings

Method PKPM1 (Peak Power Measurement)

Peak power measurements were performed only when the EUT was transmitting at its maximum power control level using a broadband power meter with a pulse sensor. The pulse sensor employs a VBW = 50MHz so this method was only used for signals whose DTS bandwidth was less than or equal to 50MHz.

Method AVGPM-G (Average Power Measurement)

Average power measurements were performed only when the EUT was transmitting at its maximum power control level using a broadband power meter with a pulse sensor. The power meter implemented triggering and gating capabilities which were set up such that power measurements were recorded only during the ON time of the transmitter. The trace was averaged over 100 traces to obtain the final measured average power.








Plot 7-13. Power Spectral Density Plot SISO ANT1 (802.11ax OFDMA – 26 Tones – Ch. 1)




Plot 7-14. Power Spectral Density Plot SISO ANT1 (802.11ax OFDMA – 26 Tones – Ch. 6)




Plot 7-15. Power Spectral Density Plot SISO ANT1 (802.11ax OFDMA – 26 Tones – Ch. 11)




Plot 7-16. Power Spectral Density Plot SISO ANT1 (802.11ax OFDMA – 242 Tones – Ch. 1)


Plot 7-18. Power Spectral Density Plot SISO ANT1 (802.11ax OFDMA – 242 Tones – Ch. 11)






Plot 7-19. Power Spectral Density Plot SISO ANT2 (802.11ax OFDMA – 26 Tones – Ch. 1)




Plot 7-20. Power Spectral Density Plot SISO ANT2 (802.11ax OFDMA – 26 Tones – Ch. 6)




Plot 7-21. Power Spectral Density Plot SISO ANT2 (802.11ax OFDMA – 26 Tones – Ch. 11)




Plot 7-22. Power Spectral Density Plot SISO ANT2 (802.11ax OFDMA – 242 Tones – Ch. 1)


Plot 7-24. Power Spectral Density Plot SISO ANT2 (802.11ax OFDMA – 242 Tones – Ch. 11)






Plot 7-25. Power Spectral Density Plot MIMO ANT1 (802.11ax OFDMA – 6 Tones – Ch. 1)




Plot 7-26. Power Spectral Density Plot MIMO ANT1 (802.11ax OFDMA – 26 Tones – Ch. 6)




Plot 7-27. Power Spectral Density Plot MIMO ANT1 (802.11ax OFDMA – 26 Tones – Ch. 11)




Plot 7-28. Power Spectral Density Plot MIMO ANT1 (802.11ax OFDMA – 242 Tones – Ch. 1)




Plot 7-29. Power Spectral Density Plot MIMO ANT1 (802.11ax OFDMA – 242 Tones – Ch. 6)




Plot 7-30. Power Spectral Density Plot MIMO ANT1 (802.11ax OFDMA – 242 Tones – Ch. 11)




Plot 7-31. Power Spectral Density Plot MIMO ANT2 (802.11ax OFDMA – 26 Tones – Ch. 1)




Plot 7-32. Power Spectral Density Plot MIMO ANT2 (802.11ax OFDMA – 26 Tones – Ch. 6)




Plot 7-33. Power Spectral Density Plot MIMO ANT2 (802.11ax OFDMA – 26 Tones – Ch. 11)




Plot 7-34. Power Spectral Density Plot MIMO ANT2 (802.11ax OFDMA – 242 Tones – Ch. 1)






Plot 7-39. Band Edge Plot SISO ANT1 (802.11ax OFDMA – 242 Tones – Ch. 1)



Plot 7-40. Band Edge Plot SISO ANT1 (802.11ax OFDMA – 242 Tones – Ch. 10)




Plot 7-41. Band Edge Plot SISO ANT1 (802.11ax OFDMA – 242 Tones – Ch. 11)

SISO Antenna-2 Conducted Emissions at the Band Edge




Plot 7-42. Band Edge Plot SISO ANT2 (802.11ax OFDMA – 106 Tones – Ch. 1)




Plot 7-43. Band Edge Plot SISO ANT2 (802.11ax OFDMA – 106 Tones – Ch. 11)




Plot 7-44. Band Edge Plot SISO ANT2 (802.11ax OFDMA – 242 Tones – Ch. 1)

For the following out of band conducted emissions plots, the EUT was set to a data rate of MCS0 in 802.11ax mode as this setting produced the worst-case emissions.

The limit for out-of-band spurious emissions at the band edge is 20dB below the fundamental emission level, as determined from the in-band power measurement of the DTS channel performed in a 100kHz bandwidth per the procedure in Section 11.1 of ANSI C63.10-2013 and KDB 558074 D01 v05r02.








Plot 7-47. Conducted Spurious Plot SISO ANT1 (802.11ax OFDMA – 26 Tones – Ch. 1)




Plot 7-48. Conducted Spurious Plot SISO ANT1 (802.11ax OFDMA – 26 Tones – Ch. 1)




Plot 7-49. Conducted Spurious Plot SISO ANT1 (802.11ax OFDMA – 26 Tones – Ch. 6)




Plot 7-50. Conducted Spurious Plot SISO ANT1 (802.11ax OFDMA – 26 Tones – Ch. 6)




Plot 7-51. Conducted Spurious Plot SISO ANT1 (802.11ax OFDMA – 26 Tones – Ch. 11)




Plot 7-52. Conducted Spurious Plot SISO ANT1 (802.11ax OFDMA – 26 Tones – Ch. 11)




Plot 7-53. Conducted Spurious Plot SISO ANT1 (802.11ax OFDMA – 242 Tones – Ch. 1)




Plot 7-54. Conducted Spurious Plot SISO ANT1 (802.11ax OFDMA – 242 Tones – Ch. 1)




Plot 7-55. Conducted Spurious Plot SISO ANT1 (802.11ax OFDMA – 242 Tones – Ch. 6)




Plot 7-56. Conducted Spurious Plot SISO ANT1 (802.11ax OFDMA – 242 Tones – Ch. 6)


Plot 7-57. Conducted Spurious Plot SISO ANT1 (802.11ax OFDMA – 242 Tones – Ch. 11)




Plot 7-58. Conducted Spurious Plot SISO ANT1 (802.11ax OFDMA – 242 Tones – Ch. 11)

SISO Antenna-2 Conducted Spurious Emissions




Plot 7-59. Conducted Spurious Plot SISO ANT2 (802.11ax OFDMA – 26 Tones – Ch. 1)




Plot 7-60. Conducted Spurious Plot SISO ANT2 (802.11ax OFDMA – 26 Tones – Ch. 1)




Plot 7-61. Conducted Spurious Plot SISO ANT2 (802.11ax OFDMA – 26 Tones – Ch. 6)




Plot 7-62. Conducted Spurious Plot SISO ANT2 (802.11ax OFDMA – 26 Tones – Ch. 6)




Plot 7-63. Conducted Spurious Plot SISO ANT2 (802.11ax OFDMA – 26 Tones – Ch. 11)




Plot 7-64. Conducted Spurious Plot SISO ANT2 (802.11ax OFDMA – 26 Tones – Ch. 11)




Plot 7-65. Conducted Spurious Plot SISO ANT2 (802.11ax OFDMA – 242 Tones – Ch. 1)




Plot 7-66. Conducted Spurious Plot SISO ANT2 (802.11ax OFDMA – 242 Tones – Ch. 1)




Plot 7-67. Conducted Spurious Plot SISO ANT2 (802.11ax OFDMA – 242 Tones – Ch. 6)




Plot 7-68. Conducted Spurious Plot SISO ANT2 (802.11ax OFDMA – 242 Tones – Ch. 6)




Figure 7-6. Test Instrument & Measurement Setup

Test Notes

1. The optional test procedures for antenna port conducted measurements of unwanted emissions per the guidance of KDB 558074 D01 v05r02 were not used to evaluate this device for compliance to radiated limits. All radiated spurious emissions levels were measured in a radiated test setup.
2. All emissions lying in restricted bands specified in Section 15.205 and Section 8.10 of RSS-Gen are below the limit shown in Table 7-19.
3. The antenna is manipulated through typical positions, polarity and length during the tests. The EUT is manipulated through three orthogonal planes.

9. Some band edge measurements were performed using a channel integration method to determine compliance with the out of band average radiated spurious emissions limit in the 2483.5 – 2500MHz band. Per KDB 558074 D01 v05r02 Section 13.3, a measurement was performed using a RBW of 100kHz at the frequency with highest emission outside of band edge. For integration that does not start at 2483.5MHz, consideration was taken to ensure the worst case emission is in the 1MHz spectrum. The results were integrated up to the 1MHz reference bandwidth to show compliance with the 15.209 radiated limit for emissions greater than 1GHz.
10. For radiated measurements, emissions were investigated for the fully-loaded RU configuration and for all the partially-loaded RU configurations. Among all of the available partially-loaded RU configurations, only the configuration with the worst case emissions is reported.







Plot 7-71. Radiated Spurious Plot above 1GHz SISO ANT1 (802.11ax OFDMA – 106 Tones – Ch. 1)




Plot 7-72. Radiated Spurious Plot above 1GHz SISO ANT1 (802.11ax OFDMA – 106 Tones – Ch. 6)




Plot 7-73. Radiated Spurious Plot above 1GHz SISO ANT1 (802.11ax OFDMA – 26T Tones – Ch. 11)



Plot 7-74. Radiated Spurious Plot above 1GHz SISO ANT1 (802.11ax OFDMA – 26T Tones – Ch. 1)




Plot 7-75. Radiated Spurious Plot above 1GHz SISO ANT1 (802.11ax OFDMA – 26T Tones – Ch. 6)




Plot 7-76. Radiated Spurious Plot above 1GHz SISO ANT1 (802.11ax OFDMA – 242 Tones – Ch. 11)







Plot 7-79. Radiated Spurious Plot above 1GHz SISO ANT2 (802.11ax OFDMA – 26 Tones – Ch. 1)




Plot 7-80. Radiated Spurious Plot above 1GHz SISO ANT2 (802.11ax OFDMA – 26 Tones – Ch. 6)




Plot 7-81. Radiated Spurious Plot above 1GHz SISO ANT2 (802.11ax OFDMA – 26 Tones – Ch. 11)



Plot 7-83. Radiated Spurious Plot above 1GHz SISO ANT2 (802.11ax OFDMA – 242 Tones – Ch. 6)




Plot 7-84. Radiated Spurious Plot above 1GHz SISO ANT2 (802.11ax OFDMA – 242 Tones – Ch. 11)









Plot 7-87. Radiated Spurious Plot above 1GHz MIMO (802.11ax OFDMA – 106 Tones – Ch. 1)




Plot 7-88. Radiated Spurious Plot above 1GHz MIMO (802.11ax OFDMA – 106 Tones – Ch. 6)




Plot 7-89. Radiated Spurious Plot above 1GHz MIMO (802.11ax OFDMA – 106 Tones – Ch. 11)



Plot 7-90. Radiated Spurious Plot above 1GHz MIMO (802.11ax OFDMA – 242 Tones – Ch. 1)




Plot 7-91. Radiated Spurious Plot above 1GHz MIMO (802.11ax OFDMA – 242 Tones – Ch. 6)




Plot 7-92. Radiated Spurious Plot above 1GHz MIMO (802.11ax OFDMA – 242 Tones – Ch. 11)








Plot 7-95. Radiated Restricted Lower Band Edge Measurement SISO ANT1 (Average – 106 Tones)




Plot 7-96. Radiated Restricted Lower Band Edge Measurement SISO ANT1 (Peak – 106 Tones)

Plot 7-97. Radiated Restricted Upper Band Edge Measurement SISO ANT1 (Average – 106 Tones)




Plot 7-98. Radiated Restricted Upper Band Edge Measurement SISO ANT1 (Peak – 106 Tones)






Plot 7-99. Radiated Restricted Lower Band Edge Measurement SISO ANT1 (Average – 242 Tones)




Plot 7-100. Radiated Restricted Lower Band Edge Measurement SISO ANT1 (Peak – 242 Tones)

Plot 7-101. Radiated Restricted Upper Band Edge Measurement SISO ANT1 (Average – 242 Tones)




Plot 7-102. Radiated Restricted Upper Band Edge Measurement SISO ANT1 (Peak – 242 Tones)










Plot 7-105. Radiated Restricted Lower Band Edge Measurement SISO ANT2 (Average – 106 Tones)




Plot 7-106. Radiated Restricted Lower Band Edge Measurement SISO ANT2 (Peak – 106 Tones)


Plot 7-107. Radiated Restricted Upper Band Edge Measurement SISO ANT2 (Average – 106 Tones)




Plot 7-108. Radiated Restricted Upper Band Edge Measurement SISO ANT2 (Peak – 106 Tones)




Plot 7-109. Radiated Restricted Lower Band Edge Measurement SISO ANT2 (Average – 242 Tones)




Plot 7-110. Radiated Restricted Lower Band Edge Measurement SISO ANT2 (Peak – 242 Tones)

Plot 7-111. Radiated Restricted Upper Band Edge Measurement SISO ANT2 (Average – 242 Tones)




Plot 7-112. Radiated Restricted Upper Band Edge Measurement SISO ANT2 (Peak – 242 Tones)



Plot 7-114. Radiated Restricted Upper Band Edge Measurement SISO ANT2 (Peak – 242 Tones)








Plot 7-115. Radiated Restricted Lower Band Edge Measurement MIMO (Average – 106 Tones)




Plot 7-116. Radiated Restricted Lower Band Edge Measurement MIMO (Peak – 106 Tones)


Plot 7-117. Radiated Restricted Upper Band Edge Measurement MIMO (Average – 106 Tones)




Plot 7-118. Radiated Restricted Upper Band Edge Measurement MIMO (Peak – 106 Tones)




Plot 7-119. Radiated Restricted Lower Band Edge Measurement MIMO (Average – 242 Tones)




Plot 7-120. Radiated Restricted Lower Band Edge Measurement MIMO (Peak – 242 Tones)

Plot 7-122. Radiated Restricted Upper Band Edge Measurement MIMO (Peak – 242 Tones)






Figure 7-7. Radiated Test Setup < 30Mhz




Figure 7-8. Radiated Test Setup < 1GHz



Test Notes


1. All emissions lying in restricted bands specified in §15.205 and RSS-Gen(8.10) are below the limit shown in Table 7-38.
2. The broadband receive antenna is manipulated through vertical and horizontal polarizations during the tests. The EUT is manipulated through three orthogonal planes.
3. This unit was tested with its standard battery.
4. The spectrum is investigated using a peak detector and final measurements are recorded using CISPR quasi peak detector. The worst-case emissions are reported however emissions whose levels were not within 20dB of the respective limits were not reported.
5. Emissions were measured at a 3 meter test distance.
6. Emissions are investigated while operating on the center channel of the mode, band, and modulation that produced the worst case results during the transmitter spurious emissions testing.
7. No spurious emissions were detected within 20dB of the limit below 30MHz.
8. The results recorded using the broadband antenna is known to correlate with the results obtained by using a tuned dipole with an acceptable degree of accuracy. The VSWR for the measurement antenna was found to be less than 2:1.
9. The wide spectrum spurious emissions plots shown on the following pages are used only for the purpose of emission identification. There were no emissions detected in the 30MHz – 1GHz frequency range, as shown in the subsequent plots.
