### 1.2 Time-Averaging Algorithm for RF Exposure Compliance

This Device is enabled with the Qualcomm® Smart Transmit feature. This feature performs time averaging algorithm in real time to control and manage transmitting power and ensure the time-averaged RF exposure is in compliance with FCC requirements all the time. Refer to Compliance Summary document for detailed description of Qualcomm® Smart Transmit feature (report SN could be found in Section 1.11 – Bibliography).

Note that WLAN operations are not enabled with Smart Transmit.

The Smart Transmit algorithm maintains the time-averaged transmit power, in turn, time-averaged RF exposure of SAR design target, below the predefined time-averaged power limit (i.e., Plimit for sub-6 radio), for each characterized technology and band (see RF Exposure Part 0 Test Report, report SN could be found in Section 1.11 - Bibliography).

Smart Transmit allows the device to transmit at higher power instantaneously, as high as  $P_{max}$ , when needed, but enforces power limiting to maintain time-averaged transmit power to  $P_{limit}$ . Below table shows  $P_{limit}$  EFS settings and maximum tune up output power  $P_{max}$  configured for this EUT for various transmit conditions (Device State Index DSI). Note that the device uncertainty for sub-6GHz WWAN is 1.0dB for this EUT.

The purpose of this report (Part 1 test) is to demonstrate that the EUT meets FCC SAR limits when transmitting in static transmission scenario at maximum allowable time-averaged power levels.

Measurement Condition: All conducted power and SAR measurements in this report (Part 1 test) were performed by setting Reserve power margin (Smart Transmit EFS entry) to 0dB.

#### 1.3 Power Reduction for SAR

This device used an independent fixed level power reduction mechanism for WLAN when 5G NR is active and also for WLAN/BT during all voice or VoIP held to ear scenarios. Per FCC Guidance, the held-to-ear exposure conditions were evaluated at reduced power according to the head SAR positions described in IEEE 1528-2013. Detailed descriptions of the power reduction mechanism are included in the operational description.

### 1.4.2 WLAN and Bluetooth Maximum and Reduced Output Powers

Only operations relevant to this permissive change were evaluated for compliance. No other target changes have been made. Targets for all other bands/exposure conditions can be found in the original filing.

### 1.5 DUT Antenna Locations

The overall dimensions of this device are > 9 x 5 cm. A diagram showing the location of the device antennas can be found in Appendix E. Since the diagonal dimension of this device is > 160 mm and <200 mm, it is considered a "phablet."

Note: Particular DUT edges were not required to be evaluated for wireless router SAR or phablet SAR if the edges were greater than 2.5 cm from the transmitting antenna according to FCC KDB Publication 941225 D06v02r01 Section III and FCC KDB Publication 648474 D04v01r03. The distances between the transmit antennas and the edges of the device are included in the filing. When wireless router mode is enabled, U-NII-1, U-NII-2A, U-NII-2C, and WIFI6E operations are disabled.

### 1.6 Near Field Communications (NFC) Antenna

This DUT has NFC operations. The NFC antenna is integrated into the device for this model. Therefore, all SAR tests were performed with the device which already incorporates the NFC antenna. A diagram showing the location of the NFC antenna can be found in Appendix E.

### 1.7 Simultaneous Transmission Capabilities

According to FCC KDB Publication 447498 D01v06, transmitters are considered to be operating simultaneously when there is overlapping transmission, with the exception of transmissions during network hand-offs with maximum hand-off duration less than 30 seconds.

This device contains multiple transmitters that may operate simultaneously, and therefore requires a simultaneous transmission analysis according to FCC KDB Publication 447498 D01v06 4.3.2 procedures.

Per FCC KDB Publication 648474 D04v01r03, this device is considered a "phablet" since the diagonal dimension is greater than 160mm and less than 200mm. Therefore, phablet SAR tests are required when wireless router mode does not apply or if wireless router 1g SAR > 1.2 W/kg.

This device supports NR capabilities with overlapping transmission frequency ranges. When the supported frequency range of an NR Band falls completely within an NR band with a larger transmission frequency range, both NR bands have the same target power (or the band with the larger transmission frequency range has a higher target power), and both NR bands share the same transmission path and signal characteristics, SAR was only assessed for the band with the larger transmission frequency range.

NR implementation supports SA and NSA mode. In EN-DC mode, NR operates with the LTE Bands shown in the NR FR1 checklist acting as anchor bands. Per FCC guidance, SAR tests for NR Bands and LTE Anchors Bands were performed separately due to limitations in SAR probe calibration factors

The FCC and Innovation, Science, and Economic Development Canada have adopted the guidelines for evaluating the environmental effects of radio frequency (RF) radiation in ET Docket 93-62 on Aug. 6, 1996 and Health Canada Safety Code 6 to protect the public and workers from the potential hazards of RF emissions due to FCC-regulated portable devices. [1]

The safety limits used for the environmental evaluation measurements are based on the criteria published by the American National Standards Institute (ANSI) for localized specific absorption rate (SAR) in IEEE/ANSI C95.1-1992 Standard for Safety Levels with Respect to Human Exposure to Radio Frequency Electromagnetic Fields, 3 kHz to 300 GHz [3] and Health Canada RF Exposure Guidelines Safety Code 6 [22]. The measurement procedure described in IEEE/ANSI C95.3-2002 Recommended Practice for the Measurement of Potentially Hazardous Electromagnetic Fields - RF and Microwave [4] is used for guidance in measuring the Specific Absorption Rate (SAR) due to the RF radiation exposure from the Equipment Under Test (EUT). These criteria for SAR evaluation are similar to those recommended by the International Committee for Non-Ionizing Radiation Protection (ICNIRP) in Biological Effects and Exposure Criteria for Radiofrequency Electromagnetic Fields," Report No. Vol 74. SAR is a measure of the rate of energy absorption due to exposure to an RF transmitting source. SAR values have been related to threshold levels for potential biological hazards.

#### 3.1 SAR Definition

Specific Absorption Rate is defined as the time derivative (rate) of the incremental energy (dU) absorbed by (dissipated in) an incremental mass (dm) contained in a volume element (dV) of a given density ( $\rho$ ). It is also defined as the rate of RF energy absorption per unit mass at a point in an absorbing body (see Equation 3-1).

Equation 3-1 SAR Mathematical Equation

$$SAR = \frac{d}{dt} \left( \frac{dU}{dm} \right) = \frac{d}{dt} \left( \frac{dU}{\rho dv} \right)$$

SAR is expressed in units of Watts per Kilogram (W/kg).

$$SAR = \frac{\sigma \cdot E^2}{\rho}$$

where:

 $\sigma$  = conductivity of the tissue-simulating material (S/m)  $\rho$  = mass density of the tissue-simulating material (kg/m<sup>3</sup>)

E = Total RMS electric field strength (V/m)

NOTE: The primary factors that control rate of energy absorption were found to be the wavelength of the incident field in relation to the dimensions and geometry of the irradiated organism, the orientation of the organism in relation to the polarity of field vectors, the presence of reflecting surfaces, and whether conductive contact is made by the organism with a ground plane.[6]

### 4 DOSIMETRIC ASSESSMENT

#### 4.1 Measurement Procedure

The evaluation was performed using the following procedure compliant to FCC KDB Publication 865664 D01v01r04 and IEEE 1528-2013:

- 1. The SAR distribution at the exposed side of the head or body was measured at a distance no greater than 5.0 mm from the inner surface of the shell. The area covered the entire dimension of the device-head and body interface and the horizontal grid resolution was determined per FCC KDB Publication 865664 D01v01r04 (See Table 4-1) and IEEE 1528-2013.
- 2. The point SAR measurement was taken at the maximum SAR region determined from Step 1 to enable the monitoring of SAR fluctuations/drifts during the 1g/10g cube evaluation. SAR at this fixed point was measured and used as a reference value.




Figure 4-1 Sample SAR Area Scan

- 3. Based on the area scan data, the peak of the region with maximum SAR was determined by spline interpolation. Around this point, a volume was assessed according to the measurement resolution and volume size requirements of FCC KDB Publication 865664 D01v01r04 (See Table 4-1) and IEEE 1528-2013. On the basis of this data set, the spatial peak SAR value was evaluated with the following procedure (see references or the DASY manual online for more details):
  - a. SAR values at the inner surface of the phantom are extrapolated from the measured values along the line away from the surface with spacing no greater than that in Table 4-1. The extrapolation was based on a least-squares algorithm. A polynomial of the fourth order was calculated through the points in the z-axis (normal to the phantom shell).
  - b. After the maximum interpolated values were calculated between the points in the cube, the SAR was averaged over the spatial volume (1g or 10g) using a 3D-Spline interpolation algorithm. The 3D-spline is composed of three one-dimensional splines with the "Not a knot" condition (in x, y, and z directions). The volume was then integrated with the trapezoidal algorithm. One thousand points (10 x 10 x 10) were obtained through interpolation, in order to calculate the averaged SAR.
  - c. All neighboring volumes were evaluated until no neighboring volume with a higher average value was found
- 4. The SAR reference value, at the same location as step 2, was re-measured after the zoom scan was complete to calculate the SAR drift. If the drift deviated by more than 5%, the SAR test and drift measurements were repeated.

#### 5.1 EAR REFERENCE POINT




Figure 5-1 Close-Up Side view of ERP

Figure 5-2 shows the front, back and side views of the SAM Twin Phantom. The point "M" is the reference point for the center of the mouth, "LE" is the left ear reference point (ERP), and "RE" is the right ERP. The ERP is 15mm posterior to the entrance to the ear canal (EEC) along the B-M line (Back-Mouth), as shown in Figure 5-1. The plane passing through the two ear canals and M is defined as the Reference Plane. The line N-F (Neck-Front), also called the Reference Pivoting Line, is not perpendicular to the reference plane (see Figure 5-1). Line B-M is perpendicular to the N-F line. Both N-F and B-M lines are marked on the external phantom shell to facilitate handset positioning [5].

### 5.2 HANDSET REFERENCE POINTS

Two imaginary lines on the handset were established: the vertical centerline and the horizontal line. The test device was placed in a normal operating position with the acoustic output located along the "vertical centerline" on the front of the device aligned to the "ear reference point" (See Figure 5-3). The acoustic output was than located at the same level as the center of the ear reference point. The test device was positioned so that the "vertical centerline" was bisecting the front surface of the handset at its top and bottom edges, positioning the "ear reference point" on the outer surface of the both the left and right head phantoms on the ear reference point.



### TEST CONFIGURATION POSITIONS

#### 6.1 **Device Holder**

The device holder is made out of low-loss POM material having the following dielectric parameters: relative permittivity  $\varepsilon = 3$  and loss tangent  $\delta = 0.02$ .

#### 6.2 **Positioning for Cheek**

1. The test device was positioned with the device close to the surface of the phantom such that point A is on the (virtual) extension of the line passing through points RE and LE on the phantom (see Figure 6-1), such that the plane defined by the vertical center line and the horizontal line of the phone is approximately parallel to the sagittal plane of the phantom.

- 2. The handset was translated towards the phantom along the line passing through RE & LE until the handset touches the pinna.
- 3. While maintaining the handset in this plane, the handset was rotated around the LE-RE line until the vertical centerline was in the reference plane.
- The phone was then rotated around the vertical centerline until the phone (horizontal line) was 4. symmetrical was respect to the line NF.
- 5. While maintaining the vertical centerline in the reference plane, keeping point A on the line passing through RE and LE, and maintaining the device contact with the ear, the device was rotated about the NF line until any point on the handset made contact with a phantom point below the ear (cheek) (See Figure 6-2).

#### 6.3 Positioning for Ear / 15° Tilt

With the test device aligned in the "Cheek Position":

- 1. While maintaining the orientation of the phone, the phone was retracted parallel to the reference plane far enough to enable a rotation of the phone by 15degrees.
- 2. The phone was then rotated around the horizontal line by 15 degrees.
- While maintaining the orientation of the phone, the phone was moved parallel to the reference plane until any part of the handset touched the head. (In this position, point A was located on the line RE-LE). The tilted position is obtained when the contact is on the pinna. If the contact was at any location other than the pinna, the angle of the phone would then be reduced. In this situation, the tilted position was obtained when any part of the phone was in contact of the ear as well as a second part of the phone was in contact with the head (see Figure 6-2).



### 6.4 SAR Evaluations near the Mouth/Jaw Regions of the SAM Phantom

Antennas located near the bottom of a phone may require SAR measurements around the mouth and jaw regions of the SAM head phantom. This typically applies to clam-shell style phones that are generally longer in the unfolded normal use positions or to certain older style long rectangular phones. Per IEEE 1528-2013, a rotated SAM phantom is necessary to allow probe access to such regions. Both SAM heads of the TwinSAM-Chin20 are rotated 20 degrees around the NF line. Each head can be removed from the table for emptying and cleaning.

Under these circumstances, the following procedures apply, adopted from the FCC guidance on SAR handsets document FCC KDB Publication 648474 D04v01r03. The SAR required in these regions of SAM should be measured using a flat phantom. The phone should be positioned with a separation distance of 4 mm between the ear reference point (ERP) and the outer surface of the flat phantom shell. While maintaining this distance at the ERP location, the low (bottom) edge of the phone should be lowered from the phantom to establish the same separation distance between the peak SAR location identified by the truncated partial SAR distribution measured with the SAM phantom. The distance from the peak SAR location to the phone is determined by the straight line passing perpendicularly through the phantom surface. When it is not feasible to maintain 4 mm separation at the ERP while also establishing the required separation at the peak SAR location, the top edge of the phone will be allowed to touch the phantom with a separation < 4 mm at the ERP. The phone should not be tilted to the left or right while placed in this inclined position to the flat phantom.

### 6.5 Body-Worn Accessory Configurations

Body-worn operating configurations are tested with the belt-clips and holsters attached to the device and positioned against a flat phantom in a normal use configuration (see Figure 6-4). Per FCC KDB Publication 648474 D04v01r03, Body-worn accessory exposure is typically related to voice mode operations when handsets are carried in body-worn accessories. The body-worn accessory procedures in FCC KDB Publication 447498 D01v06 should be used to test for body-worn accessory SAR compliance, without a headset connected to it. This enables the test results for such configuration to be compatible with that required for hotspot mode when the body-worn accessory test separation



distance is greater than or equal to that required for hotspot mode, when applicable. When the reported SAR for a body-worn accessory, measured without a headset connected to the handset, is > 1.2 W/kg, the highest reported SAR configuration for that wireless mode and frequency band should be repeated for that body-worn accessory with a headset attached to the handset.

Accessories for Body-worn operation configurations are divided into two categories: those that do not contain metallic components and those that do contain metallic components. When multiple accessories that do not

contain metallic components are supplied with the device, the device is tested with only the accessory that dictates the closest spacing to the body. Then multiple accessories that contain metallic components are tested with the device with each accessory. If multiple accessories share an identical metallic component (i.e. the same metallic belt-clip used with different holsters with no other metallic components) only the accessory that dictates the closest spacing to the body is tested.

Body-worn accessories may not always be supplied or available as options for some devices intended to be authorized for body-worn use. In this case, a test configuration with a separation distance between the back of the device and the flat phantom is used. Test position spacing was documented.

Transmitters that are designed to operate in front of a person's face, as in push-to-talk configurations, are tested for SAR compliance with the front of the device positioned to face the flat phantom in head fluid. For devices that are carried next to the body such as a shoulder, waist or chest-worn transmitters, SAR compliance is tested with the accessories, including headsets and microphones, attached to the device and positioned against a flat phantom in a normal use configuration.

### 6.6 Extremity Exposure Configurations

Devices that are designed or intended for use on extremities or mainly operated in extremity only exposure conditions; i.e., hands, wrists, feet and ankles, may require extremity SAR evaluation. When the device also operates in close proximity to the user's body, SAR compliance for the body is also required. The 1g body and 10g extremity SAR Exclusion Thresholds found in KDB Publication 447498 D01v06 should be applied to determine SAR test requirements.

Per KDB Publication 447498 D01v06, Cell phones (handsets) are not normally designed to be used on extremities or operated in extremity only exposure conditions. The maximum output power levels of handsets generally do not require extremity SAR testing to show compliance. Therefore, extremity SAR was not evaluated for this device.

### 6.7 Wireless Router Configurations

Some battery-operated handsets have the capability to transmit and receive user data through simultaneous transmission of WIFI simultaneously with a separate licensed transmitter. The FCC has provided guidance in FCC KDB Publication 941225 D06v02r01 where SAR test considerations for handsets (L x W  $\geq$  9 cm x 5 cm) are based on a composite test separation distance of 10 mm from the front, back and edges of the device containing transmitting antennas within 2.5 cm of their edges, determined from general mixed use conditions for this type of devices. Since the hotspot SAR results may overlap with the body-worn accessory SAR requirements, the more conservative configurations can be considered, thus excluding some body-worn accessory SAR tests.

When the user enables the personal wireless router functions for the handset, actual operations include simultaneous transmission of both the WIFI transmitter and another licensed transmitter. Both transmitters often do not transmit at the same transmitting frequency and thus cannot be evaluated for SAR under actual use conditions due to the limitations of the SAR assessment probes. Therefore, SAR must be evaluated for each frequency transmission and mode separately and spatially summed with the WIFI transmitter according to FCC KDB Publication 447498 D01v06 procedures. The "Portable Hotspot" feature on the handset was NOT activated during SAR assessments, to ensure the SAR measurements were evaluated for a single transmission frequency RF signal at a time.

### 6.8 Phablet Configurations

For smart phones with a display diagonal dimension > 150 mm or an overall diagonal dimension > 160 mm that provide similar mobile web access and multimedia support found in mini-tablets or UMPC mini-tablets that

support voice calls next to the ear, the phablets procedures outlined in KDB Publication 648474 D04v01r03 should be applied to evaluate SAR compliance. A device marketed as phablets, regardless of form factors and operating characteristics must be tested as a phablet to determine SAR compliance. In addition to the normally required head and body-worn accessory SAR test procedures required for handsets, the UMPC mini-tablet procedures must also be applied to test the SAR of all surfaces and edges with an antenna <=25 mm from that surface or edge, in direct contact with the phantom, for 10g SAR. The UMPC mini-tablet 1g SAR at 5 mm is not required. When hotspot mode applies, 10g SAR is required only for the surfaces and edges with hotspot mode 1g SAR > 1.2 W/kg.

### 6.9 Proximity Sensor Considerations

This device uses a power reduction mechanism to reduce output powers in certain use conditions when the device is used close the user's body.

When the device's antenna is within a certain distance of the user, the sensor activates and reduces the maximum allowed output power. However, the sensor is not active when the device is moved beyond the sensor triggering distance and the maximum output power is no longer limited. Therefore, additional evaluation is needed in the vicinity of the triggering distance to ensure SAR is compliant when the device is allowed to operate at a non-reduced output power level. FCC KDB Publication 616217 D04v01r02 Section 6 was used as a guideline for selecting SAR test distances for this device at these additional test positions.

The sensor is designed to support sufficient detection range and sensitivity to cover regions of the sensors in all applicable directions since the sensor entirely covers the antennas.

### 7 RF EXPOSURE LIMITS

#### 7.1 Uncontrolled Environment

UNCONTROLLED ENVIRONMENTS are defined as locations where there is the exposure of individuals who have no knowledge or control of their exposure. The general population/uncontrolled exposure limits are applicable to situations in which the general public may be exposed or in which persons who are exposed as a consequence of their employment may not be made fully aware of the potential for exposure or cannot exercise control over their exposure. Members of the general public would come under this category when exposure is not employment-related; for example, in the case of a wireless transmitter that exposes persons in its vicinity.

### 7.2 Controlled Environment

CONTROLLED ENVIRONMENTS are defined as locations where there is exposure that may be incurred by persons who are aware of the potential for exposure, (i.e. as a result of employment or occupation). In general, occupational/controlled exposure limits are applicable to situations in which persons are exposed as a consequence of their employment, who have been made fully aware of the potential for exposure and can exercise control over their exposure. This exposure category is also applicable when the exposure is of a transient nature due to incidental passage through a location where the exposure levels may be higher than the general population/uncontrolled limits, but the exposed person is fully aware of the potential for exposure and can exercise control over his or her exposure by leaving the area or by some other appropriate means.

# 8 FCC MEASUREMENT PROCEDURES

### 8.1 Measured and Reported SAR

Per FCC KDB Publication 447498 D01v06, when SAR is not measured at the maximum power level allowed for production units, the results must be scaled to the maximum tune-up tolerance limit according to the power applied to the individual channels tested to determine compliance. For simultaneous transmission, the measured aggregate SAR must be scaled according to the sum of the differences between the maximum tune-up tolerance and actual power used to test each transmitter. When SAR is measured at or scaled to the maximum tune-up tolerance limit, the results are referred to as *reported* SAR. The highest *reported* SAR results are identified on the grant of equipment authorization according to procedures in KDB 690783 D01v01r03.




Figure 9-1 **Power Measurement Setup**




Figure 10-1 System Verification Setup Diagram

### 11.5 SAR Test Notes

#### General Notes:

- 1. The test data reported are the worst-case SAR values according to test procedures specified in IEEE 1528-2013, and FCC KDB Publication 447498 D01v06.
- 2. Batteries are fully charged at the beginning of the SAR measurements.
- 3. Liquid tissue depth was at least 15.0 cm for all frequencies.
- 4. The manufacturer has confirmed that the device(s) tested have the same physical, mechanical and thermal characteristics and are within operational tolerances expected for production units.
- 5. SAR results were scaled to the maximum allowed power to demonstrate compliance per FCC KDB Publication 447498 D01v06.
- 6. Device was tested using a fixed spacing for body-worn accessory testing. A separation distance of 15 mm was considered because the manufacturer has determined that there will be body-worn accessories available in the marketplace for users to support this separation distance.
- 7. Per FCC KDB Publication 648474 D04v01r03, body-worn SAR was evaluated without a headset connected to the device. Since the standalone reported body-worn SAR was ≤ 1.2 W/kg, no additional body-worn SAR evaluations using a headset cable were required.
- 8. Per FCC KDB Publication 865664 D01v01r04, variability SAR tests were not required since measured SAR results for all frequency bands were less than 0.8 W/kg.
- 9. During SAR Testing for the Wireless Router conditions per FCC KDB Publication 941225 D06v02r01, the actual Portable Hotspot operation (with actual simultaneous transmission of a transmitter with WIFI) was not activated (See Section 6.7 for more details).
- 10. Per FCC KDB Publication 648474 D04v01r03, this device is considered a "phablet" since the diagonal dimension is > 160 mm and < 200 mm. Therefore, phablet SAR tests are required when wireless router mode does not apply or if wireless router 1g SAR > 1.2 W/kg.

### 12 FCC MULTI-TX AND ANTENNA SAR CONSIDERATIONS

#### 12.1 Introduction

The following procedures adopted from FCC KDB Publication 447498 D01v06 are applicable to devices with built-in unlicensed transmitters such as 802.11 and Bluetooth devices which may simultaneously transmit with the licensed transmitter.

Please see the original compliance evaluation for the standalone reported SAR for modes and bands not evaluated for this permissive change.

### 12.2 Simultaneous Transmission Procedures

This device contains transmitters that may operate simultaneously. Therefore, simultaneous transmission analysis is required. Per FCC KDB Publication 447498 D01v06 4.3.2 and IEEE 1528-2013 Section 6.3.4.1.2, simultaneous transmission SAR test exclusion may be applied when the sum of the 1g SAR for all the simultaneous transmitting antennas in a specific a physical test configuration is ≤1.6 W/kg. The different test positions in an exposure condition may be considered collectively to determine SAR test exclusion according to the sum of 1g or 10g SAR.

Per FCC KDB Publication 941225 D06v02r01, the devices edges with antennas more than 2.5 cm from edge are not required to be evaluated for SAR ("-").

(\*) For test positions that were not required to be evaluated for WLAN SAR per FCC KDB publication 248227, the worst case WLAN SAR result for the applicable exposure conditions was used for simultaneous transmission analysis.

Qualcomm Smart Transmit algorithm in WWAN adds directly the time-averaged RF exposure from 4G and time-averaged RF exposure from 5G NR. Smart Transmit algorithm controls the total RF exposure from both 4G and 5G NR to not exceed FCC limit. Therefore, simultaneous transmission compliance between 4G+5G operations is demonstrated in the Qualcomm Part 2 Report during algorithm validation.

### 12.6 Phablet Simultaneous Transmission Analysis

For SAR summation, the highest reported SAR across all test distances was used as the most conservative evaluation for simultaneous transmission analysis for each device edge.

Per FCC KDB Publication 648474 D04 Handset SAR, Phablet SAR tests were not required if wireless router 1g SAR (scaled to the maximum output power, including tolerance) < 1.2 W/kg. Therefore no further analysis beyond the tables included in this section was required to determine that possible simultaneous transmission scenarios would not exceed the SAR limit.

### 16 CONCLUSION

#### 16.1 Measurement Conclusion

The SAR evaluation indicates that the EUT complies with the RF radiation exposure limits of the FCC and Innovation, Science, and Economic Development Canada, with respect to all parameters subject to this test. These measurements were taken to simulate the RF effects of RF exposure under worst-case conditions. Precise laboratory measures were taken to assure repeatability of the tests.
