This report covers the Samsung models SM-N986B1/DS, SM-N986B1.

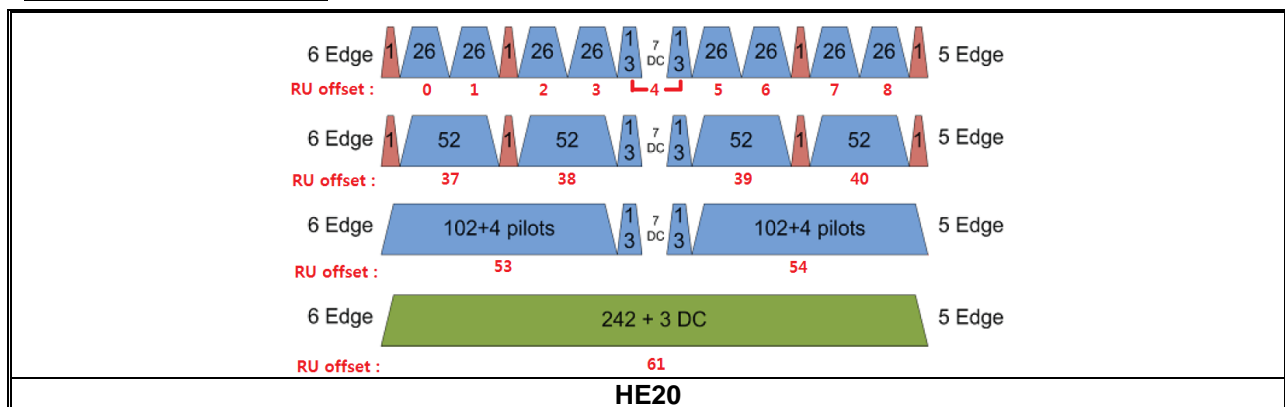
These models are identical in hardware except SM-N986B1/DS is supported dual SIM tray and SM-N986B1 has single SIM tray.

5.3. DESCRIPTION OF AVAILABLE ANTENNAS

An intentional radiator antenna shall be designed to ensure that no antenna other than that furnished by the responsible party can be used with the device. 5.5. WORST-CASE CONFIGURATION AND MODE

Radiated emission below 1GHz and power line conducted emission were performed with the EUT set to transmit at the channel with highest output power as worst-case scenario. Radiated emission above 1GHz was performed with the EUT set to transmit low/mid/High Channels.

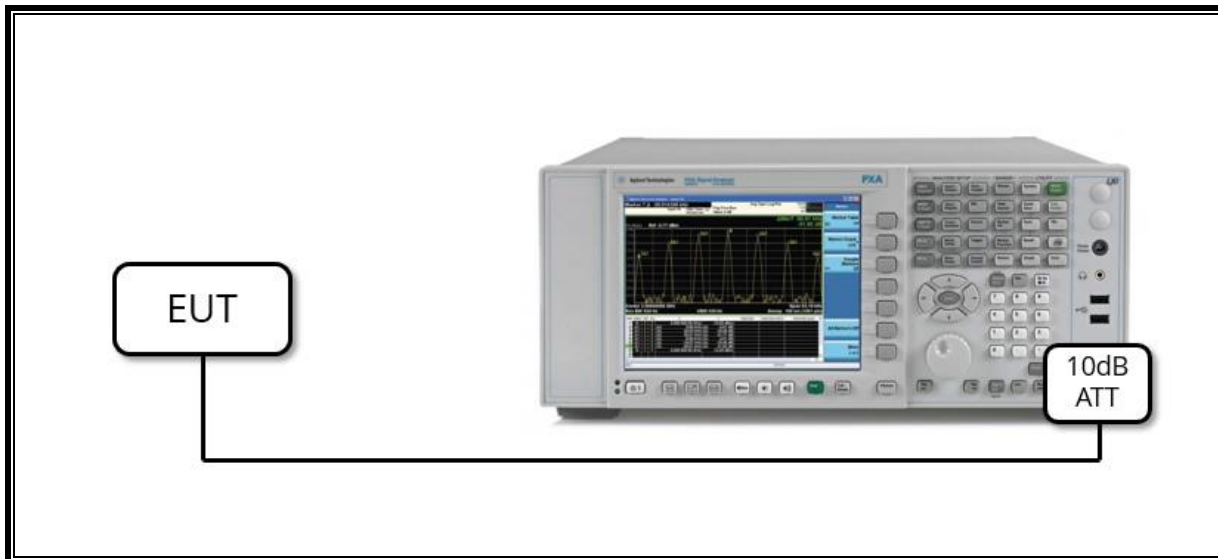

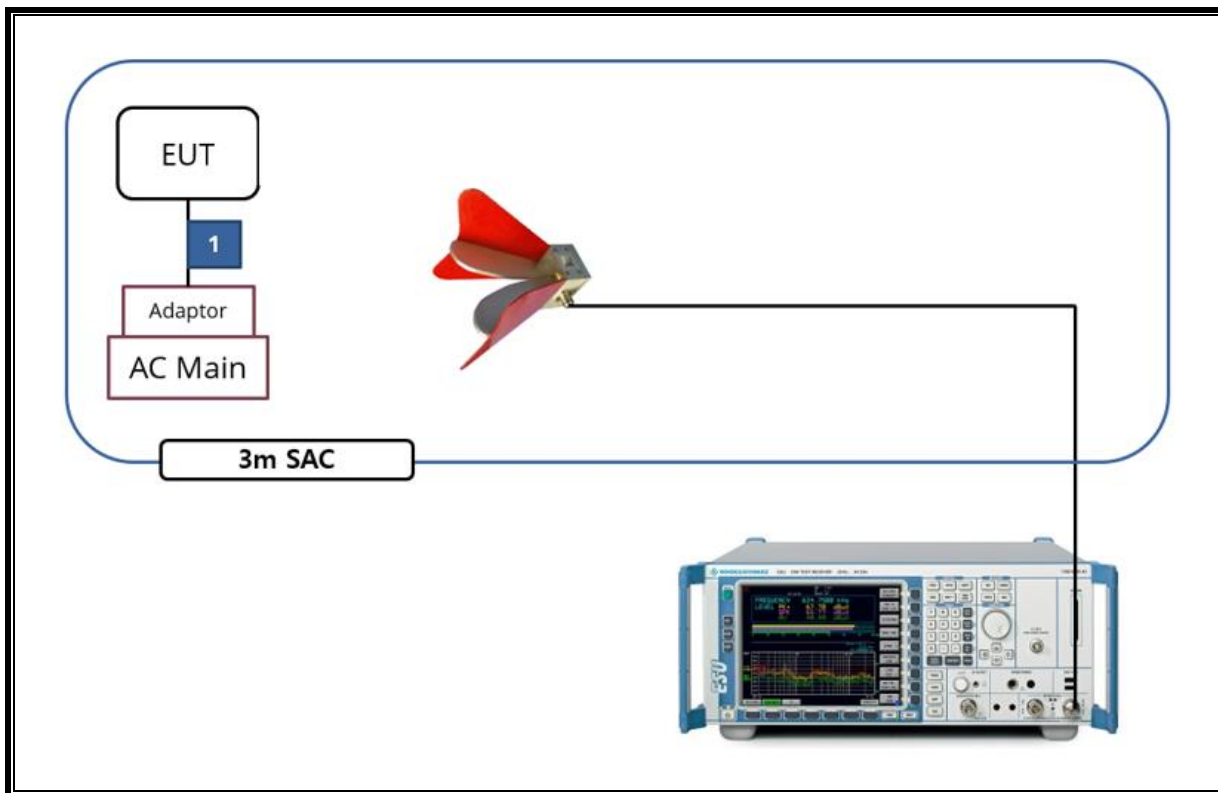
