INTRODUCTION 1.0

1.1 Scope

Measurement and determination of electromagnetic emissions (EMC) of radio frequency devices including intentional and/or unintentional radiators for compliance with the technical rules and regulations of the Federal Communications Commission and the Industry Canada Certification and Engineering Bureau.

1.2 **PCTEST Test Location**




Figure 1-1. Map of the Greater Baltimore and Metropolitan Washington, D.C. area

The map below shows the location of the PCTEST LABORATORY, its proximity to the FCC Laboratory, the Columbia vicinity, the Baltimore-Washington Internt'I (BWI) airport, the city of Baltimore and the Washington, DC area. (See Figure 1-1).

These measurement tests were conducted at the PCTEST Engineering Laboratory, Inc. facility located at 7185 Oakland Mills Road, Columbia, MD 21046. The site coordinates are 39° 10'23" N latitude and 76° 49'50" W longitude. The facility is 0.4 miles North of the FCC laboratory, and the ambient signal and ambient signal strength are approximately equal to those of the FCC laboratory. The detailed description of the measurement facility was found to be in compliance with the requirements of § 2.948 according to ANSI C63.4-2009 on February 15, 2012.

2.0 PRODUCT INFORMATION

2.1 Equipment Description

The Equipment Under Test (EUT) is the **Samsung Portable Tablet FCC ID: A3LSMP600**. The test data contained in this report pertains only to the emissions due to the EUT's ANT+ transmitter.

2.2 Device Capabilities

This device contains the following capabilities:

802.11a/b/g/n/ac WLAN (DTS/NII), Bluetooth (1x, EDR, LE), ANT+

Note: This device is capable of operating in hopping and non-hopping mode. The EUT can hop between 79 different channels in the 2400 – 2483.5MHz band.

2.3 Test Configuration

The Samsung Portable Tablet FCC ID: A3LSMP600 was tested per the guidance of ANSI C63.10-2009. See Section 3.2 of this test report for a description of the radiated emissions test setup.

2.4 EMI Suppression Device(s)/Modifications

No EMI suppression device(s) were added and no modifications were made during testing.

2.5 Labeling Requirements

Per 15.19; Docket 95-19

The label shall be permanently affixed at a conspicuous location on the device; instruction manual or pamphlet supplied to the user and be readily visible to the purchaser at the time of purchase. DESCRIPTION OF TEST 3.0

3.1 **Evaluation Procedure**

The measurement procedure described in the American National Standard for Testing Unlicensed Wireless Devices (ANSI C63.10-2009) was used in the measurement of the Samsung Portable Tablet FCC ID: A3LSMP600.

3.2 **Radiated Emissions**

The radiated test facilities consisted of an indoor 3 meter semi-anechoic chamber used for final measurements and exploratory measurements, when necessary. The measurement area is contained within the semianechoic chamber which is shielded from any ambient interference. For measurements above 1GHz absorbers are arranged on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections. For measurements below 1GHz, the absorbers are removed. An ETS Lindgren Model 2188 raised turntable is used for radiated measurement. It is a continuously rotatable, remotecontrolled, metallic turntable and 2 meters (6.56 ft.) in diameter. The turn table is flush with the raised floor of the chamber in order to maintain its function as a ground plane. A 78cm high PVC support structure is placed on top of the turntable. A ³/₄" (~1.9cm) sheet of high density polyethylene is used as the table top and is placed on top of the PVC supports to bring the total height of the table to 80cm.

For all measurements, the spectrum was scanned through all EUT azimuths and from 1 to 4 meter receive antenna height using a broadband antenna from 30MHz up to the upper frequency shown in 15.33(b)(1) depending on the highest frequency generated or used in the device or on which the device operates or tunes. For frequencies above 1GHz, linearly polarized double ridge horn antennas were used. For frequencies below 30MHz, a calibrated loop antenna was used. When exploratory measurements were necessary, they were performed at 1 meter test distance inside the semi-anechoic chamber using broadband antennas, broadband amplifiers, and spectrum analyzers to determine the frequencies and modes producing the maximum emissions. Sufficient time for the EUT, support equipment, and test equipment was allowed in order for them to warm up to their normal operating condition. The test set-up was placed on top of the 0.8 meter high, 1 x 1.5 meter table. The EUT, support equipment, and interconnecting cables were arranged and manipulated to maximize each emission. Appropriate precaution was taken to ensure that all emissions from the EUT were maximized and investigated. The system configuration, clock speed, mode of operation or video resolution, if applicable, turntable azimuth, and receive antenna height was noted for each frequency found.

Final measurements were made in the semi-anechoic chamber using calibrated, linearly polarized broadband and horn antennas. The test setup was configured to the setup that produced the worst case emissions. The spectrum analyzer was set to investigate all frequencies required for testing to compare the highest radiated disturbances with respect to the specified limits. The turntable containing the EUT was rotated through 360 degrees and the height of the receive antenna was varied 1 to 4 meters and stopped at the azimuth and height producing the maximum emission. Each emission was maximized by changing the orientation of the EUT through three orthogonal planes and changing the polarity of the receive antenna, whichever produced the worst-case emissions. For the EUT positioning, "H" is defined with the EUT lying flat on the test surface, "H2" is defined with the EUT standing up on its side, and "V" is defined with the EUT standing upright.

The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section."

- The antennas of the Samsung Portable Tablet are **permanently attached**.
- There are no provisions for connection to an external antenna.



6.2 **Duty Cycle Calculation** <u>§15.35(c)</u>

Per FCC Part 15.35(c), an average radiated field strength can be determined by applying a duty cycle correction factor to a measured peak radiated field strength level. The duty cycle correction factor is determined based on the worst case operation over a 100ms time period on any given channel. Two plots are included below to determine the appropriate duty cycle correction factor.

In Plot 6-1 beow, it is shown that the pulse width for one transmission burst of the ANT+ transmitter while operating in non-hopping mode is 217.95 µs.

Plot 6-1. Pulse Width Measurement



Since it is determined that the transmitter burst appears a maximum of 2 times over a 100ms window with a pulse width of 217.95µs, then the appropriate duty cycle correction factor is determined from the following formula, based on 15.35(c):

DCCF = $20\log_{10}$ (number of hits x (worst case 100ms operation / 100ms)) = 20log₁₀ (2 x (0.21795 ms/100ms)) = -47.21dB

6.3 Fundamental Field Strength Level Measurement §15.249(a)(e); RSS-210 (A2.9(a))

Measurement is made while the EUT is operating in non-hopping transmission mode. The field strengths shown below were measured using a spectrum analyzer. Peak field strength measurements are performed in the analyzers' swept spectrum mode using a peak detector with RBW = 3MHz and $VBW \ge RBW$. Average field strength data is determined by applying the duty cycle correction factor (DCCF) found in Section 6.2 to the measured peak field strength values.

The maximum permissible average field strength level is 50mV/m (93.98dB μ V/m). The maximum permissible peak field strength level is 500mV/m (113.98 dB μ V/m).

Test Notes

- The spectrum is measured from 9kHz to the 10th harmonic and the worst-case emissions are reported. There were no non-harmonic emissions detected whose levels were within 20dB of the applicable limits so only harmonic emissions data is shown in this section.
- All emissions lying in restricted bands specified in §15.205 are below the limit shown in Table 6-3. Per 15.249(d), the radiated emissions limits from 15.209 were used since they were less than the limit of 50dB of attenuation from the measured fundamental field strength level.
- 2. Peak measurements > 1GHz using RBW = 1MHz and VBW = 3MHz.
- 3. The antenna is manipulated through typical positions, polarity and length during the tests. The EUT is manipulated through three orthogonal planes.
- 4. The EUT is supplied with nominal AC voltage and/or a new/fully-recharged battery. The standard battery for this device contains an embedded NFC antenna.
- 5. Peak levels at -125dBm represent the analyzer noise floor and signify that no emission was detected. No detectable emissions were found. Since the peak measurements are shown to comply with the average limits, no average spurious emissions measurements were recorded.




6.5 Radiated Restricted Band Edge Measurements §15.205 & §15.209, §15.247 (d); RSS-210 (A8.5)

The radiated restricted band edge measurements are measured with an EMI test receiver connected to the receive antenna while the EUT is transmitting. Two different amplitude offsets were used depending on whether peak or average measurements were measured. The average measurements use a duty cycle correction factor (DCCF).

The amplitude offset shown in the following plots for average measurements was calculated using the formula:

Offset (dB) = (Antenna Factor + Cable Loss + 10 dB Attenuator) – Preamplifier Gain + DCCF

Plot 6-3. Radiated Restricted Upper Band Edge Measurement (Average)


