

3. Antenna requirement

Requirement of FCC part section 15.203:

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

4. Introduction

Based on their similarity, the FCC Part 15C and RSS-247 (equipment class: DSS) reuse the original model's result and do spot-check, following the FCC KDB 484596 D01 v01.

And the applicant takes full responsibility that the test data as referenced in this report represent compliance for this FCC ID and IC ID.

4.1 Difference

The FCC ID: A3LSMR880 & IC: 649E-SMR880 shares the same enclosure and circuit board as FCC ID: A3LSMR885 & IC: 649E-SMR885. The WIFI/BT/BLE antenna and surrounding circuitry and layout are identical between these two units.

As for all bands, they have been verified and the parent model test results under FCC ID : A3LSMR885 & IC: 649E-SMR885 shall remain representative of FCC ID : A3LSMR880 & IC: 649E-SMR880.

Limit

According to §15.247(a)(1), Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 $\,\mathrm{klz}$ or the 20 $\,\mathrm{dB}$ bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2 400-2 483.5 $\,\mathrm{klz}$ band may have hopping channel carrier frequencies that are separated by 25 $\,\mathrm{klz}$ or two-thirds of the 20 $\,\mathrm{dB}$ bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 $\,\mathrm{mW}$.

According to §15.247(b)(1), for frequency hopping systems operating in the 2 400-2 483.5 Mb band employing at least 75 non-overlapping hopping channels, and all frequency hopping systems in the 5 725-5 850 Mb band: 1 watt. For all other frequency hopping systems in the 2 400-2 483.5 Mb band: 0.125 watts.

According to §15.247(b)(4) The conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 $\,\mathrm{dBi}$. Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 $\,\mathrm{dBi}$ are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in $\,\mathrm{dB}$ that the directional gain of the antenna exceeds 6 $\,\mathrm{dBi}$.

According to RSS-247(5.4)(b), for FHSs operating in the band 2400-2483.5 Mb, the maximum peak conducted output power shall not exceed 1.0 W if the hopset uses 75 or more hopping channels; the maximum peak conducted output power shall not exceed 0.125 W if the hopset uses less than 75 hopping channels.

The e.i.r.p. shall not exceed 4 W, except as provided in section 5.4(e).



8.2. Carrier frequency separation



<u>Limit</u>

According to §15.247(a)(1) and RSS-247(5.1)(b), frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 $\,\mathrm{kllz}$ or the 20 $\,\mathrm{dB}$ bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2 400-2 483.5 $\,\mathrm{kllz}$ band may have hopping channel carrier frequencies that are separated by 25 $\,\mathrm{kllz}$ or two-thirds of the 20 $\,\mathrm{dB}$ bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 $\,\mathrm{mW}$.

Test procedure

ANSI C63.10-2013 - Section 7.8.2

Test settings

- a) Span: Wide enough to capture the peaks of two adjacent channels.
- b) RBW: Start with the RBW set to approximately 30 % of the channel spacing; adjust as necessary to best identify the center of each individual channel.
- c) Video (or average) bandwidth (VBW) ≥ RBW.
- d) Sweep: Auto.
- e) Detector function: Peak.
- f) Trace: Max hold.
- g) Allow the trace to stabilize.





8.3. 20dB channel bandwidth & 99% Bandwidth



<u>Limit</u>

According to §15.247(a)(1) and RSS-247(5.1)(b), frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 $\,\mathrm{klz}$ or the 20 $\,\mathrm{dB}$ bandwidth of the hopping channel, whichever is greater. The occupied bandwidth is measured as the width of the spectral envelope of the modulated signal, at an amplitude level reduced from a reference value by a specified ratio (or in decibels, a specified number of dB down from the reference value). Typical ratios, expressed in dB, are $-6\ dB$, $-20\ dB$, and $-26\ dB$, corresponding to 6 dB BW, 20 dB BW, and 26 dB BW, respectively. In this subclause, the ratio is designated by "-xx dB." The reference value is either the level of the unmodulated carrier or the highest level of the spectral envelope of the modulated signal, as stated by the applicable requirement. Some requirements might specify a specific maximum or minimum value for the "-xx dB" bandwidth; other requirements might specify that the "-xx dB" bandwidth be entirely contained within the authorized or designated frequency band.

- e) The dynamic range of the instrument at the selected RBW shall be more than 10 dB below the target "-xx dB down" requirement; that is, if the requirement calls for measuring the -20 dB OBW, the instrument noise floor at the selected RBW shall be at least 30 dB below the reference value.
- f) Detector: peak
- g) Trace mode: max hold.
- h) Allow the trace to stabilize.
- i) Determine the "-xx dB down amplitude" using ((reference value) xx). Alternatively, this calculation may be made by using the marker-delta function of the instrument.
- j) If the reference value is determined by an unmodulated carrier, then turn the EUT modulation ON, and either clear the existing trace or start a new trace on the spectrum analyzer and allow the new trace to stabilize. Otherwise, the trace from step g) shall be used for step j).
- k) Place two markers, one at the lowest frequency and the other at the highest frequency of the

8.5. Time of occupancy(Dwell time)



<u>Limit</u>

According to §15.247(a)(1)(iii) and RSS-247(5.1)(d), frequency hopping systems in the 2 400-2 483.5 Mb band shall use at least 15 channels. The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed. Frequency hopping systems may avoid or suppress transmissions on a particular hopping frequency provided that a minimum of 15 channels are used.






The diagram below shows the test setup that is utilized to make the measurements for emission from 9 kHz to 30 kHz Emissions

Attenuation below the general field strength limits specified in RSS-Gen is not required.

According to RSS-Gen(8.9), Except where otherwise indicated in the applicable RSS, radiated emissions shall comply with the field strength limits shown in table 5 and table 6. Additionally, the level of any transmitter unwanted emission shall not exceed the level of the transmitter's fundamental emission.

Note: The Worst case was based on the lowest margin condition considering Harmonic and Spurious Emission



8.7. Conducted Spurious Emission



<u>Limit</u>







8.8. AC Conducted emission

According to 15.207(a) and RSS-Gen(8.8), for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies, within the band 150 kHz to 30 kHz, shall not exceed the limits in the following table, as measured using a 50uH/50 ohm line impedance stabilization network (LISN). Measurement procedure

- 1. The EUT was placed on a wooden table of size, 1 m by 1.5 m, raised 80 cm in which is located 40 cm away from the vertical wall and 1.5m away from the side wall of the shielded room.
- 2. Each current-carrying conductor of the EUT power cord was individually connected through a $50\Omega/50\mu H$ LISN, which is an input transducer to a spectrum analyzer or an EMI/Field Intensity Meter, to the input power source.
- 3. Exploratory measurements were made to identify the frequency of the emission that had the highest amplitude relative to the limit by operating the EUT in a range of typical modes of operation, cable position, and with a typical system equipment configuration and arrangement. Based on the exploratory tests of the EUT, the one EUT cable configuration and arrangement and mode of operation that had produced the emission with the highest amplitude relative to the limit was selected for the final measurement.
- 4. The final test on all current-carrying conductors of all of the power cords to the equipment that comprises the EUT (but not the cords associated with other non-EUT equipment is the system) was then performed over the frequency range of 0.15 MHz to 30 MHz.
- 5. The measurements were made with the detector set to peak amplitude within a bandwidth of 10 kHz or to quasi-peak and average within a bandwidth of 9 kHz. The EUT was in transmitting mode during the measurements.


