

 - 1) This system is hopping pseudo-randomly.
 - 2) Each frequency is used equally on the average by each transmitter.

The applicant for equipment certification shall provide a list of all antenna types that may be used with the transmitter, where applicable (i.e. for transmitters with detachable antenna), indicating the maximum permissible antenna gain (in dBi) and the required impedance for each antenna. The test report shall demonstrate the compliance of the transmitter with the limit for maximum equivalent isotropically radiated power (e.i.r.p.) specified in the applicable RSS, when the transmitter is equipped with any antenna type, selected from this list.

4. Introduction

This report referenced from the FCC ID: A3LSMR915 and IC: 649E-SMR915.

Based on their similarity, the FCC Part 15C and RSS-247 (equipment class: DSS) reuse the original model's result and do spot-check, following the FCC KDB 484596 D01 v01.

And the applicant takes full responsibility that the test data as referenced in this report represent compliance for this FCC ID and IC ID.

4.1 Difference

The FCC ID: A3LSMR910 & IC: 649E-SMR910 shares the same enclosure and circuit board as FCC ID: A3LSMR915 & IC: 649E-SMR915. The WIFI/BT/BLE antenna and surrounding circuitry and layout are identical between these two units.

As for all bands, they have been verified and the parent model test results under FCC ID : A3LSMR915 & IC: 649E-SMR915 shall remain representative of FCC ID : A3LSMR910 & IC: 649E-SMR910.

Note. The difference between the parent and variant is that the RF circuit for WCDMA/LTE bands in the parent model SM-R915U is removed from the variant model SMR910/SM-910X.

Although these tests were performed other than open field site, adequate comparison measurements were confirmed against 30 m open field site. 8.1. Maximum peak output power

According to §15.247(a)(1), Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 $\,\mathrm{klz}$ or the 20 $\,\mathrm{dB}$ bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2 400-2 483.5 $\,\mathrm{klz}$ band may have hopping channel carrier frequencies that are separated by 25 $\,\mathrm{klz}$ or two-thirds of the 20 $\,\mathrm{dB}$ bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 $\,\mathrm{mW}$.

According to §15.247(b)(1), for frequency hopping systems operating in the 2 400-2 483.5 Mb band employing at least 75 non-overlapping hopping channels, and all frequency hopping systems in the 5 725-5 850 Mb band: 1 watt. For all other frequency hopping systems in the 2 400-2 483.5 Mb band: 0.125 watts.

According to §15.247(b)(4) The conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

IC

According to RSS-247(5.4)(b), for FHSs operating in the band 2400-2483.5 Mb, the maximum peak conducted output power shall not exceed 1.0 W if the hopset uses 75 or more hopping channels; the maximum peak conducted output power shall not exceed 0.125 W if the hopset uses less than 75 hopping channels.

The e.i.r.p. shall not exceed 4 W, except as provided in section 5.4(e).

Test settings

The test follows ANSI C63.10-2013 – Section 7.8.5. Using the power sensor instead of a spectrum analyzer.



8.2. Carrier frequency separation



Limit

According to §15.247(a)(1) and RSS-247(5.1)(b), frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2 400-2 483.5 Mz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW.

Test procedure

ANSI C63.10-2013 - Section 7.8.2

Test settings

- a) Span: Wide enough to capture the peaks of two adjacent channels.
- b) RBW: Start with the RBW set to approximately 30 % of the channel spacing; adjust as necessary to best identify the center of each individual channel.
- c) Video (or average) bandwidth (VBW) ≥ RBW.
- d) Sweep: Auto.
- e) Detector function: Peak.
- f) Trace: Max hold.
- g) Allow the trace to stabilize.

Use the marker-delta function to determine the separation between the peaks of the adjacent Channels. Compliance of an EUT with the appropriate regulatory limit shall be determined. A plot of the data shall be included in the test report.





8.3. 20dB channel bandwidth & 99% Bandwidth



<u>Limit</u>

According to §15.247(a)(1) and RSS-247(5.1)(b), frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 $\,\mathrm{kHz}$ or the 20 $\,\mathrm{dB}$ bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2 400-2 483.5 $\,\mathrm{Mz}$ band may have hopping channel carrier frequencies that are separated by 25 $\,\mathrm{kHz}$ or two-thirds of the 20 $\,\mathrm{dB}$ bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 $\,\mathrm{mW}$.

Test settings

20dB channel bandwidth and Occupied bandwidth

The occupied bandwidth is measured as the width of the spectral envelope of the modulated signal, at an amplitude level reduced from a reference value by a specified ratio (or in decibels, a specified number of dB down from the reference value). Typical ratios, expressed in dB, are -6 dB, -20 dB, and -26 dB, corresponding to 6 dB BW, 20 dB BW, and 26 dB BW, respectively. In this subclause, the ratio is designated by "-xx dB." The reference value is either the level of the unmodulated carrier or the highest level of the spectral envelope of the modulated signal, as stated by the applicable requirement. Some requirements might specify a specific maximum or minimum value for the "-xx dB" bandwidth; other requirements might specify that the "-xx dB" bandwidth be entirely contained within the authorized or designated frequency band.

- a) The spectrum analyzer center frequency is set to the nominal EUT channel center frequency.
- b) Span: Two times and five times the OBW.
- c) RBW = 1 % to 5 % of the OBW and VBW ≥ 3 x RBW
- d) Set the reference level of the instrument as required, keeping the signal from exceeding the maximum input mixer level for linear operation.
- e) The dynamic range of the instrument at the selected RBW shall be more than 10 dB below the target "-xx dB down" requirement; that is, if the requirement calls for measuring the -20 dB OBW, the instrument noise floor at the selected RBW shall be at least 30 dB below the reference value.
- f) Detector: peak
- g) Trace mode: max hold.
- h) Allow the trace to stabilize.
- i) Determine the "-xx dB down amplitude" using ((reference value) xx). Alternatively, this calculation may be made by using the marker-delta function of the instrument.
- j) If the reference value is determined by an unmodulated carrier, then turn the EUT modulation ON, and either clear the existing trace or start a new trace on the spectrum analyzer and allow the new trace to stabilize. Otherwise, the trace from step g) shall be used for step j).
- k) Place two markers, one at the lowest frequency and the other at the highest frequency of the

Reset the marker-delta function and move the marker to the other side of the emission until the delta marker amplitude is at the same level as the reference marker amplitude. The marker-delta frequency reading at this point is the specified emission bandwidth.

8.5. Time of occupancy(Dwell time)



<u>Limit</u>

According to §15.247(a)(1)(iii) and RSS-247(5.1)(d), frequency hopping systems in the 2 400-2 483.5 Mb band shall use at least 15 channels. The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed. Frequency hopping systems may avoid or suppress transmissions on a particular hopping frequency provided that a minimum of 15 channels are used.

- a) Span: Zero span, centered on a hopping channel.




The diagram below shows the test setup that is utilized to make the measurements for emission from 9 kHz to 30 MHz Emissions

8.7. Conducted Spurious Emission



<u>Limit</u>







8.8. AC Conducted emission

According to 15.207(a) and RSS-Gen(8.8), for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies, within the band 150 kHz to 30 kHz, shall not exceed the limits in the following table, as measured using a 50uH/50 ohm line impedance stabilization network (LISN). Compliance with the provision of this paragraph shall on the measurement of the radio frequency voltage between each power line and ground at the power terminal. Measurement procedure

- 1. The EUT was placed on a wooden table of size, 1 m by 1.5 m, raised 80 cm in which is located 40 cm away from the vertical wall and 1.5m away from the side wall of the shielded room.
- 2. Each current-carrying conductor of the EUT power cord was individually connected through a $50\Omega/50\mu H$ LISN, which is an input transducer to a spectrum analyzer or an EMI/Field Intensity Meter, to the input power source.
- 3. Exploratory measurements were made to identify the frequency of the emission that had the highest amplitude relative to the limit by operating the EUT in a range of typical modes of operation, cable position, and with a typical system equipment configuration and arrangement. Based on the exploratory tests of the EUT, the one EUT cable configuration and arrangement and mode of operation that had produced the emission with the highest amplitude relative to the limit was selected for the final measurement.
- 4. The final test on all current-carrying conductors of all of the power cords to the equipment that comprises the EUT (but not the cords associated with other non-EUT equipment is the system) was then performed over the frequency range of 0.15 Mb to 30 Mb.
- 5. The measurements were made with the detector set to peak amplitude within a bandwidth of 10 klb or to quasi-peak and average within a bandwidth of 9 klb. The EUT was in transmitting mode during the measurements.


