

## Antenna requirement

#### Requirement of FCC part section 15.203:

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

#### Requirement of RSS-Gen Section 6.8:

The applicant for equipment certification shall provide a list of all antenna types that may be used with the transmitter, where applicable (i.e. for transmitters with detachable antenna), indicating the maximum permissible antenna gain (in dBi) and the required impedance for each antenna. The test report shall demonstrate the compliance of the transmitter with the limit for maximum equivalent isotropically radiated power (e.i.r.p.) specified in the applicable RSS, when the transmitter is equipped with any antenna type, selected from this list.

For expediting the testing, measurements may be performed using only the antenna with highest gain of each combination of transmitter and antenna type, with the transmitter output power set at the maximum level. However, the transmitter shall comply with the applicable requirements under all operational conditions and when in combination with any type of antenna from the list provided in the test report (and in the notice to be included in the user manual, provided below).

When measurements at the antenna port are used to determine the RF output power, the effective gain of the device's antenna shall be stated, based on a measurement or on data from the antenna's manufacturer.

The test report shall state the RF power, output power setting and spurious emission measurements with each antenna type that is used with the transmitter being tested.

Immediately following the above notice, the manufacturer shall provide a list of all antenna types which can be used with the transmitter, indicating the maximum permissible antenna gain (in  $\,\mathrm{dBi}$ ) and the required impedance for each antenna type.

## 4. Introduction

This report referenced from the FCC ID: A3LSMR915 and IC: 649E-SMR915.

Based on their similarity, the FCC Part 15C and RSS-247 (equipment class: DTS) reuse the original model's result and do spot-check, following the FCC KDB 484596 D01 v01.

And the applicant takes full responsibility that the test data as referenced in this report represent compliance for this FCC ID and IC ID.

## 4.1 Difference

The FCC ID: A3LSMR910 & IC: 649E-SMR910 shares the same enclosure and circuit board as FCC ID: A3LSMR915 & IC: 649E-SMR915. The WIFI/BT/BLE antenna and surrounding circuitry and layout are identical between these two units.

As for all bands, they have been verified and the parent model test results under FCC ID : A3LSMR915 & IC: 649E-SMR915 shall remain representative of FCC ID : A3LSMR910 & IC: 649E-SMR910.

**Note.** The difference between the parent and variant is that the RF circuit for WCDMA/LTE bands in the parent model SM-R915U is removed from the variant model SMR910/SM-910X.

According to §15.247(b)(3), For systems using digital modulation in the 902-928 Mb, 2 400-2 483.5 Mb, and 5 725-5 850 Mb bands: 1 Watt. As an alternative to a peak power measurement, compliance with the one Watt limit can be based on a measurement of the maximum conducted output power. Maximum Conducted Output Power is defined as the total transmit power delivered to all antennas and antenna elements averaged across all symbols in the signaling alphabet when the transmitter is operating at its maximum power control level. Power must be summed across all antennas and antenna elements. The average must not include any time intervals during which the transmitter is off or is transmitting at a reduced power level. If multiple modes of operation are possible (e.g., alternative modulation methods), the maximum conducted output power is the highest total transmit power occurring in any mode.

According to §15.247(b)(4) The conducted output power limit specified in paragraph (b) of this section is based on the use of antennas with directional gains that do not exceed 6 dBi. Except as shown in paragraph (c) of this section, if transmitting antennas of directional gain greater than 6 dBi are used, the conducted output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1), (b)(2), and (b)(3) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

#### IC

According to RSS-247 5.4(d), For DTSs employing digital modulation techniques operating in the bands 902-928 MHz and 2400-2483.5 MHz, the maximum peak conducted output power shall not exceed 1 W. The e.i.r.p. shall not exceed 4 W, except as provided in section 5.4(e).

#### Test settings

#### General

Section 15.247 permits the maximum conducted (average) output power to be measured as an alternative to the maximum peak conducted output power for demonstrating compliance to the limit. When this option is exercised, the measured power is to be referenced to the OBW rather than the DTS bandwidth (see ANSI C63.10 for measurement guidance).

When using a spectrum analyzer or EMI receiver to perform these measurements, it shall be capable of utilizing a number of measurement points in each sweep that is greater than or equal to twice the span/RBW to set a bin-to-bin spacing of ≤ RBW/2 so that narrowband signals are not lost between frequency bins.

If possible, configure or modify the operation of the EUT so that it transmits continuously at its maximum power control level. The intent is to test at 100 % duty cycle; however a small reduction in duty cycle (to no lower than 98 %) is permitted, if required by the EUT for amplitude control purposes. Manufacturers are expected to provide software to the test lab to permit such continuous operation.

If continuous transmission (or at least 98 % duty cycle) cannot be achieved due to hardware limitations (e.g., overheating), the EUT shall be operated at its maximum power control level, with the transmit duration as long as possible, and the duty cycle as high as possible during which sweep triggering/signal gating techniques may be used to perform the measurement over the transmission duration.

#### 11.9.1. Maximum peak conducted output power

One of the following procedures may be used to determine the maximum peak conducted output power of a DTS EUT.

#### 11.9.1.1. RBW ≥ DTS bandwidth

The following procedure shall be used when an instrument with a resolution bandwidth that is greater than the DTS bandwidth is available to perform the measurement:

- Set the RBW ≥ DTS bandwidth. a)
- Set VBW  $\geq$  [3  $\times$  RBW]. b)
- Set span  $\geq$  [3  $\times$  RBW]. c)
- d) Sweep time = auto couple.
- Detector = peak. e)
- Trace mode = max hold. f)
- Allow trace to fully stabilize. g)
- Use peak marker function to determine the peak amplitude level. h)

#### 11.9.1.3. PKPM1 Peak power meter method

The maximum peak conducted output power may be measured using a broadband peak RF power meter. The power meter shall have a video bandwidth that is greater than or equal to the DTS bandwidth an shall use a fast-responding diode detector.

#### 11.9.2.3.1. Measurement using a power meter (PM)

Method AVGPM is a measurement using an RF average power meter, as follows:

- a) As an alternative to spectrum analyzer or EMI receiver measurements, measurements may be performed using a wideband RF power meter with a thermocouple detector or equivalent if all of the conditions listed below are satisfied:
  - 1) The EUT is configured to transmit continuously, or to transmit with a constant duty cycle.
  - 2) At all times when the EUT is transmitting, it shall be transmitting at its maximum power control level.
  - 3) The integration period of the power meter exceeds the repetition period of the transmitted signal by at least a factor of five.
- b) If the transmitter does not transmit continuously, measure the duty cycle, D, of the transmitter output signal as described in 11.6.
- c) Measure the average power of the transmitter. This measurement is an average over both the ON and OFF periods of the transmitter.
- d) Adjust the measurement in dBm by adding [10 log(1/D)], where D is the duty cycle

A peak responding power sensor is used, where the power sensor system video bandwidth is greater than the occupied bandwidth of the EUT.





#### Occupied bandwidth (or 99% emission bandwidth)

- The transmitter shall be operated at its maximum carrier power measured under normal test conditions.
- The span of the spectrum analyzer shall be set large enough to capture all products of the modulation process, including the emissions skirts, around the carrier frequency, but small enough to avoid having other emissions (e.g. on adjacent channels) within the span.
- The detector of the spectrum analyzer shall be set to "Sample". However, a peak, or peak hold, may be used in place of the sampling detector since this usually produces a wider bandwidth than the actual bandwidth (worst-case measurement). Use of a peak hold (or "Max hold") may be necessary to determine the occupied / x dB bandwidth if the device is not transmitting continuously.
- The resolution bandwidth (RBW) shall be in the range of 1% to 5% of the actual occupied / x dB bandwidth and the video bandwidth (VBW) shall not be smaller than three times the RBW value. Video averaging is not permitted

<u>Notes:</u> it may be necessary to repeat the measurement a few times until the RBW and VBW are in compliance with the above requirement.

For the 99% emission bandwidth, the trace data points are recovered and directly summed in linear power level terms, The recovered amplitude data points, beginning at the lowest frequency, are placed in a running sum until 0.5% of the total is reached, and that frequency recorded. The process is repeated for the highest frequency data points (starting at the highest frequency, at the right side of the span, and going down in frequency). This frequency is then recorded. The difference between the two recorded frequencies is the occupied bandwidth (or the 99% emission bandwidth).






The diagram below shows the test setup that is utilized to make the measurements for emission from 9 kHz to 30 MHz Emissions

The field strength of emissions appearing within these frequency bands shall not exceed the limits shown in section 15.209. At frequencies equal to or less than 1 000 Mb, compliance with the limits in section 15.209 shall be demonstrated using measurement instrumentation employing a CISPR quasi-peak detector. According to RSS-247(5.5), In any 100 klb bandwidth outside the frequency band in which the spread spectrum or digitally modulated device is operating, the RF power that is produced shall be at least 20 dB below that in the 100 klb bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided that the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of root-mean-square averaging over a time interval, as permitted under section 5.4(d), the attenuation required shall be 30 dB instead of 20 dB. Attenuation below the general field strength limits specified in RSS-Gen is not required.

According to RSS-Gen(8.9), Except where otherwise indicated in the applicable RSS, radiated emissions shall comply with the field strength limits shown in table 5 and table 6. Additionally, the level of any transmitter unwanted emission shall not exceed the level of the transmitter's fundamental emission.

- (a) The transmit frequency, including fundamental components of modulation, of licence-exempt radio apparatus shall not fall within the restricted frequency bands listed in table 7 except for apparatus compliant with RSS-287, Emergency Position Indicating Radio Beacons (EPIRB), Emergency Locator Transmitters (ELT), Personal Locator Beacons (PLB), and Maritime Survivor Locator Devices (MSLD).

# 8.6. AC Conducted emission

#### Limit

According to 15.207(a) and RSS-Gen(8.8), for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies, within the band 150 kHz to 30 kHz, shall not exceed the limits in the following table, as measured using a 50uH/50 ohm line impedance stabilization network (LISN). Compliance with the provision of this paragraph shall on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower applies at the boundary between the frequencies ranges.

#### **Measurement procedure**

- 1. The EUT was placed on a wooden table of size, 1 m by 1.5 m, raised 80 cm in which is located 40 cm away from the vertical wall and 1.5m away from the side wall of the shielded room.
- 2. Each current-carrying conductor of the EUT power cord was individually connected through a  $50\Omega/50\mu H$  LISN, which is an input transducer to a spectrum analyzer or an EMI/Field Intensity Meter, to the input power source.
- 3. Exploratory measurements were made to identify the frequency of the emission that had the highest amplitude relative to the limit by operating the EUT in a range of typical modes of operation, cable position, and with a typical system equipment configuration and arrangement. Based on the exploratory tests of the EUT, the one EUT cable configuration and arrangement and mode of operation that had produced the emission with the highest amplitude relative to the limit was selected for the final measurement.
- 4. The final test on all current-carrying conductors of all of the power cords to the equipment that comprises the EUT (but not the cords associated with other non-EUT equipment is the system) was then performed over the frequency range of 0.15 MHz to 30 MHz.
- 5. The measurements were made with the detector set to peak amplitude within a bandwidth of 10 klb or to quasi-peak and average within a bandwidth of 9 klb. The EUT was in transmitting mode during the measurements.


