

<u>Test settings</u>

When an average power meter is used to perform RF output power measurements, the fundamental condition that measurement be performed only over durations of active transmissions at maximum output power level applies. Thus, an average power meter can always be used to perform the measurement when the EUT can be configured to transmit continuously.

If the EUT cannot be configured to transmit continuously (i.e., burst duty cycle < 98%), then the following options can be implemented to facilitate measurement of the average power with an average power meter:

- a) A gated average power meter can be used to perform the measurement if the gating parameters can be adjusted such that the power is measured only during active transmission bursts at maximum output power levels.
- b) A conventional average power meter with no signal gating capability can also be used if the measured burst duty cycle is constant (i.e., duty cycle variations are less than or equal to \pm 2%) by performing the measurement over the on/off burst cycles and then correcting (increasing) the measured level by a factor equal to [10log (1/duty cycle)]. See 5.2.4.3.4 for guidance with respect to measuring the transmitter duty cycle.



7.2. 99% Occupied Bandwidth & 26dB Bandwidth



Limit

According to §2.1049 and RSS-Gen 6.7, the occupied bandwidth, that is the frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers radiated are each equal to 0.5 percent of the total mean power radiated by a given emission shall be measured.

Test settings

◆ 26dB Bandwidth

- a) The spectrum analyzer center frequency is set to the nominal EUT channel center frequency. The span range for the spectrum analyzer shall be wide enough to see sufficient roll off of the signal to make the measurement.
- b) The nominal RBW shall be in the range of 1% to 5% of the anticipated OBW, and the VBW shall be set ≥ 3 × RBW.
- c) Set the reference level of the instrument as required to prevent the signal amplitude from exceeding the maximum spectrum analyzer input mixer level for linear operation. See guidance provided in 4.2.3.
- d) The dynamic range of the spectrum analyzer at the selected RBW shall be more than 10 dB below the target "-X dB" requirement, i.e., if the requirement calls for measuring the -26 dB OBW, the spectrum analyzer noise floor at the selected RBW shall be at least 36 dB below the reference level.
- e) Set spectrum analyzer detection mode to peak, and the trace mode to max hold.
- f) Determine the reference value by either of the following:
 - Set the EUT to transmit a modulated signal. Allow the trace to stabilize.
 Set the spectrum analyzer marker to the highest level of the displayed trace (this is the reference value).
 - 2) Set the EUT to transmit an unmodulated carrier. Set the spectrum analyzer marker to the level of the carrier.
- g) Determine the "-X dB amplitude" as equal to (Reference Value X). Alternatively, this calculation can be performed on the spectrum analyzer using the delta-marker measurement function.
- h) If the reference value was determined using an unmodulated carrier, turn the EUT modulation on, then either clear the existing trace or start a new trace on the spectrum analyzer and allow the new trace to stabilize. Otherwise the trace from step f) shall be used for step i).

7.6. Frequency stability



Limit

According to §2.1055(a),

The frequency stability shall be measured with variation of ambient temperature as follows:

- 1) From -30° to + 50° centigrade for all equipment except that specified in paragraphs (a) (2) and (3) of this section.
- 2) From -20° to + 50° centigrade for equipment to be licensed for use in the maritime services under part 80 of this chapter, except for class A, B, and S emergency position indicating Radiobeacons (EPIRBS), and equipment to be licensed for use above 952 Mb at operational fixed stations in all services, stations in the local television transmission service and point-to-point microwave radio service under part 21 of this chapter, equipment licensed for use aboard aircraft in the aviation services under part 87 of this chapter, and equipment authorized for use in the family radio service under part 95 of this chapter.
- 3) From 0° to + 50° centigrade for equipment to be licensed for use in the radio broadcast Services under part 73 of this chapter.

According to §2.1055(d),

The frequency stability shall be measured with variation of primary supply Voltage as follows:

- 1) Vary primary supply voltage from 85 to 115 percent of the nominal value for other than hand carried battery equipment.
- 2) For hand carried, battery powered equipment, reduce primary supply voltage to the battery operating and point which shall be specified by the manufacturer.
- 3) The supply voltage shall be measured at the input to the cable normally provided with the equipment, or at the power supply terminals if cables are not normally provided. Effects on frequency of transmitter keying (except for broadcast transmitters) and any heating element cycling at the nominal supply voltage and at each extreme also shall be shown.

According to §22.355 and RSS-132(5.3),

For FCC, the carrier frequency of each transmitter in the public mobile services must be maintained within the tolerances given in Table of this section. For mobile devices operating in the 824 to 849 $\,^{\text{MHz}}$ band at a power level than or equal to 3 Watts, the limit specified in Table C-1 is ± 2.5 ppm.




The diagram below shows the test setup that is utilized to make the measurements for emission from 30 Mz to 1 Gz emissions.

According to §22.913(a)(5), the ERP of transmitters in the cellular radiotelephone service must not exceed the limits in this section. The ERP of mobile transmitters and auxiliary test transmitters must not exceed 7 watts. And according to RSS-132(5.4), the equivalent radiated power (e.r.p.) shall not exceed 7 watts for mobile equipment and 3 watts for portable equipment.

According to §24.232(c), mobile and portable stations are limited to 2 watts EIRP and the equipment must employ a means for limiting power to the minimum necessary for successful communications. And according to RSS-133(6.4), the equivalent isotropically radiated power (e.i.r.p.) for transmitters shall not exceed the limits given in SRSP-510. For SRSP-510, mobile stations and hand-held portables are limited to 2 watts maximum e.i.r.p.

According to §27.50(d)(4), fixed, mobile, and portable (hand-held) stations operating in the 1710~1755 Mb band and mobile and portable stations operating in the 1695~1710 Mb and 1755~1780 Mb bands are 1 watt EIRP. The e.i.r.p. for fixed and base stations in the band 1710-1780 Mb shall not exceed one watt(30 dBm e.i.r.p./channel bandwidth).






The diagram below shows the test setup that is utilized to make the measurements for emission from 30 Mz to 1 Gz emissions.
