INTRODUCTION

1.1 Scope

Measurement and determination of electromagnetic emissions (EMC) of radio frequency devices including intentional and/or unintentional radiators for compliance with the technical rules and regulations of the Federal Communications Commission and the Innovation, Science and Economic Development Canada.

1.2 **Element Test Location**

These measurement tests were conducted at the Element Laboratory located at 7185 Oakland Mills Road, Columbia, MD 21046. The measurement facility is compliant with the test site requirements specified in ANSI C63.4-2014.

1.3 **Test Facility / Accreditations**

2.0 PRODUCT INFORMATION

2.1 **Equipment Description**

The Equipment Under Test (EUT) is the Samsung Portable Handset FCC ID: A3LSMS918JPN. The test data contained in this report pertains only to the emissions due to the EUT's licensed transmitters that operate under the provisions of Part 24 and RSS-133.

Test Device Serial No.: 0203M, 0175M, 0179M, 0203M, 0178M

2.2 **Device Capabilities**

This device contains the following capabilities:

850/1900 GSM/GPRS/EDGE, 850 WCDMA/HSPA, Multi-band LTE, Multi-band 5G NR (FR1), 802.11b/g/n/ax WLAN, 802.11a/n/ac/ax UNII (5GHz and 6GHz), Bluetooth (1x, EDR, LE), NFC, UWB, Wireless Power Transfer

This device uses a tuner circuit that dynamically updates the antenna impedance parameters to optimize antenna performance for certain bands and modes of operation. The tuner for this device was set to simulate a "free space" condition where the transmit antenna is matched to the medium into which it is transmitting and, thus, the power is at its maximum level.

2.3 **Test Configuration**

The EUT was tested per the guidance of ANSI C63.26-2015. See Section 7.0 of this test report for a description of the radiated and antenna port conducted emissions tests.

This device supports wireless charging capability and, thus, is subject to the test requirements of KDB 648474 D03 v01r04. Additional radiated spurious emission measurements were performed with the EUT lying flat on an authorized wireless charging pad (WCP) Model: EP-N5100 while operating under normal conditions in a simulated call or data transmission configuration. The worst case radiated emissions data is shown in this report.

2.4 Software and Firmware

Testing was performed on device(s) using software/firmware version S918USQU0AVI3 installed on the EUT.

2.5 **EMI Suppression Device(s)/Modifications**

No EMI suppression device(s) were added and no modifications were made during testing.

DESCRIPTION OF TESTS 3.0

3.1 **Evaluation Procedure**

The measurement procedures described in the "American National Standard for Compliance Testing of Transmitters Used in Licensed Radio Services" (ANSI C63.26-2015) were used in the measurement of the EUT.

Deviation from Measurement Procedure......None

3.2 Radiated Power and Radiated Spurious Emissions

The radiated test facilities consisted of an indoor 3 meter semi-anechoic chamber used for final measurements and exploratory measurements, when necessary. The measurement area is contained within the semi-anechoic chamber which is shielded from any ambient interference. The test site inside the chamber is a 6m x 5.2m elliptical, obstruction-free area in accordance with Figure 5.7 of Clause 5 in ANSI C63.4-2014. Absorbers are arranged on the floor between the turn table and the antenna mast in such a way so as to maximize the reduction of reflections for measurements above 1GHz. For measurements below 1GHz, the absorbers are removed. A raised turntable is used for radiated measurement. The turn table is a continuously rotatable, remote-controlled, metallic turntable and 2 meters (6.56 ft.) in diameter. The turn table is flush with the raised floor of the chamber in order to maintain its function as a ground plane. An 80cm tall test table made of Styrodur is placed on top of the turn table. A Styrodur pedestal is placed on top of the test table to bring the total table height to 1.5m.

The equipment under test was transmitting while connected to its integral antenna and is placed on a turntable 3 meters from the receive antenna. The receive antenna height is adjusted between 1 and 4 meter height, the turntable is rotated through 360 degrees, and the EUT is manipulated through all orthogonal planes representative of its typical use to achieve the highest reading on the receive spectrum analyzer.

For radiated power measurements, substitution method is used per the guidance of ANSI C63.26-2015. For emissions below 1GHz, a half-wave dipole is substituted in place of the EUT. For emissions above 1GHz, a horn antenna is substituted in place of the EUT. The substitute antenna is driven by a signal generator with the level of the signal generator being adjusted to obtain the same receive spectrum analyzer level previously recorded from the spurious emission from the EUT. The power of the emission is calculated using the following formula:

Pd [dBm] = Pg [dBm] - cable loss [dB] + antenna gain [dBd/dBi];

where P_d is the dipole equivalent power, P_d is the generator output into the substitution antenna, and the antenna gain is the gain of the substitute antenna used relative to either a half-wave dipole (dBd) or an isotropic source (dBi). The substitute level is equal to Pq [dBm] - cable loss [dB].

For radiated spurious emissions measurements, the field strength conversion method is used per the formulas in Section 5.2.7 of ANSI C63.26-2015. Field Strength (EIRP) is calculated using the following formulas:

> E[dBµV/m] = Measured amplitude level[dBm] + 107 + Cable Loss[dB] + Antenna Factor[dB/m] $EIRP_{[dBm]} = E_{[dB\mu V/m]} + 20logD - 104.8$; where D is the measurement distance in meters.

All radiated measurements are performed in a chamber that meets the site requirements per ANSI C63.4-2014. Additionally, radiated emissions below 30MHz are also validated on an Open Area Test Site to assert correlation with the chamber measurements per the requirements of KDB 414788 D01 v01r01.

Radiated power and radiated spurious emission levels are investigated with the receive antenna horizontally and vertically polarized per ANSI C63.26-2015.

Spurious Radiated Emission

Example: Spurious emission at 3700.40 MHz

The receive spectrum analyzer reading at 3 meters with the EUT on the turntable was -81.0 dBm. The gain of the substituted antenna is 8.1 dBi. The signal generator connected to the substituted antenna terminals is adjusted to produce a reading of -81.0 dBm on the spectrum analyzer. The loss of the cable between the signal generator and the terminals of the substituted antenna is 2.0 dB at 3700.40 MHz. So 6.1 dB is added to the signal generator reading of -30.9 dBm yielding -24.80 dBm. The fundamental EIRP was 25.50 dBm so this harmonic was 25.50 dBm - (-24.80) = 50.3 dBc.

Notes:

- 1) All modes of operation and data rates were investigated. The test results shown in the following sections represent the worst case emissions.
- 2) The analyzer plots were all taken with a correction table loaded into the analyzer. The correction table was used to account for the losses of the cables, directional couplers, and attenuators used as part of the system to maintain a link between the call box and the EUT at all frequencies of interest.
- 3) All antenna port conducted emissions testing was performed on a test bench with the antenna port of the EUT connected to the spectrum analyzer through calibrated cables, attenuators, and couplers.
- 4) All conducted emissions measurements are performed with automated test software to capture the corresponding plots necessary to show compliance. The measurement software utilized is EMC Software Tool v1.0.

Test Overview

All emissions are measured with a spectrum analyzer connected to the antenna terminal of the EUT while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies. All data rates were investigated to determine the worst-case configuration. All modes of operation were investigated and the worst-case configuration results are reported in this section.

Test Procedure Used

ANSI C63.26-2015 - Section 5.2

Test Settings

- 1. Detector = RMS
- 2. Trace mode = trace average for continuous emissions, max hold for pulse emissions
- 3. Sweep time = auto couple
- 4. The trace was allowed to stabilize
- 5. Please see test notes below for RBW and VBW settings

- 1. Uplink carrier aggregation is only supported in this EUT while operating in Power Class 3.

- 3. All other conducted power measurements are contained in the RF exposure report for this filing.




Plot 7-9. Occupied Bandwidth Plot (LTE Band 2 - 3MHz QPSK - Full RB)




Plot 7-10. Occupied Bandwidth Plot (LTE Band 2 - 3MHz 16-QAM - Full RB)





Plot 7-15. Conducted Spurious Plot (LTE Band 2 - 20MHz QPSK - 1RB - Low Channel)






Plot 7-19. Conducted Spurious Plot (LTE Band 2 - 20MHz QPSK - 1RB - Mid Channel)




Plot 7-20. Conducted Spurious Plot (LTE Band 2 - 20MHz QPSK - 1RB - Mid Channel)




Plot 7-23. Conducted Spurious Plot (LTE Band 2 - 20MHz QPSK - 1RB - High Channel)




Plot 7-24. Conducted Spurious Plot (GPRS Ch. 512)





Plot 7-26. Conducted Spurious Plot (GPRS Ch. 512)




Plot 7-27. Conducted Spurious Plot (GPRS Ch. 661)



Plot 7-28. Conducted Spurious Plot (GPRS Ch. 661)




Plot 7-29. Conducted Spurious Plot (GPRS Ch. 661)



Plot 7-30. Conducted Spurious Plot (GPRS Ch. 810)







Plot 7-33. Lower Band Edge Plot (LTE Band 2 - 20MHz QPSK - Full RB)







Plot 7-39. Upper Band Edge Plot (LTE Band 2 - 15MHz QPSK - Full RB)





Plot 7-43. Upper Band Edge Plot (LTE Band 2 - 10MHz QPSK - Full RB)





Plot 7-45. Lower Band Edge Plot (LTE Band 2 - 5MHz QPSK - Full RB)





Plot 7-47. Upper Band Edge Plot (LTE Band 2 - 5MHz QPSK - Full RB)







Plot 7-51. Upper Band Edge Plot (LTE Band 2 - 3MHz QPSK - Full RB)




Plot 7-52. Extended Upper Band Edge Plot (LTE Band 2 - 3MHz QPSK - Full RB)


Plot 7-53. Lower Band Edge Plot (LTE Band 2 – 1.4MHz QPSK – Full RB)




Plot 7-54. Extended Lower Band Edge Plot (LTE Band 2 – 1.4MHz QPSK – Full RB)

Plot 7-55. Upper Band Edge Plot (LTE Band 2 – 1.4MHz QPSK – Full RB)




Plot 7-56. Extended Upper Band Edge Plot (LTE Band 2 – 1.4MHz QPSK – Full RB)



7.6 Peak-Average Ratio

Test Overview

A peak to average ratio measurement is performed at the conducted port of the EUT. The spectrum analyzers Complementary Cumulative Distribution Function (CCDF) measurement profile is used to determine the largest deviation between the average and the peak power of the EUT in a given bandwidth. The CCDF curve shows how much time the peak waveform spends at or above a given average power level. The percent of time the signal spends at or above the level defines the probability for that particular power level.

The peak-to-average power ratio (PAPR) of the transmitter output power must not exceed 13 dB.

Figure 7-5. Test Instrument & Measurement Setup






Plot 7-59. PAR Plot (LTE Band 2 - 20MHz QPSK - Full RB)




Plot 7-60. PAR Plot (LTE Band 2 - 20MHz 256-QAM - Full RB)


Plot 7-61. PAR Plot (LTE Band 2 - 15MHz QPSK - Full RB)




Plot 7-62. PAR Plot (LTE Band 2 - 15MHz 256-QAM - Full RB)


Plot 7-63. PAR Plot (LTE Band 2 - 10MHz QPSK - Full RB)




Plot 7-64. PAR Plot (LTE Band 2 - 10MHz 256-QAM - Full RB)

Plot 7-66. PAR Plot (LTE Band 2 - 5MHz 256-QAM - Full RB)






Plot 7-67. PAR Plot (LTE Band 2 - 3MHz QPSK - Full RB)




Plot 7-68. PAR Plot (LTE Band 2 - 3MHz 256-QAM - Full RB)

Plot 7-69. PAR Plot (LTE Band 2 - 1.4MHz QPSK - Full RB)




Plot 7-70. PAR Plot (LTE Band 2 - 1.4MHz 256-QAM - Full RB)



7.7 Radiated Power (EIRP)

Test Overview

Equivalent Isotropic Radiated Power (EIRP) measurements are performed using the substitution method described in ANSI C63.26-2015 with the EUT transmitting into an integral antenna. Measurements are performed using vertically and horizontally polarized broadband horn antennas. All measurements are performed as RMS average measurements while the EUT is operating at maximum power, and at the appropriate frequencies.

Test Procedures Used

- 1. Radiated power measurements are performed using the signal analyzer's "channel power" measurement capability for signals with continuous operation. For signals with burst transmission, the signal analyzer's "time domain power" measurement capability is used

- 3. VBW \geq 3 x RBW
- 4. Span = 1.5 times the OBW
- 5. No. of sweep points > 2 x span / RBW
- 6. Detector = RMS
- 7. Trigger is set to "free run" for signals with continuous operation with the sweep times set to "auto". Trigger is set to enable triggering only on full power bursts with the sweep time set less than or equal to the transmission burst duration.




Figure 7-6. Radiated Test Setup >1GHz




Figure 7-7. Test Instrument & Measurement Setup < 1GHz




Figure 7-8. Test Instrument & Measurement Setup >1 GHz









Frequency Stability / Temperature Variation

Test Overview and Limit

Frequency stability testing is performed in accordance with the guidelines of ANSI C63.26-2015. The frequency stability of the transmitter is measured by:

- a.) Temperature: The temperature is varied from -30°C to +50°C in 10°C increments using an environmental chamber.
- **Primary Supply Voltage:** The primary supply voltage is varied from 85% to 115% of the nominal value for b.) non hand-carried battery and AC powered equipment. For hand-carried, battery-powered equipment, primary supply voltage is reduced to the battery operating end point which shall be specified by the manufacturer.

For Part 24, the frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block.

Test Procedure Used

ANSI C63.26-2015 - Section 5.6

Test Settings

- 1. The carrier frequency of the transmitter is measured at room temperature (20°C to provide a reference).
- 2. The equipment is turned on in a "standby" condition for fifteen minutes before applying power to the transmitter. Measurement of the carrier frequency of the transmitter is made within one minute after applying power to the transmitter.
- 3. Frequency measurements are made at 10°C intervals ranging from -30°C to +50°C. A period of at least one half-hour is provided to allow stabilization of the equipment at each temperature level.




Plot 7-77. LTE Band 2 Frequency Stability Chart
