





Uncertainty of Frequency Response of E-field: $\pm 6.3\%$ ($k=2$)

f=600 MHz,TEM





f=1800 MHz,R22




Uncertainty of Axial Isotropy Assessment: $\pm 0.5\%$ ($k=2$)


Uncertainty of Linearity Assessment: $\pm 0.6\%$ ($k=2$)





- ConvF and Boundary Effect Parameters**: Assessed in flat phantom using E-field (or Temperature Transfer Standard for $f \leq 800$ MHz) and inside waveguide using analytical field distributions based on power measurements for $f > 800$ MHz. The same setups are used for assessment of the parameters applied for boundary compensation (alpha, depth) of which typical uncertainty values are given. These parameters are used in DASY4 software to improve probe accuracy close to the boundary. The sensitivity in TSL corresponds to NORM_{x,y,z} * ConvF whereby the uncertainty corresponds to that given for *ConvF*. - Spherical isotropy (3D deviation from isotropy)**: in a field of low gradients realized using a flat phantom exposed by a patch antenna.
- Sensor Offset**: The sensor offset corresponds to the offset of virtual measurement center from the probe tip (on probe axis). No tolerance required.
- Connector Angle**: The angle is assessed using the information gained by determining the NORM_x (no uncertainty required).







Uncertainty of Frequency Response of E-field: $\pm 6.3\%$ ($k=2$)

f=600 MHz, TEM





f=1800 MHz, R22




Uncertainty of Axial Isotropy Assessment: $\pm 0.5\%$ ($k=2$)

(TEM cell , f_{eval}= 1900 MHz)





Uncertainty of Linearity Assessment: ± 0.6% (k=2)
