



Plot 7-93. Conducted Spurious Plot SISO ANT1 (802.11b - Ch. 6)

Plot 7-95. Conducted Spurious Plot SISO ANT1 (802.11b - Ch. 11)




Plot 7-96. Conducted Spurious Plot SISO ANT1 (802.11b - Ch. 11)

Plot 7-97. Conducted Spurious Plot SISO ANT2 (802.11b - Ch. 1)




Plot 7-98. Conducted Spurious Plot SISO ANT2 (802.11b - Ch. 1)




Plot 7-99. Conducted Spurious Plot SISO ANT2 (802.11b - Ch. 6)




Plot 7-100. Conducted Spurious Plot SISO ANT2 (802.11b - Ch. 6)

Test Overview and Limit

All out of band radiated spurious emissions are measured with a spectrum analyzer connected to a receive antenna while the EUT is operating at its maximum duty cycle, at maximum power, and at the appropriate frequencies. All data rates and modes were investigated for radiated spurious emissions. Only the radiated emissions of the configuration that produced the worst case emissions are reported in this section.

All out of band emissions appearing in a restricted band as specified in Section 15.205 of the Title 47 CFR and Table 6 of RSS-Gen (8.10) must not exceed the limits shown in Table 7-14 per Section 15.209 and RSS-Gen (8.9).

The EUT and measurement equipment were set up as shown in the diagram below.




Figure 7-6. Test Instrument & Measurement Setup

Test Notes

- 1. The optional test procedures for antenna port conducted measurements of unwanted emissions per the guidance of KDB 558074 D01 v05r02 were not used to evaluate this device for compliance to radiated limits. All radiated spurious emissions levels were measured in a radiated test setup.
- 2. All emissions lying in restricted bands specified in Section 15.205 and Section 8.10 of RSS-Gen are below the limit shown in Table 7-14.
- 3. The antenna is manipulated through typical positions, polarity and length during the tests. The EUT is manipulated through three orthogonal planes.
- 4. This unit was tested with its standard battery.
- 5. The spectrum is measured from 9kHz to the 10th harmonic of the fundamental frequency of the transmitter using CISPR quasi peak detector below 1GHz. Above 1 GHz, average and peak measurements were taken using linearly polarized horn antennas. The worst-case emissions are reported however emissions whose levels were not within 20dB of the respective limits were not reported.
- 6. Emissions below 18GHz were measured at a 3 meter test distance while emissions above 18GHz were measured at a 1 meter test distance with the application of a distance correction factor.
- 7. Radiated spurious emissions were investigated while operating in MIMO mode, however, it was determined that single antenna operation produced the worst case emissions. Since the emissions produced from MIMO operation were found to be more than 20dB below the limit, the MIMO emissions are not reported.







Plot 7-104. Radiated Spurious Plot above 1GHz SISO ANT1 (802.11b - Ch. 6)




Plot 7-105. Radiated Spurious Plot above 1GHz SISO ANT1 (802.11b - Ch. 11)







Plot 7-108. Radiated Spurious Plot above 1GHz SISO ANT2 (802.11b - Ch. 6)




Plot 7-109. Radiated Spurious Plot above 1GHz SISO ANT2 (802.11b - Ch. 11)







Plot 7-112. Radiated Spurious Plot above 1GHz MIMO/CDD (802.11g - Ch. 6)




Plot 7-113. Radiated Spurious Plot above 1GHz MIMO/CDD (802.11g - Ch. 11)




Plot 7-115. Radiated Restricted Lower Band Edge Measurement SISO ANT1 (Average)

Plot 7-120. Radiated Restricted Upper Band Edge Measurement SISO ANT1 (Peak)




Plot 7-121. Radiated Restricted Lower Band Edge Measurement SISO ANT1 (Average)




Plot 7-122. Radiated Restricted Lower Band Edge Measurement SISO ANT1 (Peak)

Plot 7-123. Radiated Restricted Upper Band Edge Measurement SISO ANT2 (Average)




Plot 7-124. Radiated Restricted Upper Band Edge Measurement SISO ANT2 (Peak)












Plot 7-135. Radiated Restricted Lower Band Edge Measurement MIMO (Average)




Plot 7-136. Radiated Restricted Lower Band Edge Measurement MIMO (Peak)

Plot 7-137. Radiated Restricted Lower Band Edge Measurement MIMO (Average)




Plot 7-138. Radiated Restricted Lower Band Edge Measurement MIMO (Peak)



Plot 7-139. Radiated Restricted Upper Band Edge Measurement MIMO (Average)




Plot 7-140. Radiated Restricted Upper Band Edge Measurement MIMO (Peak)




Figure 7-7. Radiated Test Setup < 30Mhz




Figure 7-8. Radiated Test Setup < 1GHz







Figure 7-9. Test Instrument & Measurement Setup


