


Plot 7-85. Radiated Spurious Plot above 1GHz (BT- Ch. 78) - Ant1















Plot 7-89. Radiated Spurious Plot above 1GHz (BT- Ch. 78) - Ant2








Plot 7-91. Radiated Restricted Upper Band Edge Measurement (Average) – Ant1














Plot 7-94. Radiated Restricted Upper Band Edge Measurement (Peak) – Ant2





Figure 7-10. Radiated Test Setup < 30Mhz





- 2. The broadband receive antenna is manipulated through vertical and horizontal polarizations during the tests. The EUT is manipulated through three orthogonal planes.
- 3. This unit was tested with its standard battery.
- 4. The spectrum is investigated using a peak detector and final measurements are recorded using CISPR quasi peak detector. The worst-case emissions are reported however emissions whose levels were not within 20dB of the respective limits were not reported.
- 5. Emissions were measured at a 3 meter test distance.
- 6. Emissions are investigated while operating on the center channel of the mode, band, and modulation that produced the worst case results during the transmitter spurious emissions testing.
- 7. No spurious emissions were detected within 20dB of the limit below 30MHz.
- 8. The results recorded using the broadband antenna is known to correlate with the results obtained by using a tuned dipole with an acceptable degree of accuracy. The VSWR for the measurement antenna was found to be less than 2:1.
- The wide spectrum spurious emissions plots shown on the following pages are used only for the purpose of emission identification. There were no emissions detected in the 30MHz – 1GHz frequency range, as shown in the subsequent plots.







Figure 7-12. Test Instrument & Measurement Setup


