4. TEST METHODOLOGY

Generally the tests were performed according to the KDB789033 D02 v01. And ANSI C63.10-2009 was used to reference appropriate EUT setup and maximizing procedures of radiated spurious emission and AC line conducted

emission testing

4.1 EUT configuration

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement

and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

4.2 EUT exercise

The EUT was operated in the test mode to fix the Tx frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209 and 15.407

under the FCC Rules Part 15 Subpart C.

4.3 General test procedures

Conducted Emissions

The power-line conducted emission test procedure is not described on the KDB789033 D02 v01. So this test was

fulfilled with the requirements in Section 6.2 of ANSI C63.10-2009.

The EUT is placed on the table, which is 0.8 m above ground plane and the conducted emissions from the EUT

measured in the frequency range between 0.15MHz and 30MHz using CISPR Quasi-peak and Average detector.

Radiated Emissions

Basically the radiated tests were performed with KDB789033 D02 v01. But some requirements and procedures like test

site requirements, EUT setup and maximizing procedure were fulfilled with the requirements in Section 5 and 6 of the

ANSI C63.10-2009 as stated on KDB789033 D02 v01.

The EUT is placed on a non-conductive table, which is 0.8 m above ground plane. The turntable shall rotate 360

degrees to determine the position of maximum emission level. EUT is set 3 m away from the receiving antenna, which

varied from 1 m to 4 m to find out the highest emission. And also, each emission was to be maximized by changing the

polarization of receiving antenna both horizontal and vertical. In order to find out the highest emission, the relative

positions of the EUT were rotated through three orthogonal axis.

4.4 Description of test modes

A test program is used to control the EUT for staying in continuous transmitting mode with maximum fixed duty cycle.

5. INSTRUMENT CALIBRATION

The measuring equipment, which was utilized in performing the tests documented herein, has been calibrated in accordance with the manufacturer's recommendations for utilizing calibration equipments, which is traceable to recognized national standards.

6. FACILITIES AND ACCREDITATIONS

6.1 Facilities

The open area test site(OATS) or semi anechoic chamber and conducted measurement facility used to collect the radiated and conducted test data are located at the 42, Yurim-ro, 154beon-gil, Cheoin-gu, Yongin-si, Gyeonggi-do, Korea 449-935. The site is constructed in conformance with the requirements.

6.2 Equipment

Radiated emissions are measured with one or more of the following types of Linearly polarized antennas: tuned dipole, bi-conical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with pre-selectors and peak, quasi-peak detectors are used to perform radiated measurements. Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers. Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements. All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

7. ANTENNA REQUIREMENTS

7.1 According to FCC 47 CFR §15.203:

An intentional radiator antenna shall be designed to ensure that no antenna other than that furnished by the responsible party can be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

The internal antenna of this E.U.T is permanently attached on the main PCB.(Refer to Internal Photo.) Therefore this module Complies with the requirement of §15.203

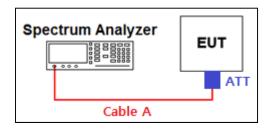
8. TEST RESULT

8.1 Emission Bandwidth (26 dB Bandwidth)

■ Test Requirements

The bandwidth at 26 dB down from the highest in-band spectral density is measured with a spectrum analyzer connected to the antenna terminal while the EUT is operating in transmission mode at the appropriate frequencies. The 26dB bandwidth is used to determine the conducted output power limit.

■ Test Configuration



■ Test Procedure

The transmitter output is connected to the Spectrum Analyzer and used following test procedure of KDB789033 D02 V01.

- 1. Set resolution bandwidth (RBW) = approximately 1 % of the EBW.
- 2. Set the video bandwidth (VBW) > RBW.
- 3. Detector = Peak.
- 4. Trace mode = max hold.

Measure the maximum width of the emission that is 26 dB down from the peak of the emission. Compare this with the RBW setting of the analyzer. Readjust RBW and repeat measurement as needed until the RBW/EBW ratio is approximately 1%.

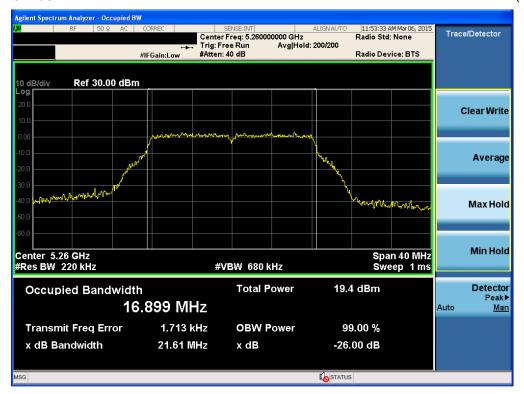

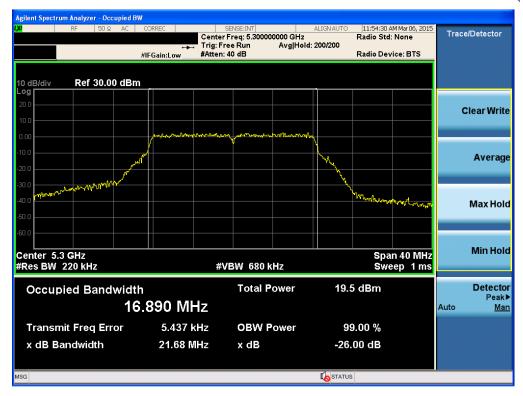

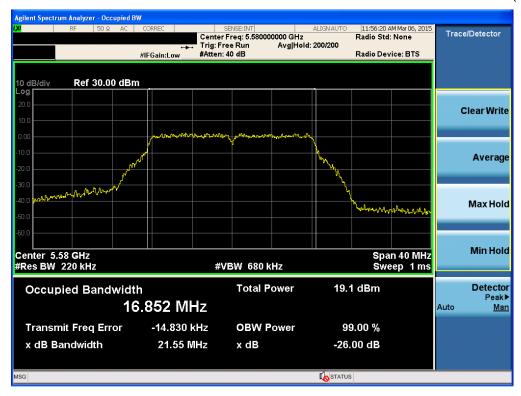

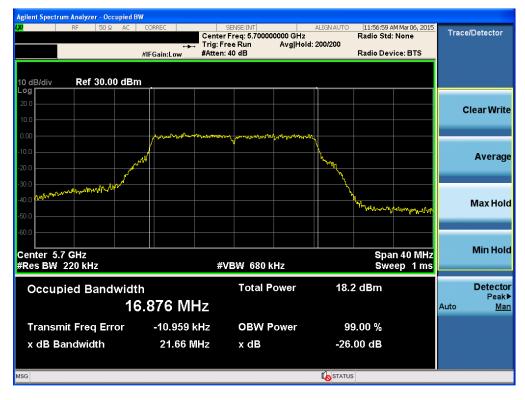

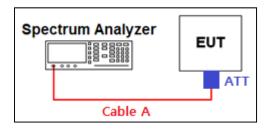

- 2. Set the video bandwidth ≥ 3 x RBW.

- 4. Trace mode = max hold.

Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.

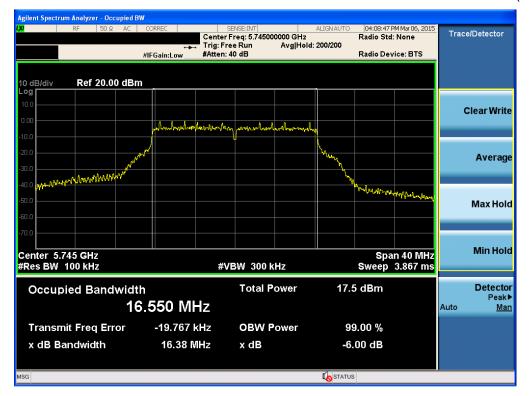

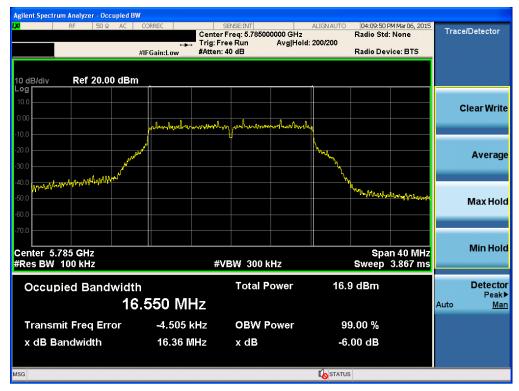

Test Mode: 802.11a & Ch.149 & SISO(ANT 2)



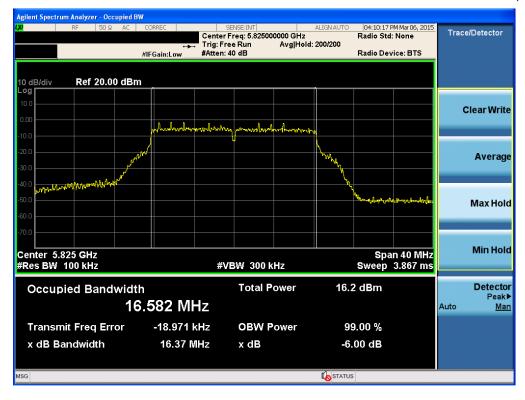

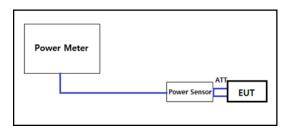

- (i) For an outdoor access point operating in the band 5.15-5.25 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W provided the maximum antenna gain does not exceed 6 dBi. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi. The maximum e.i.r.p. at any elevation angle above 30 degrees as measured from the horizon must not exceed 125 mW (21 dBm).
- (ii) For an indoor access point operating in the band 5.15-5.25 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W provided the maximum antenna gain does not exceed 6 dBi. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.
- (iii) For fixed point-to-point access points operating in the band 5.15-5.25 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W. Fixed point-to-point U-NII devices may employ antennas with directional gain up to 23 dBi without any corresponding reduction in the maximum conducted output power or maximum power spectral density. For fixed point-to-point transmitters that employ a directional antenna gain greater than 23 dBi, a 1 dB reduction in maximum conducted output power and maximum power spectral density is required for each 1 dB of antenna gain in excess of 23 dBi. Fixed, point-to-point operations exclude the use of point-to-multipoint systems, omnidirectional applications, and multiple collocated transmitters transmitting the same information. The operator of the U-NII device, or if the equipment is professionally installed, the installer, is responsible for ensuring that systems employing high gain directional antennas are used exclusively for fixed, point-to-point operations.
- (iv) For mobile and portable client devices in the 5.15-5.25 GHz band, the maximum conducted output power over the frequency band of operation shall not exceed 250 mW provided the maximum antenna gain does not exceed 6 dBi. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.
- (2) For the 5.25-5.35 GHz and 5.47-5.725 GHz bands, the maximum conducted output power over the frequency bands of operation shall not exceed the lesser of 250 mW or 11 dBm + 10 log B, where B is the 26 dB emission bandwidth in megahertz. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

Measurements may be performed using a wideband gated RF power meter provided that the gate parameters are adjusted such that the power is measured only when the EUT is transmitting at its maximum power control level. Since the measurement is made only during the ON time of the transmitter, no duty cycle correction factor is required.

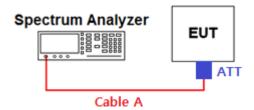

(This procedure is required even if the maximum conducted output power measurement was performed using a power meter, method PM.)

- 2) Use the peak search function on the instrument to find the peak of the spectrum and record its value.
- 3) Make the following adjustments to the peak value of the spectrum, if applicable:

a) If Method SA-2 or SA-2 Alternative was used, add 10 log(1/x), where x is the duty cycle, to the peak of the spectrum.

- b) If Method SA-3 Alternative was used and the linear mode was used in step II.E.2.g)(viii), add 1 dB to the final result to compensate for the difference between linear averaging and power averaging.
- 4) The result is the Maximum PSD over 1 MHz reference bandwidth.
- 5) For devices operating in the bands 5.15-5.25 GHz, 5.25-5.35 GHz, and 5.47-5.725 GHz, the above procedures make use of 1 MHz RBW to satisfy directly the 1 MHz reference bandwidth specified in §15.407(a)(5). For devices operating in the band 5.725-5.85 GHz, the rules specify a measurement bandwidth of 500 kHz. Many spectrum analyzers do not have 500 kHz RBW, thus a narrower RBW may need to be used. The rules permit the use of a RBWs less than 1 MHz, or 500 kHz, "provided that the measured power is integrated over the full reference bandwidth" to show the total power over the specified measurement bandwidth (i.e., 1 MHz, or 500 kHz). If measurements are performed using a reduced resolution bandwidth (< 1 MHz, or < 500 kHz) and integrated over 1 MHz, or 500 kHz bandwidth, the following adjustments to the procedures apply:
 - a) Set RBW ≥ 1/T, where T is defined in section II.B.1.a). (Refer to Appendix II)
 - b) Set VBW ≥ 3 RBW.
 - c) If measurement bandwidth of Maximum PSD is specified in 500 kHz, add 10log(500kHz/RBW) to the measured result, whereas RBW (< 500 kHz) is the reduced resolution bandwidth of the spectrum analyzer set during measurement.
 - d) If measurement bandwidth of Maximum PSD is specified in 1 MHz, add 10log(1MHz/RBW) to the measured result, whereas RBW (< 1 MHz) is the reduced resolution bandwidth of spectrum analyzer set during measurement.
 - e) Care must be taken to ensure that the measurements are performed during a period of continuous transmission or are corrected upward for duty cycle.

Note: As a practical matter, it is recommended to use reduced RBW of 100 kHz for the sections 5.c) and 5.d) above, since RBW=100 kHz is available on nearly all spectrum analyzers.

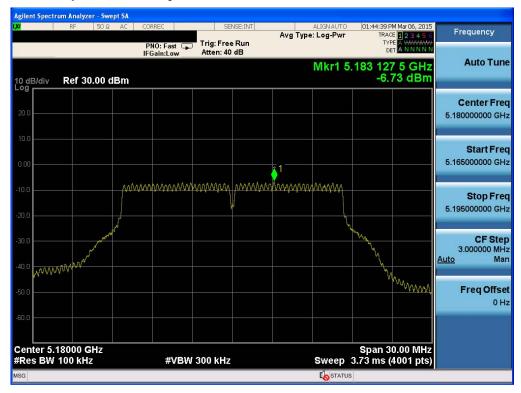

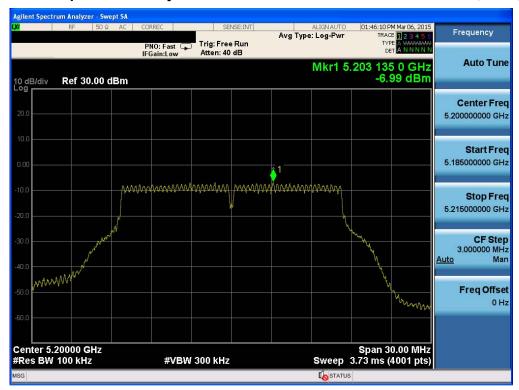

Test Mode: 802.11a & Ch.36 & SISO(ANT 2)



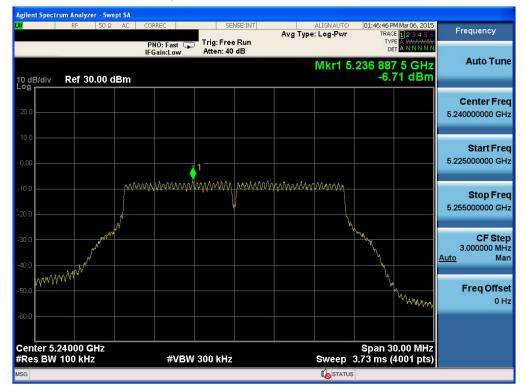

Test Mode: 802.11a & Ch.40 & SISO(ANT 2)

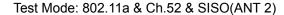


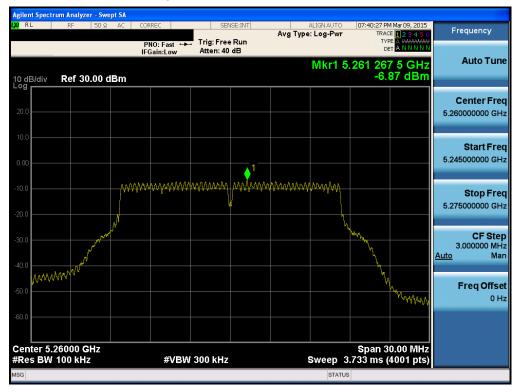

8.5 Frequency Stability

■ Test requirements

Manufacturers of U-NII devices are responsible for ensuring frequency stability such that an emission is maintained within the band of operation under all conditions of normal operation as specified in the user's manual.

■ Test Procedure

The EUT was placed inside of an environmental chamber as the temperature in the chamber was varied between -30 $^{\circ}$ C and +50 $^{\circ}$ C. The temperature was incremented by 10 $^{\circ}$ C intervals and the unit was allowed to stabilize at each measurement. The center frequency of the transmitting channel was evaluated at each temperature and the frequency deviation from the channel's center frequency was recorded.

■ Test Results: Note Tested

This test item was performed at the worst case mode for original grant. Therefore this test item is not performed for this class II permissive change.

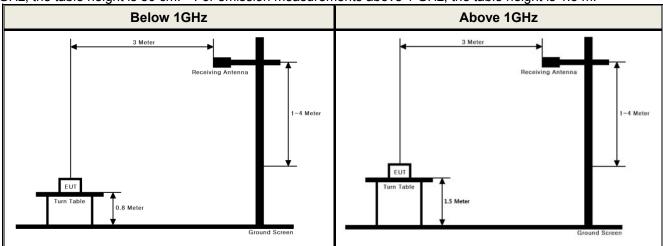

- FCC Part 15.205(b): The field strength of emissions appearing within these frequency bands shall not exceed the limits shown in §15.209.  - (2) For transmitters operating in the 5.25-5.35 GHz band: all emissions outside of the 5.15-5.35 GHz band shall not exceed an EIRP of -27 dBm/MHz.
 - (3) For transmitters operating in the **5.47-5.725 GHz band**: all emissions outside of the **5.47-5.725 GHz band** shall not exceed an **EIRP of -27 dBm/MHz**.
 - (4) For transmitters operating in the **5.725-5.85 GHz band**: All emissions within the frequency range from the band edge to 10 MHz above or below the band edge shall not exceed an e.i.r.p. of −17 dBm/MHz; for frequencies 10 MHz or greater above or below the band edge, emissions shall not exceed an e.i.r.p. of −27 dBm/MHz.
 - (5) The emission measurements shall be performed using a minimum resolution bandwidth of 1 MHz. A lower resolution bandwidth may be employed near the band edge, when necessary, provided the measured energy is integrated to show the total power over 1 MHz.
 - (6) Unwanted emissions below 1 GHz must comply with the general field strength limits set forth in Section 15.209. Further, any U-NII devices using an AC power line are required to comply also with the conducted limits set forth in Section 15.207
 - (7) The provisions of §15.205 apply to intentional radiators operating under this section
 - (8) When measuring the emission limits, the nominal carrier frequency shall be adjusted as close to the upper and lower frequency band edges as the design of the equipment permits.

Test Procedure

The EUT was placed on a non-conductive table inside a shielded enclosure. For emission measurements at or below 1 GHz, the table height is 80 cm. For emission measurements above 1 GHz, the table height is 1.5 m.



An antenna was placed near the EUT and measurements of frequencies and amplitudes of field strengths were recorded for reference during final measurements. For final radiated testing, measurements were performed in semi anechoic chamber. Measurements were performed with the EUT oriented in 3 orthogonal axis and rotated 360 degrees to determine the worst-case orientation for maximum emissions.

► General Requirements for Unwanted Emissions Measurements

The following requirements apply to all unwanted emissions measurements, both in and outside of the restricted bands:

- EUT Duty Cycle
 - (1) The EUT shall be configured or modified to **transmit continuously** except as stated in (ii), below. The intent is to test at 100 percent duty cycle; however a small reduction in duty cycle(**to no lower than 98 percent**) is permitted if required by the EUT for amplitude control purposes. Manufacturers are expected to provide software to the test lab to permit such continuous operation.
 - (2) If **continuous transmission (or at least 98 percent duty cycle) cannot be achieved** due to hardware limitations of the EUT (e.g., overheating), the following additions to the measurement and reporting procedures are required:
 - The EUT shall be configured to operate at the maximum achievable duty cycle.
 - Measure the duty cycle, x, of the transmitter output signal.
 - Adjustments to measurement procedures (e.g., increasing test time and number of traces averaged) shall be performed as described in the procedures below.
 - The test report shall include the following additional information:
 - The reason for the duty cycle limitation.
 - \circ The duty cycle achieved for testing and the associated transmit duration and interval between transmissions.
 - The sweep time and the amount of time used for trace stabilization during max-hold measurements for peak emission measurements.
 - (3) Reduction of the measured emission amplitude levels to account for operational duty factor is not permitted. Compliance is based on emission levels occurring during transmission not on an average across on and off times of the transmitter.

► Measurements below 1000 MHz

- a) Follow the requirements in section II.G.3, "General Requirements for Unwanted Emissions Measurements".
- b) Compliance shall be demonstrated using CISPR quasi-peak detection; however, peak detection is permitted as an alternative to quasi-peak detection.

► Measurements Above 1000MHz(Peak)

a) Follow the requirements in section II.G.3, "General Requirements for Unwanted Emissions Measurements".

- b) Peak emission levels are measured by setting the analyzer as follows:
 - (i) RBW = 1 MHz.
 - (ii) VBW ≥ 3 MHz.
 - (iii) Detector = Peak.
 - (iv) Sweep time = auto.
 - (v) Trace mode = max hold.
 - (vi) Allow sweeps to continue until the trace stabilizes. Note that if the transmission is not continuous, the time required for the trace to stabilize will increase by a factor of approximately 1/x, where x is the duty cycle. For example, at 50 percent duty cycle, the measurement time will increase by a factor of two relative to measurement time for continuous transmission.

► Measurements Above 1000MHz(Method AD)

- (i) RBW = 1 MHz.
- (ii) VBW ≥ 3 MHz.
- (iii) **Detector = RMS**, if span/(# of points in sweep) ≤ RBW/2. Satisfying this condition may require increasing the number of points in the sweep or reducing the span. If the condition is not satisfied, the detector mode shall be set to peak.
- (iv) Averaging type = power (i.e., RMS)
 - As an alternative, the detector and averaging type may be set for linear voltage averaging.
 Some analyzers require linear display mode in order to use linear voltage averaging. Log or dB averaging shall not be used.
- (v) Sweep time = auto.
- (vi) Perform a trace average of at least 100 traces if the transmission is continuous. If the transmission is not continuous, the number of traces shall be increased by a factor of 1/x, where x is the duty cycle. For example, with 50 percent duty cycle, at least 200 traces shall be averaged.
- (vii) If tests are performed with the EUT transmitting at a duty cycle less than 98 percent, a correction factor shall be added to the measurement results prior to comparing to the emission limit in order to compute the emission level that would have been measured had the test been performed at 100 percent duty cycle. The correction factor is computed as follows:
- If power averaging (RMS) mode was used in step (iv) above, the correction factor is 10 log(1/x), where x is the duty cycle.

For example, if the transmit duty cycle was 50 percent, then 3 dB must be added to the measured emission levels.

- If linear voltage averaging mode was used in step (iv) above, the correction factor is 20 log(1/x), where x is the duty cycle. For example, if the transmit duty cycle was 50 percent, then 6 dB must be added to the measured emission levels.
- If a specific emission is demonstrated to be continuous (100 percent duty cycle) rather than turning on and off with the transmit cycle, no duty cycle correction is required for that emission.

8.7 AC Conducted Emissions

APPENDIX I

Duty Cycle Information

■ Test Procedure

Duty Cycle [X = On Time / (On + Off time)] is measured using Measurement Procedure of KDB789033 D02 V01

- 1. Set the center frequency of the spectrum analyzer to the center frequency of the transmission.
- 2. Set RBW ≥ EBW if possible; otherwise, set RBW to the largest available value.
- 3. Set VBW ≥ RBW. Set detector = peak.
- 4. Note: The zero-span measurement method shall not be used unless both **RBW and VBW are> 50/T**, where *T* is defined in section II.B.1.a), and **the number of sweep points across duration** *T* **exceeds 100**. (For example, if VBW and/or RBW are limited to 3 MHz, then the zero-span method of measuring duty cycle shall not be used if *T* ≤ 16.7 microseconds.)
 - T: The minimum transmission duration over which the transmitter is on and is transmitting at its maximum power control level for the tested mode of operation.
 - (**T = On time** of the above table since the EUT operates with above fixed Duty Cycle and it is the minimum On time)

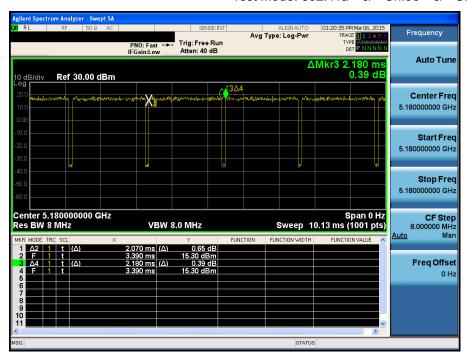

The DFS testing at high channel of UNII band I is not required because the measured 99% bandwidth is within 5250MHz.
