GENERAL INFORMATION

Product Description for Equipment under Test (EUT)

The *DDM Brands LLC*'s product, model number: *CC40007(FCC ID: A4JC40)* or the "EUT" in this report was a *3G Mobile phone*, which was measured approximately: 107.4 mm (L) ×46.0mm (W) × 14.4mm (H), rated with input voltage: DC 3.7V rechargeable Li-ion battery or DC 5.0V from adapter. The highest operating frequency is 2480MHz.

Note: The series product, model C40, CC40 and CC40007, they are electrically identical and the difference between them is only the model number. Model CC40007was selected for fully testing, which was explained in the attached product similarity declaration letter.

Objective

This test report is prepared on behalf of *DDM Brands LLC* in accordance with Part 2-Subpart J, Part 15-Subparts A and B of the Federal Communication Commissions rules.

The objective of the manufacturer is to determine the compliance of the EUT with FCC Part 15 B.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.4-2014, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.81 dB for 30MHz-1GHz, and 4.88 dB for above 1GHz, 1.95dB for conducted measurement.









The radiated emission tests were performed in the 3 meters chamber test site, using the setup accordance with the ANSI C63.4-2014. The specification used was the FCC Part 15.109 Class B limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The spacing between the peripherals was 10 cm.

The system was investigated from 30 MHz to 12.4 GHz.
