The only difference is the number of SIM card, GO20 is double cards and GO20C is single card. The model GO20 was selected to fully test. Objective

This test report is prepared on behalf of *DDM Brands LLC* in accordance with Part 2-Subpart J, Part 22-Subpart H and Part 24-Subpart E of the Federal Communication Commissions rules.

The objective is to determine the compliance of the EUT with FCC rules for output power, modulation characteristic, occupied bandwidth, and spurious emission at antenna terminal, spurious radiated emission, frequency stability and band edge.

Test Methodology

All radiated and conducted emissions measurements were performed at Bay Area Compliance Laboratories Corp. The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is $5.91~\mathrm{dB}$ for $30\mathrm{MHz}$ - $1\mathrm{GHz}$. and $4.92~\mathrm{dB}$ for above $1\mathrm{GHz}$, $1.95\mathrm{dB}$ for conducted measurement.




99% Occupied Bandwidth &26 dB Emissions Bandwidth for GSM Mode






Cellular Band (Part 22H)






1 GHz – 2 GHz (GSM Mode)

Test Procedure

The transmitter was placed on a wooden turntable, and it was transmitting into a non-radiating load which was also placed on the turntable.

The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the receiving antenna height and polarization as well as EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. The test was performed by placing the EUT on 3-orthogonal axis.

The frequency range up to tenth harmonic of the fundamental frequency was investigated.

Remove the EUT and replace it with substitution antenna. A signal generator was connected to the substitution antenna by a non-radiating cable. The absolute levels of the spurious emissions were measured by the substitution.

Spurious emissions in $dB = 10 \lg (TXpwr in Watts/0.001)$ – the absolute level

Spurious attenuation limit in $dB = 43 + 10 \text{ Log}_{10}$ (power out in Watts)






Cellular Band, Left Band Edge for GSM Mode






PCS Band, Left Band Edge for GSM Mode


