- 9. keep a record of all complaints that have been made known to Google relating to the product's compliance with requirements of the relevant standard and to make these records available to BV CPS Taoyuan Branch when requested;
- 10. take appropriate action with respect to such complaints and any deficiencies found in products or services that affect compliance with the requirements for certification; and
- 11. document the actions taken.
