The NFC test is performed with app "adb" installed in the mobile phone. It can enable continuous transmission with type A/B/F/V tag respectively.

The EUT pre-scanned in reader mode with NFC tag (four NFC type A, B, F, V) and without reading tag. Based on the highest field strength of fundamental and spurious emissions, the worst case type (type F) was recorded in this report.

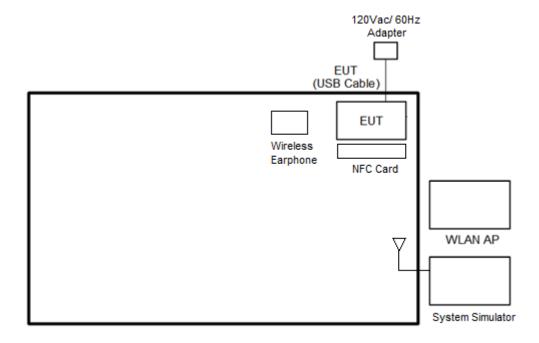
The measured emission level of the EUT was maximized by rotating the EUT on a turntable, adjusting the orientation of the EUT and EUT antenna in three orthogonal axis (X: flat, Y: portrait, Z: landscape), and three receiving antenna orientations (parallel, perpendicular, and ground-parallel) for Loop Antenna and adjusting the measurement antenna orientation, following C63.10 exploratory test procedures and find X Plane without tag as worst plane.

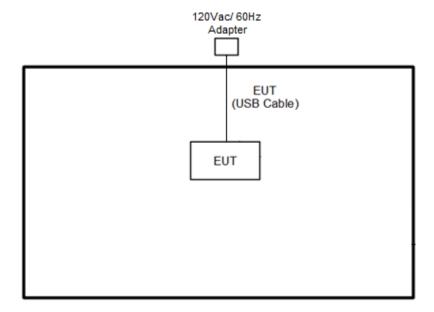

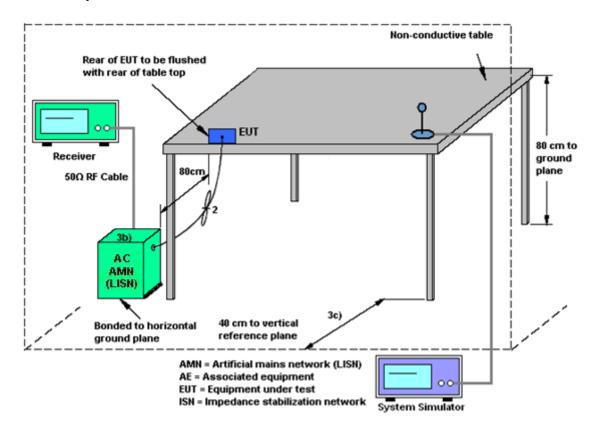

#### 3.1.3 Test Procedures

- 1. The EUT is placed 0.4 meter away from the conducting wall of the shielding room, and is kept at least 80 centimeters from any other grounded conducting surface.
- 2. Connect EUT to the power mains through a line impedance stabilization network (LISN).
- 3. All the support units are connecting to the other LISN.
- 4. The LISN provides 50 ohm coupling impedance for the measuring instrument.
- 5. The FCC states that a 50 ohm, 50 microhenry LISN shall be used.
- 6. Both Line and Neutral shall be tested in order to find out the maximum conducted emission.
- 7. The frequency range from 150 kHz to 30 MHz is scanned.
- Set the test-receiver system to Peak Detect Function and specified bandwidth (IF Bandwidth = 9 kHz) with Maximum Hold Mode. Then measurement is also conducted by Average Detector and Quasi-Peak Detector Function respectively.

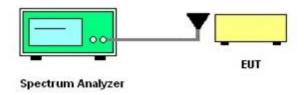

## 3.3 Frequency Stability Measurement

#### 3.3.1 Limit

The frequency tolerance of the carrier signal shall be maintained within +/- 0.01% (100ppm) of the operating frequency over a temperature variation of -20 degrees to +50 degrees C at normal supply voltage, and for a variation in the primary supply voltage from 85% to 115% of the rated supply voltage at a temperature of 20 degrees C. 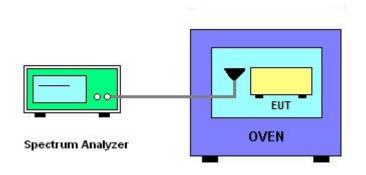

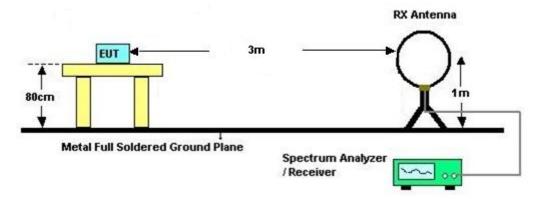

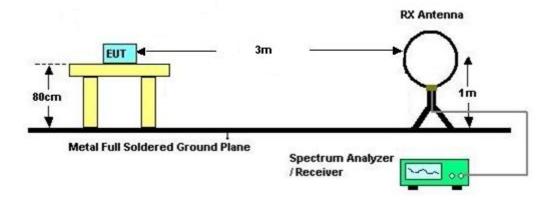

- The height of the broadband receiving antenna is varied between one meter and four meters above ground to find the maximum emissions field strength of both horizontal and vertical polarization.
- 4. For each suspected emissions, the antenna tower is scanned (from 1 M to 4 M) and then the turntable is rotated (from 0 degree to 360 degrees) to find the maximum reading.
- Set the test-receiver system to Peak or CISPR quasi-peak Detect Function with specified bandwidth under Maximum Hold Mode.
- 6. When the radiated emissions limits are expressed in terms of the average value of the emissions, and pulsed operation is employed, the measurement field strength shall be determined by averaging over one complete pulse train, including blanking intervals, as long as the pulse train does not exceed 0.1 seconds. 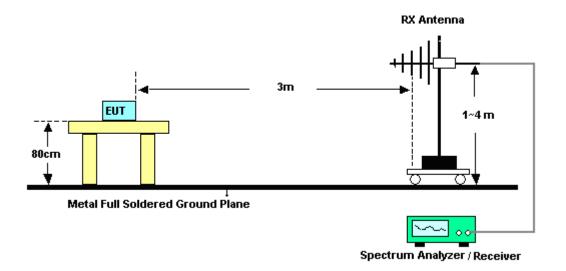

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that the user can replace a broken antenna, but the use of a standard antenna jack or electrical connector is prohibited.
