2.2 Test Mode

a. The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction emission (150 kHz to 30 MHz), radiation emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). For radiated measurement, the measured emission level of the EUT was maximized by rotating the EUT on a turntable, adjusting the orientation of the EUT and EUT antenna in three orthogonal axis (X: flat, Y: portrait, Z: landscape) and accessory (Adapter or Earphone), and adjusting the measurement antenna orientation, following C63.10 exploratory test procedures and only the worst case emissions were reported in this report, and the worst mode of radiated spurious emissions is X plane with Adapter and recorded in this report.



Remark:

- For Radiated Test Cases, the worst mode data rate 2Mbps was reported only since the highest RF output power in the preliminary tests. The conducted spurious emissions and conducted band edge measurement for other data rates were not worse than 2Mbps, and no other significantly frequencies found in conducted spurious emission.
- 2. For Radiated Test Cases, the tests were performed with USB Cable 2.
- 3. During the preliminary test, both charging modes (Adapter mode and WPT Charging mode) were verified. It is determined that the adaptor mode is the worst case for official test.



2.6 Measurement Results Explanation Example

For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 4.2 dB and 10 dB attenuator.

Offset(dB) = RF cable loss(dB) + attenuator factor(dB). = 4.2 + 10 = 14.2 (dB)



When there is no suspected emission found and the emission level is with at least 6 dB margin against QP limit line, the position is marked as "-".
- 8. Radiated testing above 1 GHz is performed by adjusting the antenna tower from 1 m to 4 m and by rotating the turn table from 0 degree to 360 degrees to find the peak maximum hold reading for scanning all frequencies. When there is no suspected emission found and the harmonic emission level is with at least 6 dB margin against average limit line, the position is marked as "-".
