

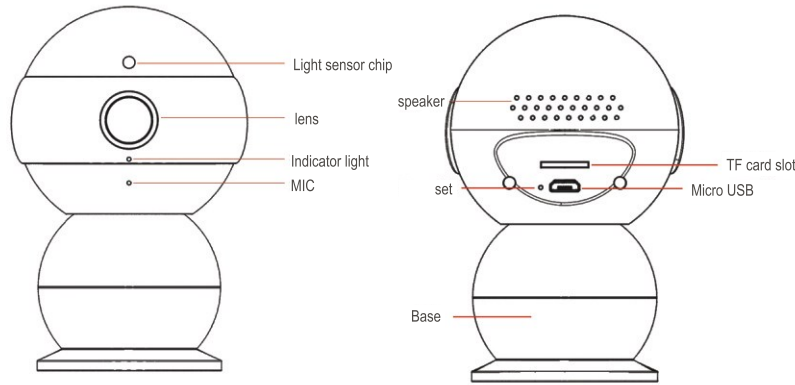

## 2 camera configuration

- 1.Before configuring,please confirm the environment.
2. Environment covered with Wi-Fi signal can be used.
- 3.Support android 4.4 and ios8.0 smart devices.

### Step one Scan QR Code to download APP

## 3 FAQ

### 1.How to reset the camera?

Use the reset pin insert the reset hole on the back of the machine,and press the reset button,about 30s you will hear the prompt 等待 for installation ?that means reset finished.

### 2.Why is cloud video discontinuous?

When you watch it remotely on phone,in order to save mobile traffic and reduce the useless message.To avoid wasting customer's time,remote recording adopts mobile detection mode, the video is only recorded when the object is found moving.

### 3.How much capacity does the TF card support? Format?

At present, the camera supports the FAT32 format Class10 TF card, with the maximum support of 32G, and after TF card is fully loaded it will automatically deleted from former video for automatic deletion.

### 4.What Wi-Fi support?What not?

At present only support 2.4GHZ,do not support 5g Wi-Fi.Router encryption support WPA2/WPA2-PSK,do not support WEP,and also do not support hidden SSID.

### 5.Indicator light displays information.

The red light flashing	Waiting for configuration
The blue green light flashing	Connecting to the cloud server
Green light normally on	Normal operation
The blue light flashing	Download the update
Blue light normally on	Camera offline

## Camera wall installation instructions :

### Step 1

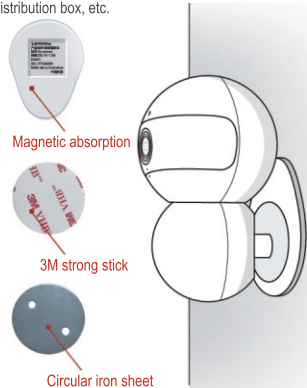
The camera is enclosed with wall installation accessories.(Circular iron sheet and 3M glue). The iron can be pasted on the wall or roof.

### Step 2

When the wall mounting accessories are fixed, the camera base can be pulled apart, screw in the direction of the base arrow, and then adsorb on the wall by the base with magnet.

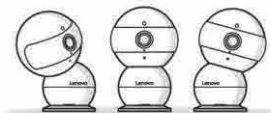
### Instruction

The camera base is designed with magnetic adsorption base. You can stick it on the surface of the fridge, air conditioner, distribution box, etc.
