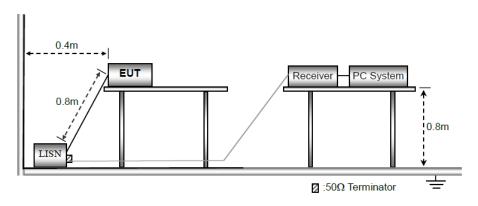

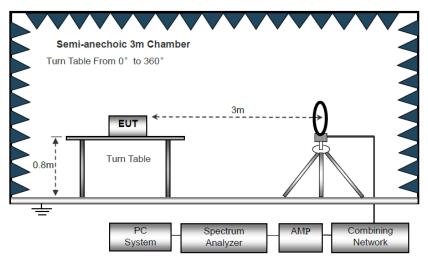

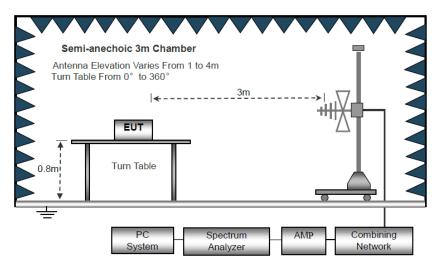

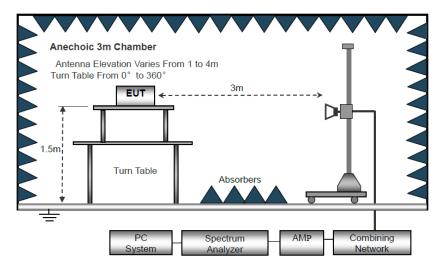

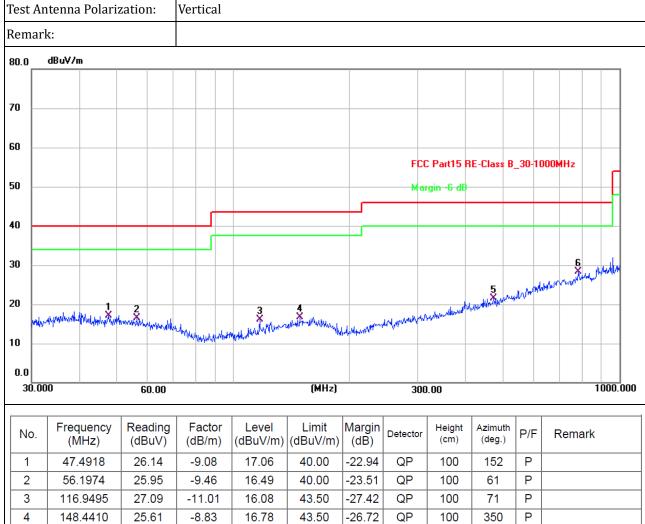

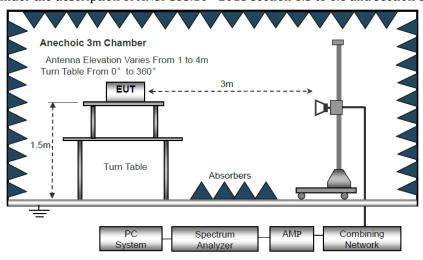

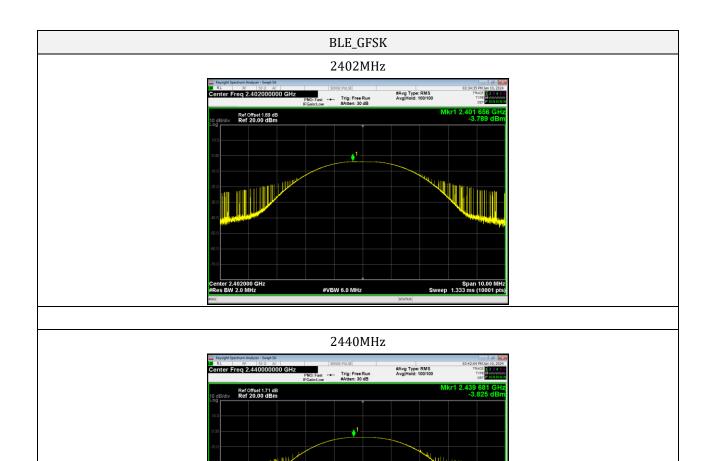


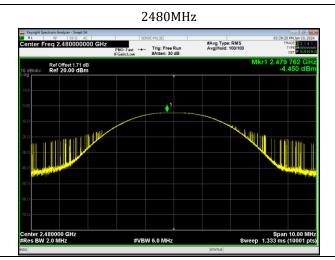
Test Setup Block Diagram

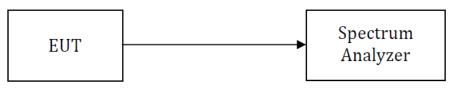

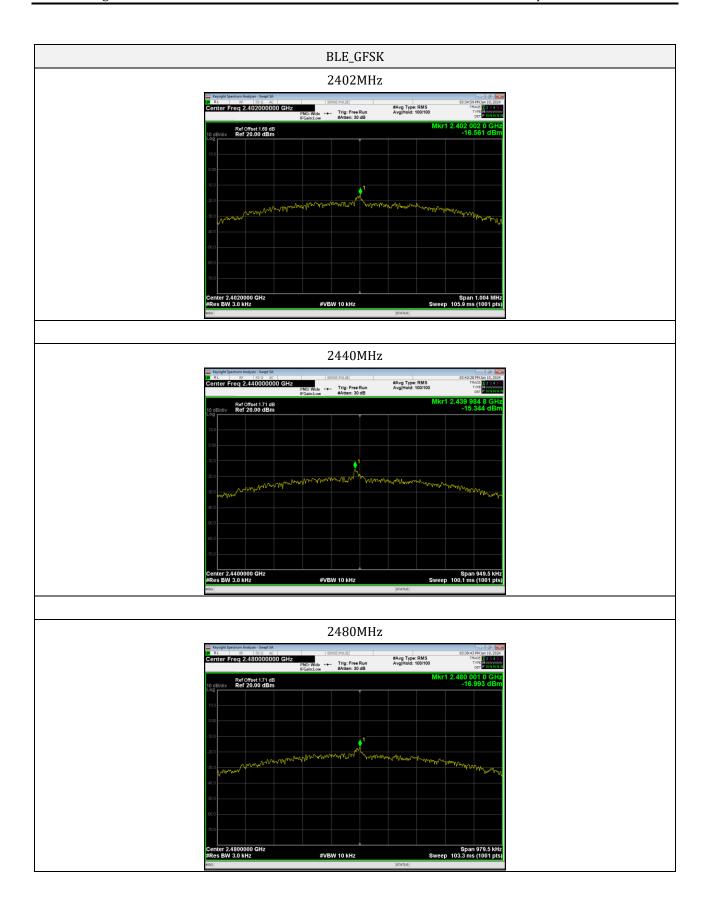


Test Setup Block Diagram

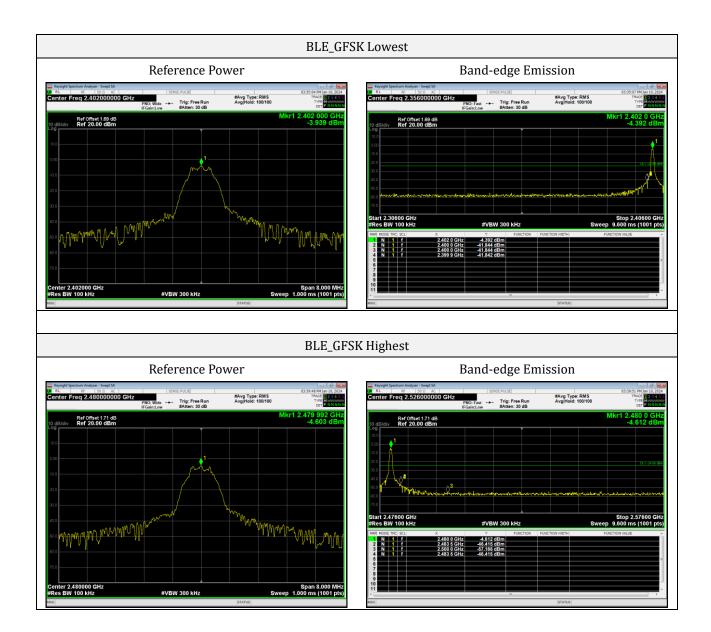


Test Setup Block Diagram

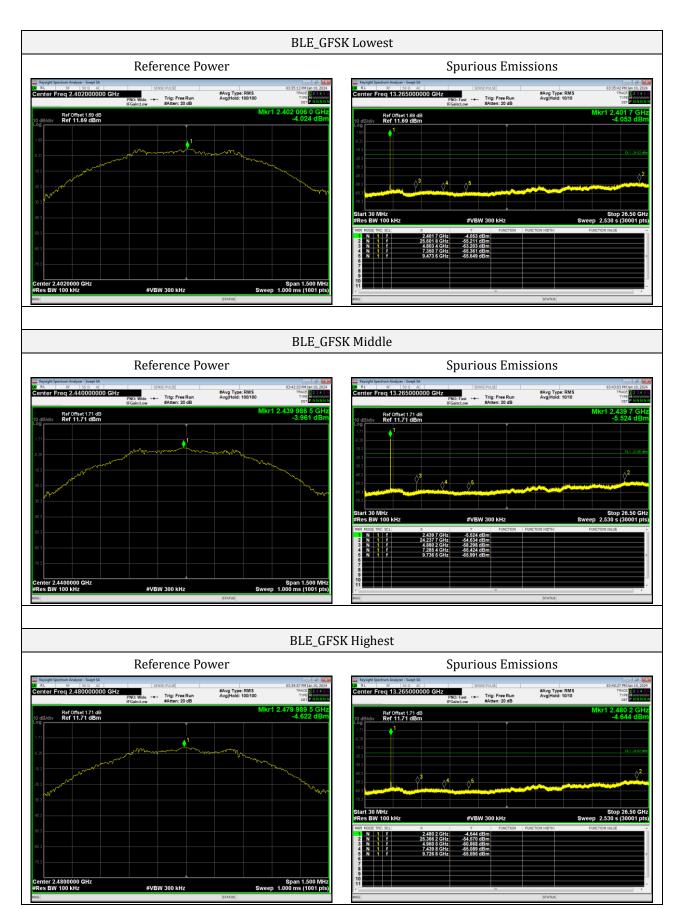
