
How to use it?



Listen to your Bluetooth-Enabled music player

- 2. Open the Bluetooth function in your device and search Bluetune-POP, LED indicator starts blinking quickly
- 3. Connect your device to Bluetune-POP Successfully, LED indicator stop blinking and show blue
- 4. Play the music in your device then enjoy your favorite music

Listen to your non-bluetooth-enabled audio device



- 1. Insert one end of USB connector into the charging port of Bluetune-POP
- 2. Insert the 3.5mm audio connector into your audio device directly.
- 3. Turn on you audio device and start the music playing.
- 4. Adjust the volume in your audio device.
- 5. Enjoy your favorite music.

NOTICE: 1) Please fully charge it with USB cable before using


- 2) Bluetune-POP only can connect with one Bluetooth device when it s working
