2.2 MPE Calculation Formula

 $Pd = (Pout*G) / (4*pi*r^2)$

where

Pd = power density in mW/cm²

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

2.3 Classification

The antenna of this product, under normal use condition, is at least 21cm away from the body of the user. So, this device is classified as **Mobile Device**.

2.4GHz Band: Directional gain = $10 \log[(10^{G1/20} + 10^{G2/20 + ... + } 10^{GN/20})^2/2] = 7.35dBi$ 5.0GHz Band: Directional gain = $10 \log[(10^{G1/20} + 10^{G2/20 + ... + } 10^{GN/20})^2/2] = 9.19dBi$

CONCULSION:

Both of the WLAN 2.4G & WLAN 5G can transmit simultaneously, the formula of calculated the MPE is:

CPD1 / LPD1 + CPD2 / LPD2 +etc. < 1

CPD = Calculation power density

LPD = Limit of power density

WLAN 2.4G + WLAN 5.0G = 0.383 + 0.540 = 0.923

Therefore, the maximum calculation of this situation is 0.923, which is less than the "1" limit.
