#### 2.2 MPE Calculation Formula

 $Pd = (Pout*G) / (4*pi*r^2)$ 

where

Pd = power density in mW/cm<sup>2</sup>

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

#### 2.3 Classification
