## 5 SAR Evaluation

### 5.1 RF Exposure Compliance Requirement

#### 5.1.1 Standard Requirement

According to KDB447498D01 General RF Exposure Guidance v05

##### 4.3.1. Standalone SAR test exclusion considerations

Unless specifically required by the published RF exposure KDB procedures, standalone 1-g head or body and 10-g extremity SAR evaluation for general population exposure conditions, by measurement or numerical simulation, is not required when the corresponding SAR Exclusion Threshold condition, listed below, is satisfied.

#### 5.1.2 Limits

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances  $\leq 50$  mm are determined by:

$[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] \cdot \sqrt{f(\text{GHz})} \leq 3.0$  for 1-g SAR and  $\leq 7.5$  for 10-g extremity SAR, where

$f(\text{GHz})$  is the RF channel transmit frequency in GHz

Power and distance are rounded to the nearest mW and mm before calculation<sup>17</sup>

The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is  $\leq 50$  mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is  $< 5$  mm, a distance of 5 mm is applied to determine SAR test exclusion

#### 5.1.3 EUT RF Exposure

For 4.0 (classic mode) :

The Max Conducted Peak Output Power is 3.56dBm in Highest channel(2.480 GHz);

The best case gain of the antenna is 3dBi

EIRP= 3.56 dBm +3 dBi =6.56 dBm

6.56dBm logarithmic terms convert to numeric result is nearly 4.5290 mW

According to the formula. calculate the EIRP test result:

$[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] \cdot \sqrt{f(\text{GHz})}$

General RF Exposure =  $(4.5290 \text{ mW} / 5 \text{ mm}) \times \sqrt{2.480 \text{ GHz}} = 1.4265$  ①

For 4.0 (BLE mode):

The Max Conducted Peak Output Power is 0.36dBm in Middle channel(2.441 GHz);

The best case gain of the antenna is 3dBi

EIRP= 0.36 dBm +3 dBi =3.36 dBm

3.36dBm logarithmic terms convert to numeric result is nearly 2.1677 mW

According to the formula. calculate the EIRP test result:

$$\left[ \frac{\text{(max. power of channel, including tune-up tolerance, mW)}}{\text{(min. test separation distance, mm)}} \cdot \sqrt{f(\text{GHz})} \right]$$

General RF Exposure =  $(2.1677 \text{ mW} / 5 \text{ mm}) \times \sqrt{2.441 \text{ GHz}} = 0.6773$  ①
