<br>This is in response to your correspondence answering my questions.&nbsp; Part 2.1049 uses the 1% of energy is outside the bandwidth having .5% on either side of the bandwidth.&nbsp; However, when a specific rule part is used (i.e. Part 24), compliance must be to that rule part.&nbsp; Part 24 specifically states that it is the 26dB down that must be used.&nbsp; The values of 2.1049 then are not relevant to the emissions bandwidth required in Part 24.&nbsp; Thus, the 23dB bandwidth cannot be used, it must be the 26dB bandwidth.&nbsp; I understand that there is not much difference in this, but it is the rules that must be met in the certification process.
